FINAL ENVIRONMENTAL ASSESSMENT

MONTANA ENVIRONMENTAL POLICY ACT (MEPA) COMPLIANCE: An environmental assessment required by the Montana Environmental Policy Act, was completed for this project as follows:

LEGAL DESCRIPTION OF SITE: NW¼, SW¼ of Section 18, T31N, R16E, in Hill County, Montana near Havre, Montana

DESCRIPTION OF PROJECT: HPC has applied for an alteration to permit #1627-02, this alteration is the addition of one (1) 1,478 hp Waukesha 7042GL compressor engine and one (1) PESCO Tri-Ethylene Glycol (TEG) dehydrator.

BENEFITS AND PURPOSE OF PROPOSAL: The addition of the 1,478 hp compressor engine will allow HPC to increase natural gas transmission. The addition of the TEG dehydrator will remove moisture from the natural gas that is being transported.

DESCRIPTION AND ANALYSIS OF REASONABLE ALTERNATIVES WHENEVER ALTERNATIVES ARE REASONABLY AVAILABLE AND PRUDENT TO CONSIDER: No reasonable alternatives are available.

A LISTING AND APPROPRIATE EVALUATION OF MITIGATION, STIPULATIONS AND OTHER CONTROLS ENFORCEABLE BY THE AGENCY OR ANOTHER GOVERNMENT AGENCY: A list of enforceable permit conditions are contained in Air Quality Permit 1627-03.

DESCRIPTION AND ANALYSIS OF REGULATORY IMPACTS ON PRIVATE PROPERTY RIGHTS: The department has considered alternatives to the conditions imposed in this permit as part of the permit development. The department has determined that the permit conditions are reasonably necessary to ensure compliance with applicable requirements and to demonstrate compliance with those requirements and do not unduly restrict private property rights.
