Project Name: Rindal **Proposed Implementation Date:** Summer 1999

Proponent: Konitz Contracting Inc.

Type and Purpose of Action: The proponent proposes to mine, crush stockpile and transport 45,600 cubic yards of sand & gravel from a 9.26 acre site for resurfacing of missile roads. The site would be reclaimed by recontouring, respreading the topsoil and reseeding the site with grasses. The reclaimed use would be rangeland and the site would be reclaimed by September of 2001.

RESOURCE	[Y/N] POTENTIAL IMPACTS AND MITIGATION MEASURES
1. GEOLOGY AND SOIL QUALITY, STABILITY AND MOISTURE: Are fragile, compactible or unstable soils present? Are there unusual geologic features? Are there special reclamation considerations?	[N] The proposed operation is located on a bench overlooking a small drainage to the north. The proposed pit is located on the north side Judith Mountains. The soils are approximately 8 inches deep and are of a sandy loam texture. There is 8 inches of rocky loam overburden. After regrading the overburden and then the soil would be replaced. Microorganisms should invade the soil. There are no fragile, compactible or unstable soils present, no unusual geologic features, or special reclamation considerations.
2. WATER QUALITY, QUANTITY AND DISTRIBUTION: Are important surface or groundwater resources present? Is there potential for violation of ambient water quality standards, drinking water maximum contaminant levels, or degradation of water quality?	[N] There are no surface water sources or water wells within 1,000 feet of the site. The site will be mined to a depth of 10 feet which is well above the depth to the water table. Any bulk fuel storage containers would be lined and bermed and be of sufficient size to contain any spills. Best Management Practices would be used to prevent any off site sedimentation or erosion.
3. AIR QUALITY: Will pollutants or particulate be produced? Is the project influenced by air quality regulations or zones (Class I airshed)?	[Y] Air quality would be degraded, but the proponent must comply with air quality standards, and an Air Quality Permit obtained from the Montana Dept. of Environmental Quality for the crusher. A water truck would be used to control any dust on the haul road.
4. VEGETATION COVER, QUANTITY AND QUALITY: Will vegetative communities be permanently altered? Are any rare plants or cover types present?	[Y] The vegetation on the site of the proposed operation is various wheatgrasses. Native and nonnative grass species would be seeded onto the site upon recontouring and retopsoiling. A literature search was done by the Montana National Heritage Program and no rare plants or cover types were identified and none were identified during a ground search.
5. TERRESTRIAL, AVIAN AND AQUATIC LIFE AND HABITATS: Is there substantial use of the area by important wildlife, birds or fish?	[N]

[N] Ground and literature searches were conducted and no threatened or endangered species or identified habitat or species of special concern were found on the site. No wetlands are present.

If the operator of the proposed operation discovers any cultural resources the operation must be routed around the site of discovery for a reasonable amount of time until salvage can be made.
