PURPOSE OF PUBLIC NOTICE

The purpose of this notice is to state the Department's intention to issue a wastewater discharge permit to the facility listed in this notice and hold a public hearing on the issuance of this permit. This permit is issued by the Department under the authority of 75-5-402, Montana Code Annotated (MCA) and the Administrative Rules of Montana 17.30.1001 *et seq.*, Montana Ground Water Pollution Control System (MGWPCS). The Water Protection Bureau has prepared a draft permit for the facility listed below. Manufacturing (PCM), a timber products processing facility that manufactures plywood, Medium Density Fiberboard (MDF) and finished wood products. All discharges from the PCM facility discharge to Class I ground waters. PCM will be issued standard mixing zones for each outfall for the parameter Total Dissolved Solids (TDS). The Department will grant PCM a mixing zone for TDS at each outfall and the permittee will be required to meet the SMCL of 500 mg/L at the end of each mixing zone. The proposed discharge is not a new or increased source pursuant to ARM 17.30.702 (18).

PUBLIC COMMENT

Public comments are invited ANYTIME PRIOR TO CLOSE OF BUSINESS April 24, 2008. A public hearing will be held on the draft wastewater discharge permit, the statement of basis, environmental assessment, and the Department's tentative determination at **7:00 pm , April 15th at Columbia Falls High School, 610 13th Street, Columbia Falls, MT.**

The Department will respond to all substantive comments and issue a final decision within sixty days of this notice or as soon as possible thereafter.
