5. Narrative summary of the proposed project, purpose, action to be taken, and benefits:  
The Applicant proposes to change the point of diversion and place of use for a non-filed water project for stock out of a spring in Park County. The intent of the project is to allow stock to water at an upslope area of the property so they don't travel to the creek at a rate of 8 GPM up to 0.3 AF per year. The DNRC shall issue a change authorization if an applicant proves the criteria in 85-2-402 MCA are met.

**1. Environmental Impact Checklist:**

**PHYSICAL ENVIRONMENT**

**WATER QUANTITY, QUALITY AND DISTRIBUTION**

**Water quantity** - Assess whether the source of supply is identified as a chronically or periodically dewatered stream by DFWP. Assess whether the proposed use will worsen the already dewatered condition.

*Determination:* No impact identified.

Department of Fish, Wildlife and Parks does not identify the source of supply, an unnamed tributary Pine Creek, as a dewatered stream.

**Water quality** - Assess whether the stream is listed as water quality impaired or threatened by DEQ, and whether the proposed project will affect water quality.

*Determination:* No impact identified.

The source, a spring, is not on the DEQ list.

**Groundwater** - Assess if the proposed project impacts ground water quality or supply. If this is a groundwater appropriation, assess if it could impact adjacent surface water flows.

*Determination:* No impact identified.

The stock use should not impact adjacent surface water flows.

**DIVERSION WORKS** - Assess whether the means of diversion, construction and operation of the appropriation works of the proposed project will impact any of the following: channel impacts, flow modifications, barriers, riparian areas, dams, well construction.

*Determination:* No impact identified.

The diversion is a pipeline to a stock tank with a float valve. Resource impacts are not expected.

The Montana Natural Heritage Program was contacted. The gray wolf, Canada lynx, bison, elk, antelope, and Grizzly bear, as well as, Yellowstone cutthroat trout, may be found within Sec. 11, T4S, R8E. This project should not have impact on these animals.

No existing wetlands were identified.
