(possible concerns)

Long drilling time: No, 30-40 days drilling time.

Unusually deep drilling (high horsepower rig): Triple derrick drilling rig to drill a single lateral horizontal Three Forks Formation test, 20,673' MD/10,500' TVD.

Possible H₂S gas production: Yes, slight H₂S possible, Mississippian Formations.

In/near Class I air quality area: No Class I air quality area nearby.

Air quality permit for flaring/venting (if productive): Yes, DEQ air quality permit required under 75-2-211.

Comments: Plan is to drill a single lateral horizontal Three Forks Formation test, 20,673' MD/10,500' TVD. If there are existing pipeline for natural gas in the area then associated gas can be tied into system or if no gathering system nearby associated gas can be flared under Board Rule 36.22.1220.

Water Quality

(possible concerns)

Salt/oil based mud: Yes to oil based invert drilling fluids for intermediate casing hole. Horizontal hole will be drilled with saltwater. Surface casing hole will be drilled with freshwater and freshwater mud system.

High water table: No high water table anticipated in the area of review.

Surface drainage leads to live water: No, closest drainage is an unnamed ephemeral tributary drainage to Horse Tied Creek, about 1/8 of a mile to the west from this location. A large stock pond is situated, about 7/8 of a mile to the northwest from this location.

Water well contamination: No, water wells within a 1 mile radius from this location. Excluding any water wells to the east in North Dakota. This proposed oil well will be drilled with freshwater and freshwater mud to 2,019' and steel surface casing will be run and cemented to surface to protect groundwater.

Porous/permeable soils: No, sandy clay soils.

Class I stream drainage: No, Class I stream drainages.

Comments: 2,019' surface casing will be drilled with freshwater, steel casing will be run to 2,019' and cemented back to surface, to protect freshwater zones in adjacent water wells. Also, covering Fox Hills aquifer. Adequate surface casing and operational BOP equipment will help mitigate any formation pressure problems.

Soils/Vegetation/Land Use

(possible concerns)

Stream crossings: None anticipated, crossing only ephemeral drainage.

High erosion potential: No high erosion potential on cut and fill slopes, location will require a small cut of up to 6.3' and a moderate fill of up to 11.2', required.

Loss of soil productivity: No, location to be restored after drilling, if nonproductive. If productive unused portion of this drillsite will be reclaimed.

Unusually large wellsite: No a large well site 530' X 355', for a dual well drilling pad, Justice Federal 2759 44-11T and Mercy Federal 2759 44-11B.

Damage to improvements: Slight surface use appears to be grassland.

Conflict with existing land use/values: Slight

Avoid improvements (topographic tolerance)

Other Requires DEQ General Permit for Storm Water Discharge Associated with Construction Activity, under ARM 17.30.1102(28).

Comments: Access will be over existing county roads and existing lease road. New access road will be built into this location, about 215' into this location from the existing lease road. Oil based invert drilling fluids will be recycled. Completion fluids will hauled to a commercial Class II disposal. Cuttings and solids will be buried/solidified on site in the lined reserve pit. The lined pit will be allowed to dry and the pit backfilled. No concerns.

Health Hazards/Noise

(possible concerns)

Proximity to public facilities/residences: Nearest residences are about 1 mile to the north and about 1.325 miles to the northwest from this location. The Town of Bainville, Montana is about 8.4 miles to the northwest from this location.

Possibility of H2S: Yes, slight from Mississippian Formations.

Size of rig/length of drilling time: Triple drilling rig 30 to 40 days drilling time.

Comments: Adequate surface casing cemented to surface with working BOP stack should mitigate any problems. (BOP's 5,000 psig annular, pipe and blind rams) rule 36.22.1014

Threatened or endangered Species: Species identified as threatened or endangered are the Pallid Sturgeon, Piping Plover, Interior Least Tern and Whooping Crane. Candidate species is the Sprague's Pipit. NH tracker website indicates, three (3) species of concern: Piping Plover, Whooping Crane, and

Red-headed Woodpecker.

Mitigation:

Comments: Private surface grasslands. There may be species of concern that maybe impacted by this wellsite. We ask the operator to consult with the surface owner as to what he would like done, if a species of concern is discovered at this location. The Board of Oil & Gas has no jurisdiction over private surface lands.

We ask the operator to consult with the surface owner as to his desires to preserve these sites or not, if they are found during construction of the wellsite. The Board of Oil & Gas has no jurisdiction over private surface lands.

An exploratory single lateral horizontal Three Forks Formation test, 20,673' MD/10,500' TVD.
