Air Quality

(possible concerns)

Long drilling time: No, 25-35 days drilling time.

Unusually deep drilling (high horsepower rig): Triple derrick rig to drill a single lateral horizontal Bakken Formation test, 13,992'MD/9,405'TVD.

Possible H₂S gas production: Slight chance H₂S gas from Mississippian Formations.

In/near Class I air quality area: No Class I air quality area in the area of review.

Air quality permit for flaring/venting (if productive): Yes, DEQ air quality permit required under 75-2-211.

- Air quality permit (AQB review)
- Gas plants/pipelines available for sour gas

Comments: Triple derrick drilling rig to drill a single lateral horizontal Bakken Formation test, 13,992'MD/9,405'TVD. If there is an existing pipeline for associated gas/H₂S gas in the area and gas can be gathered or if no gathering system nearby associated gas/H₂S gas can be flared under Board Rule 36.22.1220.

Water Quality

(possible concerns)

Salt/oil based mud: Yes to intermediate string hole to be drilled with oil based invert drilling fluids. Horizontal lateral will be drilled with oil based invert drilling fluids. Surface casing hole will use freshwater and freshwater mud system, Rule 36.22.1001.

High water table: No high water table anticipated.

Surface drainage leads to live water: Yes surface drainage leads to live water, closest drainages are unnamed ephemeral tributary drainage to East Redwater Creek, about 1/8 of a mile to the east, about 5/16 of a mile to the west and about 1/4 of a mile to the northwest from this location. Within this drainage is a stock pond, about 1/4 of a mile to the northwest from this location.

Water well contamination: None, closest water wells are about 1/2 of a mile to the northeast, about 1/2 of a mile to the west, about 5/8 of a mile to the east, about 3/4 of a mile to the west, about 3/4 of a mile to the southwest, about 7/8 of a mile to the east southeast and all other water wells are 1 mile and further away from this location. Depth of these stock/domestic water wells range from 20' to 328'. This well will drill surface casing hole to 1550' and will run 1550' of steel surface casing and cement it to surface.

Porous/permeable soils: No, sandy clay soils.

Class I stream drainage: No, Class I stream drainages.

Mitigation:

- Lined reserve pit
- Adequate surface casing
- Berms/dykes, re-routed drainage
- Closed mud system
- Off-site disposal of solids/**liquids** (in approved facility)
- Other: Lined cuttings pit.

Comments: 1550' surface casing well below freshwater zones in adjacent water wells. Also, covering Fox Hills aquifer, Rule 36.22.1001. Adequate surface casing and BOP

equipment to prevent any problems (BOP's 5,000psig annular, pipe and blind rams) rule 36.22.1014.

Soils/Vegetation/Land Use

(possible concerns)

Steam crossings: None anticipated, crossing only ephemeral drainages.

High erosion potential: Yes this location has a high erosion potential due to moderate cut, location needs a moderate cut, up to 22.4' and a small fill, up to 9.7', required.

Loss of soil productivity: None, location to be restored after drilling well, if nonproductive. If productive unused portion of drillsite will be reclaimed.

Unusually large wellsite: No, large well site 450'X405', dual well location for Scavenger 2-28H and existing well Scavenger 1-28H.

Damage to improvements: Slight, surface use is cultivated land.

Conflict with existing land use/values: Slight

Mitigation

Avoid improvements (topographic tolerance)

Exception location requested

Stockpile topsoil

Stream Crossing Permit (other agency review)

Reclaim unused part of wellsite if productive

Special construction methods to enhance reclamation

Other: Requires DEQ General Permit for Storm Water Discharge Associated with Construction Activity, under ARM 17.30.1102(28).

Comments: Access will be over existing county road, #133. Operator will construct about 384' of new access road into this location from the existing county. Oil based invert drilling fluids will be recycled. Completion fluids will be trucked to a Class II disposal. Operator will utilize a closed loop mud system. Cuttings and mud solids will be disposed of in the lined cuttings pit and solidified. No concerns.

Health Hazards/Noise

(possible concerns)

Proximity to public facilities/residences: Closest residences are about 1/2 of a mile to the northeast, about 5/8 of a mile to the west and about 3/4 of a mile to southwest from this location.

Possibility of H2S: Slight chance H2S gas from Mississippian Formations.

Size of rig/length of drilling time: Triple drilling rig 25 to 35 days drilling time.

Mitigation:

Proper BOP equipment

Topographic sound barriers

H2S contingency and/or evacuation plan

Special equipment/procedures requirements

Comments: Adequate surface casing cemented to surface with a working BOP stack should mitigate any problems, (BOP's 5,000psig annular, pipe and blind rams) rule 36.22.1014.

Wildlife/recreation

(possible concerns)

Proximity to sensitive wildlife areas (DFWP identified): None identified.

Proximity to recreation sites: None identified.

Creation of new access to wildlife habitat: No, none.

Conflict with game range/refuge management: No, none.

Threatened or endangered Species: Species identified as threatened or endangered are the Pallid Sturgeon, Interior Least Tern, Whooping Crane and Piping Plover. Candidate species are the Sprague's Pipit and the Greater Sage Grouse. NH tracker website indicates one (1) species of concern in this area, Iowa Darter.

Mitigation:

- Avoidance (topographic tolerance/exception)
- Other agency review (DFWP, federal agencies, DSL)
- Screening/fencing of pits, drillsite

Comments: Private surface cultivated lands. There maybe species of concern that maybe impacted by this wellsite. We ask the operator to consult with the surface owner as to what he would like done, if a species of concern are discovered at this location.

- avoidance (topographic tolerance, location exception)
- other agency review (SHPO, DSL, federal agencies)

Comments: Private surface cultivated lands. There maybe possible historical/cultural/paleontological sites that maybe impacted by this wellsite. We ask the operator to consult with the surface owner as to his desires to preserve these sites or not, if they are found during construction of the wellsite.

Single lateral horizontal Bakken Formation test 13,992'MD/9,405'TVD.
