**Air Quality**

(possible concerns)

Long drilling time: No, 30 to 40 days drilling time.

Unusually deep drilling (high horsepower rig): No, triple derrick rig to drill a single lateral horizontal Bakken Formation test, 19,304' MD/9,265' TVD.

Possible H2S gas production: Slight chance H2S gas from Mississippian Formations.

In/near Class I air quality area: Yes nearest Class I air quality area is the Fort Peck Indian Reservation, about 4 miles to the north from this location.

Air quality permit for flaring/venting (if productive): Yes, DEQ air quality permit required under 75-2-211.

Air quality permit (AQB review)

Gas plants/pipelines available for sour gas

Comments: No special concerns – using triple rig to drill a single lateral horizontal Bakken Formation test, 19,304' MD/9,265' TVD. If there is an existing pipeline for gas in the area, then associated gas can be gathered or if no gathering system nearby gas can be flared under Board Rule 36.22.1220.

**Water Quality**

(possible concerns)

Salt/oil based mud: Yes to intermediate casing string hole to be drilled with oil based invert drilling fluids. Horizontal lateral will be drilled with brine water. Surface casing hole will use freshwater and freshwater mud system (Rule 36.22.1001).

High water table: No high water table anticipated at this location.

Surface drainage leads to live water: No, nearest drainage is Wolf Coulee, an ephemeral tributary drainage to Charley Creek, about 1/32 of a mile east from this location. Charley Creek is about 1/2 of a mile to the southwest at its closest from this location, within Charley Creek our what appears to be stock ponds.

Water well contamination: None anticipated, closest water wells are about 5/8 of a mile to the northeast, about 3/4 of a mile to the northeast and about 7/8 of a mile to the south southeast from this location. Depth of these stock and domestic water wells range from 110' to 815'. Surface hole will be drilled with freshwater and freshwater mud system, Rule 36.22.1001. Surface casing will be set at 1100' and steel casing set and cemented to surface from 1100'.

Porous/permeable soils: No, silty-sandy clay soils.

Class I stream drainage: No Class I stream drainages in the area of review.

Mitigation:

Lined reserve pit

Adequate surface casing

- Berms/dykes, re-routed drainage
- Closed mud system
- Off-site disposal of solids/**liquids** (in approved facility)
- Other: Lined cuttings pit will be used since this is a closed loop mud system to be employed.

Comments: Require 1100' of surface casing be set to cover the base of the Fox Hills and cemented to surface adequate to protect freshwater zones, Rule 36.22.1001.

### Soils/Vegetation/Land Use

(possible concerns)

- Stream crossings: No stream crossings. Crossing only ephemeral drainage.
- High erosion potential: No high erosion potential. This location will require a moderate cut, up to 11.8' and a moderate fill, up to 13.2'.
- Loss of soil productivity: No, location will be restored after drilling if unproductive. If productive, unused portion of this drilling location will be restored.
- Unusually large wellsite: A large wellsite, 270'X500' required.
- Damage to improvements: Slight
- Conflict with existing land use/values: Slight, surface use appears to be grassland.

Mitigation

- Avoid improvements (topographic tolerance)
- Exception location requested
- Stockpile topsoil
- Stream Crossing Permit (other agency review)
- Reclaim unused part of wellsite if productive
- Special construction methods to enhance reclamation

Comments: Access will be over existing county road, #321 and existing lease road. About 113' of new access road will be built into this location off the existing lease road. Cuttings will be buried in the lined cuttings pit. Oil based drilling fluids will be recycled. Completion fluids will be hauled to a commercial SWD disposal. The lined cuttings pit will be allowed to dry and then closed by filling and mixing with clay subsoils. Minimum of 4' of cover over the top of the cuttings. No special concerns.

### Health Hazards/Noise

(possible concerns)

- Proximity to public facilities/residences: Closest residence is about 1.5 miles to the south southeast from this location. Lynn Cemetery is about 1.5 miles to the south southwest from this location.
- Possibility of H2S: Slight chance from Mississippian Formations.
- Size of rig/length of drilling time: Triple drilling rig/short 30 to 40 days drilling time.

Mitigation:

- Proper BOP equipment
- Topographic sound barriers
- H2S contingency and/or evacuation plan
- Special equipment/procedures requirements

Comments: Adequate surface casing cemented to surface with an operational BOP stack (annular and double ram rated for 5,000 psig) should mitigate any problems, Rule 36.22.1014.

### Wildlife/recreation

(possible concerns)

Proximity to sensitive wildlife areas (DFWP identified): None.

Proximity to recreation sites: None.

Creation of new access to wildlife habitat: No new access to wildlife habitat.

Conflict with game range/refuge management: No

Threatened or endangered Species: Species identified as threatened or endangered are the Pallid Sturgeon, Interior Least Tern, Whooping Crane and Piping Plover.

Candidate specie is the Sprague's Pipit and the Greater Sage Grouse. NH tracker website indicates thirteen (13) species of concern: Eastern Red Bat, Great Blue Heron, Piping Plover, Least Tern, Northern Redbelly Dace, Blue Sucker, Iowa Darter, Shortnose Gar, Surgeon Chub, Sicklefin Chub, Paddlefish, Sauger and Pallid Surgeon.

Mitigation:

Avoidance (topographic tolerance/exception)

Other agency review (DFWP, federal agencies, DSL)

Screening/fencing of pits, drillsite

Comments: Private grass surface lands. There may be species of concern that maybe impacted by this wellsite. We ask the operator to consult with the surface owner as to what he would like done, if species of concern are discovered at this location.
