Four of the seven state-funded residential meth treatment facilities were open by April 15, 2008.

Performance Report:

The data for the legislative performance measures is submitted by the contractor, Boyd Andrew Community Services. The Residential Treatment Expansion Project (RTEC) oversees the seven meth treatment facilities. The eight bed facilities are accepting clients for services in the following locations: Rimrock Foundation/ White Birch - adult males; Boyd Andrew Community Services/Elkhorn - adult females; Miles City - adult males; Gateway Community Services/Blue Thunder Lodge - adult Native American males. Kalispell - adult females, Rocky Boy - adult Native American females; and Bozeman/Olive Branch - adult males. The seven facilities receive continuous clinical and administrative support and technical assistance with the RTEC Project Coordinator. Rimrock Foundation has developed standardized intake and reporting forms for the facilities. The data will be gathered, monitored and compiled for the continuous improvement process for the project. Additionally, In late June, the principles and tools of the Network for the improvement of Addiction Treatment (NIATx) were introduced and integrated into the facilities as well as the project's CQI process. NIATx works with addiction treatment providers to make more efficient use of their capacity and share strategies for improving treatment access and retention.

Increase in the length of time of non-use. RESPONSE: The total number of clients admitted into the community based residential services since January 2008 is 95. Of those clients, 1 of 95 admissions has experienced relapse. The client was referred to a higher level of care to address relapse issues. Upon completion of this level of care, the client returned to the community home and has continued to remain sober.

Decrease in the incidence of involvement with the criminal justice system. RESPONSE: Of the 95 admissions, 48% have been referred from the criminal justice system. Of the 48%, less than 1% have experienced a re-arrest.

Decrease in the admissions to inpatient treatment. RESPONSE: The number of clients admitted into this level of care/inpatient was 74. These clients were historically referred to Montana Chemical Dependency Center..

Increase in the length of gainful employment. RESPONSE: The number of clients who are gainfully employed during this report period is 52%.
