RE: Supplemental Appropriation Request – Department Of Justice Major Litigation

Funds

A request has been received for Legislative Finance Committee review of and comment on a proposed transfer of up to \$350,000 general fund from FY 2013 to FY 2012. The funds are associated with the Department of Justice major litigation appropriation, which is restricted for this purpose. The proposed transfer is to cover costs the Department of Justice incurred representing the State of Montana on cases including Pacific Power and Light (PPL), Nob Hill, Yellowstone River Compact, and the Columbia River suit.

Staff has reviewed the request and does not raise concerns about whether it meets legal requirements for this transfer. It should be noted that the appropriations transfer statute specifically exempts this program from the requirement to submit a plan for reducing expenditures in the second year of the biennium.

The committee may take one of three actions for this transfer:

- 1) Inform the Governor that the committee does not raise any issues of statutory compliance with the proposed transfer,
- 2) Inform the Governor of statutory compliance issues with the proposed transfer, or
- 3) Do not report. If the committee chooses this option, the executive must wait 90 days to process the transfer.
