Subject: Required Reports for November 2010 LFC Meeting

The legislature (through statute, language in bills, or committee action) requires certain reports to be submitted to the Legislative Finance Committee (LFC) and the Legislative Fiscal Division (LFD). State agencies and other entities have been requested to provide information on various subjects of interest to facilitate the decision-making process.

The reports fit into two categories: 1) reports required to be submitted to the LFC are generally to monitor compliance or progress with legislative policy/initiatives; and 2) reports required to be submitted to the LFD are primarily to provide data relevant for staff analysis of budget issues for the next legislative session. The attached report lists the required reports identified and the occurrences of the reports received or expected to be received during the 2011 biennium. Three reports have been received since the last LFC meeting (October 2010). Only one, the EMS Grant Program (item #2), is attached under this cover for your review. The annual report of the Montana Comprehensive Health Association (item #18) is mailed direct to all legislators and the Information Technology Services Division exception report (item #4) is being provided under a separate agenda item.

Generally, this summary report on "required reports" is provided to the committee simply for information purposes. Although it is on the LFC meeting agenda, there are typically no oral reports provided unless there is an issue identified by the staff that needs to be brought to the committee's attention. If a committee member has a question, he or she can contact the indicated staff member directly or raise the question in the meeting.

# **Emergency Medical Services Grant Program**

## SUMMARY

The 2009 Montana Legislature passed HB 85 and enacted an emergency services grant program. The Montana Department of Transportation was tasked with developing and implementing this program.

The grant program is funded for the 2011 biennium. MDT appropriates \$1 million each year of the biennium. Grant recipients are required to provide a ten percent match for any grant funds received.

MDT wrote the Administrative Rules for the program that were later adopted and then developed application material and award criteria (available at [www.mdt.mt.gov/business/grants\\_ems.shtml](http://www.mdt.mt.gov/business/grants_ems.shtml)).

In March 2010, MDT notified emergency service providers of the grant availability. In June, the first awards were made. Forty-two providers applied, and 41 were eligible for a total request of \$2.62 million (See Table 1). Of those, 23 providers received funding for a total award of \$1.04 million (See Table 2).
