

# DEQ OPENCUT MINING PROGRAM

## ENVIRONMENTAL ASSESSMENT

**Project Name:** DNRC #2 Borrow Site.

**Proposed Implementation Date:** 4/99.

**Proponent:** D.H. Blattner & Sons, Inc.

**Type and Purpose of Action:** Proponent has applied for an 8-acre Mined Land Reclamation Contract where they propose to remove 40,000 cubic yards of borrow from a 6-acre pit. Mobile equipment will be used in the operation. Proponent has submitted all application materials required under the Opencut Mining Act and the Rules and Regulations governing the Act. Proponent proposes to properly prepare, mine, and reclaim the site to a postmining land use of rangeland. Proponent is legally bound through their reclamation contract with the state to reclaim the site. The estimated date for completion of final reclamation is 9/1/99.

**Location:** SE 36, T19N, R47E **County:** McCone County, Montana.

<p><b>1. GEOLOGY AND SOIL QUALITY, STABILITY, AND MOISTURE:</b> Are fragile, compactible, or unstable soils present? Are there unusual geologic features? Are there special reclamation considerations?</p>	<p>[Y] Geology. The proposed site is in the sedimentary plains portion of the state.</p> <p>Soils. The standard 6 inch lift of soil material is available for salvage from this borrow site after grading. After grading, soil material will be evenly replaced. There are no fragile, compactible, or unstable soils present</p> <p>Removal of mineral will alter the topography; however, operator is required properly grade the site and blend it into the surrounding topography. There are no special reclamation considerations.</p>
<p><b>2. WATER QUALITY, QUANTITY, AND DISTRIBUTION:</b> Are important surface or groundwater resources present? Is there potential for violation of ambient water quality standards, drinking water maximum contaminant levels, or degradation of water quality?</p>	<p>[N] Surface Water. It does not appear that surface water is a factor for consideration at this site.</p> <p>Groundwater. It does not appear that groundwater is a factor for consideration at this site.</p> <p>Wells. No wells were seen within or near the site.</p> <p>Surface and groundwater resources should not be adversely affected by the operation. Proponent has committed to protecting surface water and groundwater resources.</p>
<p><b>3. AIR QUALITY:</b> Will pollutants or particulate be produced? Is the project influenced by air quality regulations or zones (Class I airshed)?</p>	<p>[N] Pollutants and particulates may be produced on a temporary basis by this operation. The site is relatively small and in a remote location. Proponent is required to comply with state air quality regulations.</p>
<p><b>4. VEGETATION COVER, QUANTITY, AND QUALITY:</b> Will vegetative communities be permanently altered? Are any rare plants or cover types present?</p>	<p>[Y] Premine Vegetation. The site is currently rangeland.</p> <p>Postmining Vegetation. The site will be reclaimed to rangeland.</p> <p>Weed Control. Proponent has committed to appropriate weed control measures. The county weed control district has been notified.</p>

	The Montana Natural Heritage Program reports no element occurrences within or near the site. Abundant similar habitat exists in the area.
<b>5. TERRESTRIAL, AVIAN, AND AQUATIC LIFE AND HABITATS:</b> Is there substantial use of the area by important wildlife, birds, or fish?	[N] The site consists of common rangeland habitat. A site visit did not reveal extraordinary use by wildlife or use by unique wildlife.
<b>6. UNIQUE, ENDANGERED, FRAGILE, OR LIMITED ENVIRONMENTAL RESOURCES:</b> Are any federally listed threatened or an endangered species or identified habitat present? Any wetlands? Species of special concern?	[N] None of the mentioned resources appear to be present. Similar habitat is abundant in the area. No wetland, riparian, or other less common habitat will be affected.  The Montana Natural Heritage Program reports no element occurrences within or near the site.
<b>7. HISTORICAL AND ARCHAEOLOGICAL SITES:</b> Are any historical, archaeological, or paleontological resources present?	[N] A walk of the area revealed none of the mentioned resources. If cultural resources are found during mining and reclamation operations, proponent has committed to promptly notifying the State Historic Preservation Office and routing the operation around the site of discovery for a reasonable time until salvage can be made.
<b>8. AESTHETICS:</b> Is the project on a prominent topographic feature? Will it be visible from populated or scenic areas? Will there be excessive noise or light?	[Y] The aesthetic impact will be temporary. The site is located along a rural highway. There are no nearby residences.

Are there other activities nearby that will affect the project?	[N] The operation will not use resources that are limited in the area, and it should not impact or be affected by area activities.
<b>10. IMPACTS ON OTHER ENVIRONMENTAL RESOURCES:</b> Are there other studies, plans, or projects on this tract?	[N] Any affect on other environmental resources will be temporary, and the operation should not affect any environmental studies.
