Proposed Implementation Date: Winter 2000

Proponent: Fossom Ready Mix

Type and Purpose of Action: The proponent proposes to mine, crush and transport 50,000 cubic yards of sand & gravel from a 10.5 acre site for supplying the local market with product. The site would be reclaimed by recontouring, respreading the topsoil and reseeding the site with grasses. The reclaimed use would be grazing. The site would be reclaimed by the December of 2006.

<p>1. GEOLOGY AND SOIL QUALITY, STABILITY AND MOISTURE: Are fragile, compactible or unstable soils present? Are there unusual geologic features? Are there special reclamation considerations?</p>	<p>[N] The proposed operation is located on a bench 10 miles northeast of Glasgow. This proposed operation would expand an existing reclaimed gravel pit to the north. The soils are approximately 6 inches deep and are of a clayey silty sandy loam texture. The overburden averages 3 feet in depth. After regrading the overburden and then the soil would be evenly replaced. Microorganisms should reinvade the soil. There are no fragile, compactible or unstable soils present, no unusual geologic features, or special reclamation considerations.</p>
<p>2. WATER QUALITY, QUANTITY AND DISTRIBUTION: Are important surface or groundwater resources present? Is there potential for violation of ambient water quality standards, drinking water maximum contaminant levels, or degradation of water quality?</p>	<p>[N] There are no surface water resources within 1,000 feet of the proposed operation. There are no wells within 1,000 feet of the proposed operation. Depth to the water table is estimated to be 100 feet below the bench. The site would be mined to a depth of 14 feet. Any bulk fuel storage containers would be lined and bermed and be of sufficient size to contain any spills. Best Management Practices would be used to prevent any off site sedimentation or erosion. The proposed operation would not impact groundwater or surface water sources.</p>
<p>3. AIR QUALITY: Will pollutants or particulate be produced? Is the project influenced by air quality regulations or zones (Class I airshed)?</p>	<p>[Y] Air quality would be degraded, but the proponent must comply with air quality standards and have an Air Quality Permit from the Air and Waste Management Bureau of the Montana Dept. of Environmental Quality for the crusher. To control dust, spray bars would be utilized on the crusher and a water truck on the haul road and the mine area.</p>
<p>4. VEGETATION COVER, QUANTITY AND QUALITY: Will vegetative communities be permanently altered? Are any rare plants or cover types present?</p>	<p>[N] The vegetation on the site consists mainly of crested wheatgrass. Native and non-native species would be seeded on the site after recontouring and retopsoiling. A literature search was done by the Montana National Heritage Program and no rare plants or cover types were identified as being present on the site and none were observed during a ground search.</p>
<p>5. TERRESTRIAL, AVIAN AND AQUATIC LIFE AND HABITATS: Is there substantial use of the area by important wildlife, birds or fish?</p>	<p>[N]</p>
<p>6. UNIQUE, ENDANGERED, FRAGILE OR LIMITED ENVIRONMENTAL RESOURCES: Are any federally listed threatened or endangered species or identified habitat present? Any wetlands? Species of special concern?</p>	<p>[N] The Montana Natural Heritage Program did a literature search and no federally listed threatened or endangered species or identified habitats were identified as being present on the site. The literature search did identify the northern redbelly x finescale dace as being present in Cherry Creek, approximately 1.5 miles northeast of the site of the proposed operation. The proposed operation would have no impact on the species. A ground search did not reveal any threatened or endangered species or identified habitat or species of special concern. No wetlands are present.</p>

HISTORICAL AND ARCHAEOLOGICAL SITES: Are any historical, archaeological or paleontological resources present?</p>	<p>[N] The Bureau of Land Management conducted a cultural resource survey and no resources were found. If the operator of the proposed operation discovers any cultural resources the operation must be routed around the site of discovery for a reasonable amount of time until salvage can be made. The State Historical Preservation Office must be promptly notified.</p>
