TYPE AND PURPOSE OF ACTION: E.S. Stone and Structure quarry building stone from several properties in a three county area. They propose to excavate test pits on several properties under lease to evaluate the quality of rock. Up to 10 pits are to be left open at any time for sampling and evaluation. The pits to be dug with a tracked excavator, will be up to 15' deep and 30' long.

Reclamation Plan: Soil will be salvaged during excavation. At closure, each pit would be backfilled and seeded with native grass.
