**Name of Project:** Montana Pollutant Discharge Elimination System (MPDES) permit MT0021920 renewal for wastewater discharges from the City of Great Falls Wastewater Treatment Plant (WWTP).

**Type of Project:** The Department of Environmental Quality (Department) proposes to renew the MPDES permit for the City of Great Falls WWTP discharges for a five-year cycle. The WWTP is a 21 million gallon per day (mgd) activated sludge mechanical treatment plant with chlorine disinfection and anaerobic sludge digestion. Discharge of treated wastewater is to the Missouri River on the north bank of the Black Eagle Reservoir approximately 1.5 mile upstream of Black Eagle Dam and immediately below Sacajawea Island. The Permittee maintains an EPA-mandated Industrial Pretreatment Program for indirect dischargers.

**Location of Project:** 1600 6<sup>th</sup> Street NE, Great Falls, Cascade County, MT

**Agency Action and Applicable Regulations:** The proposed action is to renew the MPDES permit for a five-year cycle.

**Summary of Issues:** The receiving water is the Missouri River. Previous permit limitations remain in effect for the proposed permit cycle, and additional limitations are imposed. Monitoring requirements are increased. Special Conditions addressing compliance with proposed total ammonia as nitrogen limits and facility flow monitoring capabilities are included.

**Benefits and Purpose of Action:** The permit will ensure compliance with the Montana Water Quality Act and protection of the beneficial uses of the Missouri River.
