PART I. PROPOSED ACTION DESCRIPTION

1. **Type of proposed state action:** Montana Fish, Wildlife & Parks (FWP) is proposing to remove an undersized culvert and install a free span 24' x 14' bridge using pressure treated wood stringers, concrete wing walls and surfaced with 14 ft wood planks on the east fork of Fishtrap Creek—a tributary to the Big Hole River. The intent of this project is to improve fish passage for Arctic grayling and other native and sport fish species, improve sediment transport and floodplain function.
2. **Agency authority for the proposed action:**
FWP is required by law to implement programs that manage sensitive fish species in a manner that assists in the maintenance or recovery of those species, and that prevents the need to list species under 87-5-107 or the federal Endangered Species Act. Section 87-1-201(9)(a), M.C.A.

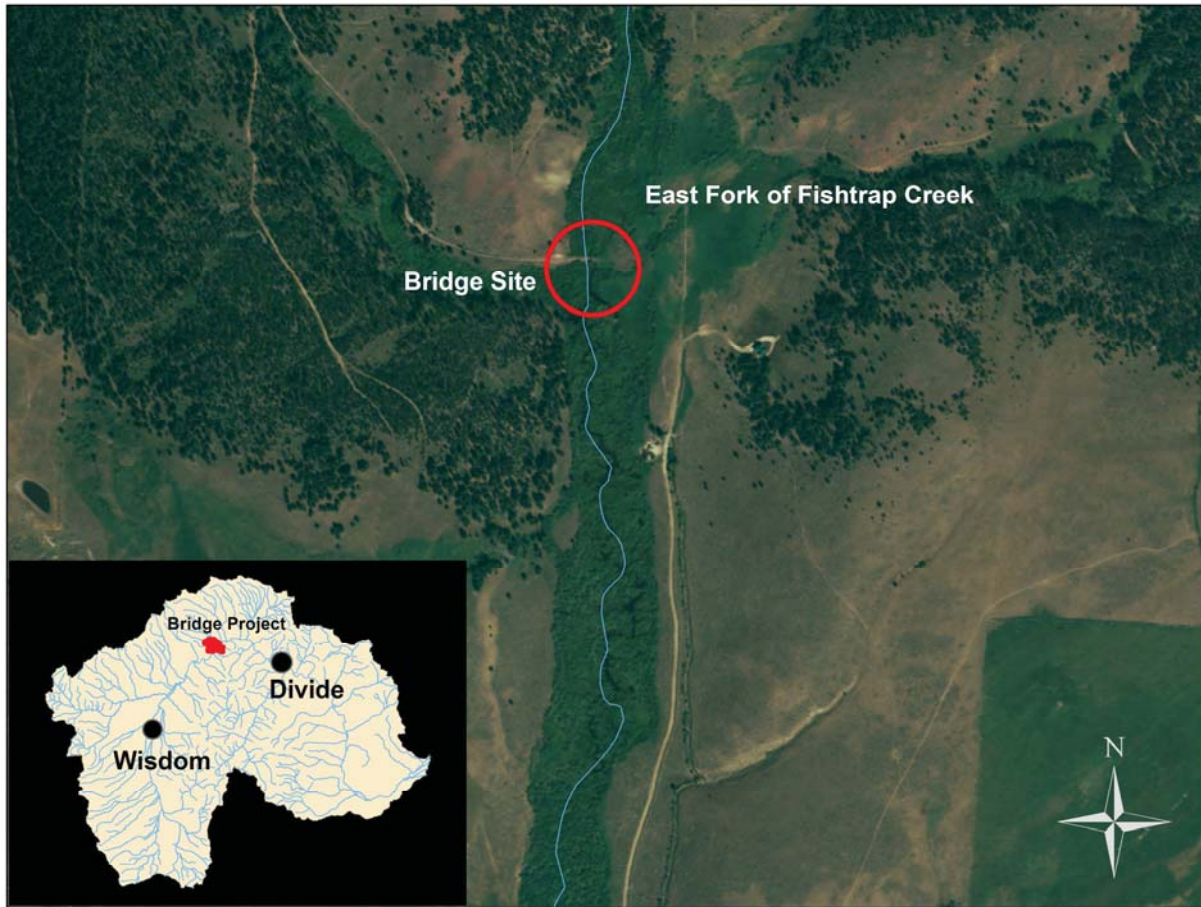


Figure 1. East Fork Fishtrap Creek Bridge Project located north of Wisdom, Montana.

The project site is located on property owned by John Driggers (T2N, R13W, Section 19). The Project is located approximately 20 miles north of the community of Wisdom in Deerlodge County (Figure 1).

7. Narrative summary of the proposed action:

The upper Big Hole River Basin supports the last fluvial Arctic grayling population in the lower 48 United States. These fish are classified as a “species of special concern” by FWP because of their reduced abundance and diminished distribution.

Access to critical habitats (spawning, rearing, summer and winter) is an essential component throughout the life-cycle of Arctic grayling. Connectivity to healthy instream habitats has been identified as a key conservation element of the Big Hole Arctic Grayling Candidate Conservation Agreement with Assurances Program (CCAA). This program works with private landowners to develop and implement conservation plans on privately owned ranches that address limiting factors and improve habitats for the Big Hole Arctic grayling population. This project will improve fish passage by replacing an undersized culvert with a bridge that will eliminate velocities that may inhibit movement through the culvert during specific flows. The culvert is undersized and does not have the capacity for high-water events and cannot transport sediment or access a floodplain. Removal of the culvert and installing a bridge will widen the channel to the appropriate size that will improve sediment transport, access to the floodplain and reduce water velocity.

This project is part of a much larger effort on Fishtrap Creek to improve habitat for Arctic grayling and numerous other fish and wildlife species. These efforts include installing riparian fence, developing grazing management plans, developing off stream stock watering facilities, improving irrigation infrastructure that will assist with implementing an instream flow conservation plan and improving fish passage. Cumulatively these projects will, over time, produce complex, high quality fish habitat. Carrying capacity and overall numbers of Arctic grayling and other native and sportfish species will improve.

8. Alternatives:

Alternative A: No Action

Under this alternative, the culvert will remain in the east fork of Fishtrap Creek and fish passage may be inhibited during high flows, along with compromised sediment transport and floodplain function. Arctic grayling and other native and sportfish species will not be able to access important habitats throughout the year. The landowner may not have access to adjacent properties if the culvert continues to erode. The landowner will have a continual maintenance problem that requires disturbance to stream banks, and stream channel to repair.

Alternative B: Repair Culvert

The current culvert is in need of repair and is eroding on both the upstream and downstream ends. Repair would involve resetting the culvert into the stream bed and stabilizing both ends with rock or concrete. Maintenance would be required periodically depending on magnitude and frequency of runoff events, and the corresponding erosion to surrounding stream banks. Fish passage would still be inhibited and sediment transport and floodplain function compromised.

Alternative C: Proposed Action

The proposed alternative will provide fish passage in all flow conditions, improve sediment transport and floodplain function, while providing the landowner access to adjacent property. Project will reduce disturbance to stream banks and the channel that occurs with maintenance of the culvert. This project is complimentary to numerous restoration projects on Fishtrap Creek to actively restore the overall aquatic and riparian habitats of Fishtrap Creek. Fluvial Arctic grayling, as well as other native and sportfish species will benefit from this project by providing fish passage to important habitats and improving stream function.

Comment 1a/b. Soils along the stream margin would be disturbed during the installation of bridge. Soils disturbed by construction will be reseeded with native vegetation.

Comment 1d. Short-term increases in turbidity will occur during project construction. To minimize this dynamic, construction will occur during low-flow periods and the operation of equipment in the stream channel will be minimized to the extent practical. The Department of Environmental Quality will be contacted to determine narrative conditions required to meet short-term water quality standards and protect aquatic biota. A 124 permit (Stream Protection Act) will be obtained from FWP and a 404 permit will be obtained from the U.S. Army Corps of Engineers. Bridge will benefit channel by eliminating disturbance to streambed and banks for maintenance and therefore reduce siltation, deposition and erosion. Sediment transport will also improve.

Comment 5c. This project will improve fish passage, and decrease erosion of stream banks and disturbance of the stream channel which will provide benefit to numerous aquatic, avian and terrestrial species.

Comment 11b. The proposed action will negatively affect aesthetics during project construction because of ground disturbance and the presence of heavy equipment. These negative effects will be relatively short-term and the heavy equipment on-site will be minimal (a maximum of two excavators working at one time). Proposed action is expected to have long-term positive impacts to the aesthetics of stream, and the riparian corridors once the reseeding of the disturbed areas is completed, and vegetation is established. The stabilization of the streambanks is expected to reduce bank erosion and contribution of sediments to the east fork of Fishtrap Creek.
