

**Montana Board of Oil and Gas Conservation

Air Quality

(possible concerns)

Long drilling time: No, 30 to 40 days drilling time.

Unusually deep drilling (high horsepower rig): No, triple derrick drilling rig to drill a single lateral Three Forks Formation well test to 18,906' MD/9,585' TVD.

Possible H2S gas production: H2S gas production possibility is slight.

In/near Class I air quality area: Closest Class I air quality area in the area of review is the Fort Peck Indian Reservation, about 5 miles to the west of this location.

Air quality permit for flaring/venting (if productive): Yes, DEQ air quality permit required under rule 75-2-211.

Mitigation:

Air quality permit (AQB review)

Gas plants/pipelines available for sour gas

Special equipment/procedures requirements

Other:

Comments: No special concerns – using triple derrick drilling rig to drill a single lateral Three Forks Formation well, 18,906' MD/9,585' TVD. If existing pipeline for H2S gas in the area, gas can be gathered or if no gathering system nearby, H2S gas can be flared under Board Rule 36.22.1220.

Water Quality

(possible concerns)

Salt/oil based mud: Yes, oil based invert drilling fluids will be used on the mainhole. The horizontal lateral will be drilled with brine water. The surface hole will be drilled with freshwater and freshwater drilling fluids.

High water table: No, no high water table anticipated in the area of review.

Surface drainage leads to live water: No, nearest drainage is an unnamed ephemeral drainage to Sheep Creek, about 3/8 of a mile to the southeast from this location.

Water well contamination: None, closest water wells are about 3/4 of a mile to the southeast, about 1 mile to the east, about 1 mile to the northwest and about 1.25 miles to the northwest from this location. The town of Froid, Montana has 3 public and domestic water supply wells, about 3/4 of a mile and further from this location. Depth of this domestic water wells range from 64' to 800'. There are a number of MSCA shallow surface monitoring wells to the northwest, east and southwest from this location. All of these monitoring wells are less than 50' in depth. Surface casing hole will be drilled with freshwater and freshwater drilling fluids. Surface casing will be run and cemented to surface from 2000'.

Porous/permeable soils: No, sandy clay soils.

Class I stream drainage: No class I stream drainages in this area.

Mitigation:

Lined reserve pit

Adequate surface casing

- Berms/dykes, re-routed drainage
- Closed mud system
- Off-site disposal of solids/liquids (in approved facility)
- Other:

Comments: 2000' of surface casing cemented to surface adequate to protect freshwater zones and to cover the base of the Fox Hills Formation.

Soils/Vegetation/Land Use

(possible concerns)

Stream crossings: No, stream crossings anticipated.

High erosion potential: No, small cut, up to 2.7' and small fill, up to 1.0', required.

Loss of soil productivity: None, location to be restored after drilling well, if well is nonproductive. If productive unused portion of drillsite will be reclaimed.

Unusually large wellsite: No, a large wellsite 400'X440' location size required.

Damage to improvements: No surface use is a cultivated field.

Conflict with existing land use/values: Slight

Mitigation

- Avoid improvements (topographic tolerance)
- Exception location requested
- Stockpile topsoil
- Stream Crossing Permit (other agency review)
- Reclaim unused part of wellsite if productive
- Special construction methods to enhance reclamation
- Other

Comments: Access to location will be over existing county road, #2046 (East South Froid Road). A short access of 159' will be built off county road into location. Oil based invert drilling fluids will be recycled. Completion fluids will be hauled to an authorized Class II Disposal. Drilling cuttings and mud solids will be fly ashed in the lined pit and buried with subsoil cover. No special concerns.

Health Hazards/Noise

(possible concerns)

Proximity to public facilities/residences: Nearest residences are about 1 mile to the north and about 1 mile to the west northwest from the location. The town of Froid, Montana is about 1 mile to the west northwest from this location.

Possibility of H2S: H2S potential is slight.

Size of rig/length of drilling time: Triple drilling rig/short 30 to 40 days drilling time.

Mitigation:

- Proper BOP equipment
- Topographic sound barriers
- H2S contingency and/or evacuation plan
- Special equipment/procedures requirements
- Other:

Comments: Adequate surface casing and operational BOP should mitigate any problems. No concerns.

Wildlife/recreation

(possible concerns)

Proximity to sensitive wildlife areas (DFWP identified): Medicine Lake National Wildlife Refuge boundaries are about 7 miles to the northeast and 3.9 miles to the northwest from this location.

Proximity to recreation sites: Medicine Lake National Wildlife Refuge is about 7 miles to the northeast from this location.

Creation of new access to wildlife habitat: No, surface use is a cultivated field.

Conflict with game range/refuge management: No

Threatened or endangered Species: Species identified as threatened or endangered are the Pallid Sturgeon, Interior Lease Tern, Whooping Crane and Piping Plover.

Candidate species is the Sprague's Pipit. MTFWP Natural Heritage Tracker website lists ten (10) species of concerns. They are Grasshopper Sparrow, Sprague's Pipit, Great Blue Heron, Burrowing Owl, Ferruginous Hawk, Chestnut-collared Longspur, Sedge Wen, Yellow Rail, Boblink and Whooping Crane. MTFWP Natural Heritage Tracker website lists one (1) potential species of concern. It is the Eastern-Screech Owl.

Mitigation:

- Avoidance (topographic tolerance/exception)
- Other agency review (DFWP, federal agencies, DSL)
- Screening/fencing of pits, drillsite
- Other:

Comments: The drilling of this well should have no effect on the Medicine Lake National Wildlife Refuge. The surface ownership is private land and surface use is cultivated surface lands. There may be species of concern that maybe impacted by this wellsite. We ask the operator to consult with the surface owner as to what he would like done, if a species of concern is discovered at this location. The Board of Oil & Gas has no jurisdiction over private surface lands.

Historical/Cultural/Paleontological

(possible concerns)

Proximity to known sites None identified.

Mitigation

- avoidance (topographic tolerance, location exception)
- other agency review (SHPO, DSL, federal agencies)
- Other:

Comments: On private cultivated surface lands. There may be possible historical/cultural/paleontological sites that maybe impacted by this wellsite. We ask the operator to consult with the surface owner as to his desires to preserve these sites or not, if they are found during construction of the wellsite. The Board of Oil & Gas has no jurisdiction over private surface lands.

Social/Economic

(possible concerns)

- Substantial effect on tax base
- Create demand for new governmental services
- Population increase or relocation

Comments: No concerns.

Remarks or Special Concerns for this site

18,906'MD/9,585'TVD Three Forks Formation horizontal well test. No concerns.

Summary: Evaluation of Impacts and Cumulative effects

No significant long term impacts expected, some short term impacts will occur.
