### I. TYPE AND PURPOSE OF ACTION

Ronnie Schaffer has requested a land use license from the DNRC for the purpose of placing and maintaining a stock water pipeline and a storage tank across and upon state owned T5S-R54E-Sec 36. This pipeline will create more reliable water sources for livestock and wildlife, while creating better grazing distribution within the scope of the project.

Alternative A- There may be disruption to some of the vegetation currently growing at the site. Species present on the site include Western Wheatgrass (*Agropyron smithii*), Blue Grama (*Bouteloua gracilis*), Sandberg Bluegrass (*Poa secunda*), Green Needlegrass (*Stipa viridula*), Prairie Sandreed (*Calamovilfa longifolia*) Needle and Thread (*Stipa comata*), Prairie Junegrass (*Koeleria, pyramidata*), Bluebunch Wheatgrass (*Agropyron spicata*), and Cheatgrass (*Bromus tectorum*). After the reclamation has taken place the site will be seeded back to native grass species to be directed by the Eastern Land Office staff.

Alternative A- There may be minimal disruption to the wildlife that inhabit the area. Disturbance may occur while the construction is being completed. After construction is complete and the area is reclaimed there should be minimal impact. This project will also create more reliable water sources for wildlife in the area.
