### I. TYPE AND PURPOSE OF ACTION

To place a fiber optic/cooper telephone cable. 3 Rivers Communications currently has an aerial crossing on NorthWestern Energy power poles that serves the Cascade Creek Subdivision. The aerial crossing has to be removed due to NorthWestern Energy updating and rerouting their line. If granted, this easement would allow 3 Rivers Communications to bore the Gallatin River near the current aerial crossing in order to continue to provide telephone service to their Cascade Creek Subdivision customers.

The Wolverine, Hoary Bat, Canada Lynx, Little Brown Myotis, Grizzly Bear, Golden Eagle, Brown Creeper, Cassin's Finch, Clark's Nutcracker, Green-Tailed Towhee, Brewer's Sparrow, Pacific Wren, Western Toad, Westslope Cutthroat Trout, and Gallatin Mountainsnail have been listed as species of concern by the Montana Natural Heritage Program. No adverse effect would be expected with either alternative.
