



**PUBLIC NOTICE NO. MT-16-09**

PURPOSE OF PUBLIC NOTICE

The purpose of this notice is to state the Department's intention to issue a wastewater discharge permit to the facility listed in this notice and hold a public hearing on the issuance of this permit. This permit is issued by the Department under the authority of 75-5-402, Montana Code Annotated (MCA); the Administrative Rules of Montana (ARM) 17.30.1301 *et seq.*, Montana Pollutant Discharge Elimination System (MPDES); and Sections 402 and 303 of the federal Clean Water Act. The Water Protection Bureau has prepared a draft permit for the facility listed below. The Montana Department of Environmental Quality (DEQ) is reopening the public comment period on the draft Montana Pollutant Discharge Elimination System (MPDES) permit for the Montanore Project, a proposed copper-silver mine near Libby, MT.

The draft MPDES permit is for the discharge of treated adit water at three existing outfalls (Outfalls 001-003) and for the discharge of storm water from four new storm water-only outfalls (Outfalls 004-008). Since the last public notice of the draft MPDES permit, updates were made to the existing effluent limits and additional effluent limits were established at Outfalls 001-003. Additionally, the draft MPDES permit establishes effluent limits at Outfalls 004-008. The draft MPDES permit also requires the facility to develop and maintain a Storm Water Pollution Prevention Plan that includes

establishing Best Management Practices to further control or eliminate discharges of storm water. Finally, the draft MPDES permit requires the monitoring and reporting of the following: the effluent discharges at Outfalls 001-003, the storm water discharges at Outfalls 004-008, and the ambient upstream conditions in Libby Creek.
