### SPECIAL ORDERS OF THE DAY

Representative Grinde asked for the permission of the House to video members on the floor for historical purposes. There were no objections.

The following remarks were made by Representative Younkin recognizing Jeannette Rankin and her works with women's suffrage:

Mr. Speaker, Members of the House, today is an important day in Montana history. On this date, February 1st, in 1911, in an unusual event, one of Montana's great political pioneers, Jeannette Rankin, addressed this body and asked for approval of women's suffrage, which at that time, she later said, "was the funniest thing in the world to most men."

In what is still good and proper today, she asked that they "base their judgment on reason, not on prejudice." She

said, "We do not contend that the extension of the suffrage to women will be a panacea for all evils, but we do contend that it will place the right of suffrage on a basis of reason instead of on a basis of birth."

Jeannette Rankin's historic speech 88 years ago was one of many she gave to secure the right of women to vote and clearly paved the way for the 29 of us in the female persuasion serving in this House today and the 8 women in the Senate. I would like to acknowledge the efforts of Ms. Rankin, a truly remarkable woman in her time, and would submit that this 56th legislature of Montana is a better governing body because of the contributions of more women than ever before.
