COMMUNICATIONS AND PETITIONS

A JOINT PROCLAMATION OF THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE STATE OF MONTANA

WHEREAS, the citizens of Montana recognize reading as fundamental to children's education; and

WHEREAS, Montana has a strong tradition of community involvement in the education of our young people, grounded in the principle that education is key to Montana's well being; and

WHEREAS, research shows that children who read regularly, especially with adults, have greater success in school; and

WHEREAS, "Read Across America," a national celebration of Dr. Seuss's birthday on March 2nd, promotes reading and adult involvement in the education of our students; and

WHEREAS, "Read Across America" is cosponsored by groups such as the American Library Association, National PTA, Boys & Girls Clubs of America, and the International Reading Association, and is supported by educators and parents across Montana;

THEREFORE BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE STATE OF MONTANA:

That this body recognizes March 2 as "Read Across Montana Day" and recommit this state to help make Montana's children, and America's children, the best readers in the world.
