In response to the mental health managed care crisis, a select committee has been formed to provide oversight of the transition from Magellan Health Services to whatever system is created. Formation of this committee is important so that the legislative branch continues to have a role in this process, even after the legislature adjourns in April. Members of the committee are: Rep. Loren Soft, chair; Rep. Trudi Schmidt, vice-chair; Rep. Stan Fisher, Rep. John Cobb, Rep. Bill Eggers and Rep. Bev Barnhart.

The committee is charged with assessing whether DPHHS's transition plan will provide a continuum of services to the people who currently are eligible under the Magellan contract; assessing when Magellan Health Services will transition out of Montana; whether an additional appropriation is needed for transition between the current and new system of mental health care delivery, and if so, how much; assessing whether the current level of services can be maintained; to investigate how much money is owed to providers and whether Magellan Health Services has fulfilled the terms of the contract; and to take whatever legal actions empowered by Montana law to ensure that Magellan Health Services fulfills terms of the contract and reimburses providers for services rendered to clients of the system.

The committee is requested to work with the Appropriations Subcommittee on Human Services to ensure legislation provides for an orderly and fiscally responsible transition. The committee is also requested to work with the Legislative Audit Division in performing oversight and in conducting a performance audit to assess the effectiveness of the state's process in establishing and overseeing a privately contracted managed mental health care system in Montana.

Dear Speaker Mercer and President Crippen:

In accordance with the power vested in me as Governor by the Constitution and laws of the State of Montana, I hereby return with an amendment House Bill 245, "AN ACT IMPLEMENTING RECOMMENDATIONS OF THE AFFORDABLE HOUSING AND LAND USE INITIATIVE; ESTABLISHING A BUILDING CODES COUNCIL; ESTABLISHING A CONTINUING EDUCATION PROGRAM ADMINISTERED BY THE DEPARTMENT OF COMMERCE AND FUNDED BY A PORTION OF INSPECTION FEES; MANDATING THE CREATION OF A CENTRAL REGISTRY OF AUTHORITATIVE INTERPRETATIONS OF BUILDING CODES; PROVIDING FOR STATEWIDE APPROVAL OF MODEL PLANS AND A CHECKLIST FOR THE EXAMINATION OF SINGLE-FAMILY DWELLING CONSTRUCTION PLANS; AND AMENDING SECTIONS 50-60-103, 50-60-106, 50-60-201, AND 50-60-301, MCA," for the following reason.

House Bill 245 includes a requirement that when a building contractor submits to the Department of Commerce or to local government a model construction plan and checklist for a single-family dwelling, the contractor must receive the permit or notice of disapproval within a certain time frame after submission of the completed checklist. The time frame that was included in the introduced version of House Bill 245 was five days. It was changed to ten days, to reflect a more realistic turnaround time.

Although the ten day time frame was amended into the section that addressed the duties of counties and municipalities (section 6), it was inadvertently left out of the section that addressed the duties of the Department of Commerce

(section 4). My proposed amendment removes this inconsistency.

Representative Simon, the sponsor of the bill, is aware of and agrees with this proposed amendment.
