 - (a) 49% is allocated to the research and commercialization expendable trust fund established in [section 2];
 - (b) 12.24% is allocated to the long-range building program account established in 17-7-205;
- (c) 8.53% is allocated to the account in the state special revenue fund provided for in 15-35-108(3) to be used as provided in that subsection;
- (d) 1.3% is allocated to the nonexpendable trust for parks acquisition or management to be used as provided in Title 23, chapter 1, part 1;
- (e) 0.97% is allocated to the debt service fund type to the credit of the renewable resource loan debt service fund;
- (f) beginning July 1, 1999, and ending June 30, 2007, 1.33% is allocated to the long-range building program fund in the debt service fund type to fund the bonds issued for the purchase of Virginia City and Nevada City property; and
 - (g) the remainder is allocated to the state general fund."

Insert: "NEW SECTION. Section 9. Board of research and commercialization technology. (1) There is a Montana board of research and commercialization technology.

- (2) The board consists of six members. One member must be appointed by the president of the senate, one member must be appointed by the minority leader of the senate, one member must be appointed by the speaker of the house, one member must be appointed by the minority leader of the house, and two members must be appointed by the governor. One of the members appointed by the governor must be an enrolled member of a Montana tribal government.
 - (3) A member who ceases to live in the state is disqualified from membership, and the position becomes vacant.

If a vacancy occurs, the position must be filled in the manner of the original appointment.

- (4) The board shall hire an executive director and two program specialists and shall prescribe the executive director's and program specialists' salaries and duties.
- (5) (a) The board is a quasi-judicial entity subject to the provisions of 2-15-124, except that none of the members are required to be licensed to practice law in the state.
- (b) The board shall elect a presiding officer from among its members at an annual election. The presiding officer may be reelected.
 - (c) Except for the original appointments, members shall serve 2-year terms.
 - (6) The board is attached to the department of commerce for administrative purposes only."
- **Insert:** "NEW SECTION. Section 10. Meetings -- compensation. (1) The Montana board of research and commercialization technology may determine the time and place of its meetings but shall meet at least once each quarter.
- (2) Each member of the board, except legislative members, is entitled to receive compensation of \$100 a day plus travel expenses, pursuant to 2-18-501 through 2-18-503, for each day spent conducting official board business."

- (a) managing staff;

developments and opportunities in diversified research arenas;

- (d) monitoring and promoting activities that increase the presence of Montana products in new and expanding markets:
 - (e) promoting and facilitating program strategies that add value to Montana products; and
 - (f) any additional responsibilities determined necessary and appropriate by the board.
- (2) The executive director shall develop a job description for each program specialist position and recommend two

candidates for selection by the board, one each with specific experience in the fields of:

- (a) business development; and
- (b) research and commercialization.
- (3) The executive director may hire additional staff as necessary within budgetary limitations as prescribed by the board."
- "NEW SECTION. Section 12. Initial board appointments. In order to implement staggered terms, the original appointments to the Montana board of research and commercialization technology must be for the following terms:
 - (1) the appointees of the president of the senate and minority leader of the house, 1 year;
 - (2) the appointees of the speaker of the house and the minority leader of the senate, 2 years; and
 - (3) the appointees of the governor to 1-year and 2-year terms respectively.

- (e) the name of the licensed installer who will be installing or closing the underground storage tank system or, if the owner or operator is not going to have the underground storage tank system installed or closed by a licensed installer, the estimated date for inspection by the department.
- (3) After receipt of a completed application that meets the requirements of this section and any rules adopted under 75-11-204(1), the department shall issue the permit.""

Dear President Crippen and Speaker Mercer:

In accordance with the power vested in me as Governor by the Constitution and laws of the State of Montana, I hereby return Senate Bill No. 166, "AN ACT REVISING COUNTY SHERIFF AND CITY POLICE RESPONSIBILITIES FOR HANDLING ABANDONED VEHICLES; PROVIDING FOR PAYMENT OF CERTAIN ABANDONED VEHICLE REMOVAL CHARGES FROM MOTOR VEHICLE DISPOSAL FEES, SUBJECT TO THE AVAILABILITY OF FUNDING; TRANSFERRING RESPONSIBILITY FOR DETERMINING VALUE OF A JUNK VEHICLE FROM THE STATE TO COUNTIES; AMENDING SECTIONS 61-12-401, 61-12-402, 61-12-403, 61-12-404, 75-10-503, AND 75-10-532, MCA; AND PROVIDING AN EFFECTIVE DATE," for the following reasons.

Senate Bill 166 amends the motor vehicle recycling and disposal statutes contained in Title 75, Chapter 10, part 5, MCA. Section 75-10-532, MCA, currently provides that money from the sale or recycling of junk vehicles, from motor vehicle wrecking facility license fees, and from motor vehicle disposal fees must be used for the control, collection, recycling, and disposal of junk vehicles. Section 75-10-534, MCA, requires the Department of Environmental Quality to fund approved budgets for the counties' junk vehicle programs. The Department provides this funding to the counties from the junk vehicle license fees and sale revenues.

Senate Bill 166 amends 75-10-532 by authorizing the Department of Environmental Quality to also use junk vehicle

revenues to reimburse sheriffs and police departments for the costs of removing abandoned vehicles. However, House Bill 2, as currently written, does not appropriate enough funding to the Department of Environmental Quality to pay for both the county junk vehicle programs and the costs of removing abandoned vehicles. Senate Bill 166 anticipates this contingency by providing that the abandoned vehicle funding authorization is "subject to the availability of funding." This language does not, however, clearly indicate whether the Department in this situation must totally fund the junk vehicle programs and not fund the removal programs or whether it must fund a portion of each.

I believe that the intent of the Legislature is to ensure that the junk vehicle programs are always fully funded. I agree with this intent. I am therefore proposing amendments that would clearly so provide by requiring separate appropriations for junk vehicles and for abandoned vehicles.

It is my understanding that Senator Lynch, the sponsor of Senate Bill 166, is aware of and agreeable to this amendment.
