Dear President Crippen and Speaker Mercer:

In accordance with the power vested in me as Governor by the Constitution and laws of the State of Montana, I hereby return with amendments Senate Bill 270, "**AN ACT ALLOWING A COUNTY TO CHARGE THE DEPARTMENT OF REVENUE FOR SPACE PROVIDED IN A COUNTY COURTHOUSE OR OTHER COUNTY BUILDING; LIMITING THE AMOUNT THAT CAN BE CHARGED; AND AMENDING SECTION 15-8-102, MCA,**" for the following reason.

Senate Bill 270 provides the mechanism for counties to charge rent to the Department of Revenue for county office space. The language of the bill authorizes counties to charge rent only for the Department's "assessment and appraisal staff." The Department plans to co-locate in some counties its employees who work on unemployment and income taxation as well as on property taxes. The use of the words "assessment and appraisal" will create confusion about exactly what the counties' authority is with respect to charging rent to the Department.

For these reasons I am returning Senate Bill 270 with a proposed amendment that would remove the confusing language. It is my understanding that Senator Devlin, the sponsor of the bill, is agreeable with the amendment.
