(c) a default supplier may not obligate customers to a contractual term or service;

(d) federal power marketing administration power or benefits acquired by a default supplier are distributed as widely and equitably as possible among small customers and in a manner that encourages competition;

(e) a default supplier, except when the default supplier is the distribution services provider, may not construct, purchase, take, receive, or otherwise acquire or own, hold, equip, maintain, or operate electric generating plants or transmission or distribution lines or systems, except that a default supplier may enter into transmission or distribution agreements for the lease or use of capacity on transmission and distribution systems owned by others to supply electricity to its customers in the state;

(f) a default supplier may not offer for sale any products other than electricity supply or provide electricity supply to members or customers other than those residing in the state or sell electricity or otherwise engage in the marketing of electricity on the wholesale market, but may dispose of excess

electricity associated with temporary load-energy imbalances.

(3) Except as provided in subsection (2)(e), a default supplier may provide only a single electricity supply service to all of its small customers. A default supplier may also offer an additional electricity supply service that includes a component of renewable energy.

(4) A default supplier may not offer other supply services unless the default supplier forms a separate entity."

In accordance with the power vested in me as Governor by the Constitution and laws of the State of Montana, I hereby return with an amendment House Bill 90, **“AN ACT AUTHORIZING A DISTRICT TO ANTICIPATE THE AMOUNT OF CERTAIN NONLEVY REVENUE FOR COMPUTATION OF THE GENERAL FUND LEVY REQUIREMENT; CLARIFYING THE TAXABLE VALUATION USED TO CALCULATE THE NUMBER OF MILLS LEVIED; AUTHORIZING A DISTRICT TO IMPOSE A LEVY TO ELIMINATE ANY NEGATIVE FUND BALANCE AND RESTORE RESERVES TO THE PRIOR YEAR’S OPERATING RESERVE; AMENDING SECTION 20-9-141, MCA; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE, AN APPLICABILITY DATE, AND A TERMINATION DATE,”** for the following reasons.

House Bill 90 authorizes school districts to anticipate the amount of certain nonlevy revenue when they are computing the general fund levy. According to current law, the previous years motor vehicle tax collections are utilized to establish the budget and levy requirements of every district each year. Due to the passage of Senate Bill 260, however, taxation on motor vehicles will decline as a source of nonlevy revenue in school districts throughout the State.

Because motor vehicle tax revenues will fall short of previous year’s revenues due to the reductions in Senate Bill 260, districts will be left with a shortage of revenues to reach their approved base budgets. This amendment will correct the situation, allowing districts to estimate their projected revenues from motor vehicle taxes so that they can levy adequate mills to fund their base budgets.

Representative Hagener, the sponsor of the bill, is aware of and agrees with this proposed amendment.

In accordance with the power vested in me as Governor by the Constitution and laws of the State of Montana, I hereby return with amendments House Bill 260, **"AN ACT ENCOURAGING ECONOMIC DEVELOPMENT THROUGH INVESTMENT IN RESEARCH AND COMMERCIALIZATION PROJECTS; ESTABLISHING A RESEARCH AND COMMERCIALIZATION EXPENDABLE TRUST FUND; ESTABLISHING A COAL PRODUCER'S LICENSE TAX; ALLOCATING COAL PRODUCERS LICENSE TAX REVENUE; PROVIDING FOR A CREDIT AGAINST COAL SEVERANCE TAXES FOR COAL PRODUCER'S LICENSE TAXES PAID; STATUTORILY APPROPRIATING COAL PRODUCER'S LICENSE TAXES TO SUPPORT RESEARCH AND COMMERCIALIZATION CENTERS AND TO BE USED AS MATCHING FUNDS; AMENDING SECTIONS 17-5-703, 17-5-709, AND 17-7-502, MCA; AND PROVIDING AN EFFECTIVE DATE,"** for the following reasons.

House Bill 260 creates a coal producers' license tax and a research and commercialization expendable trust fund. The purpose of the bill is to support research and commercialization projects and thereby encourage economic development in Montana.

Section 16 of House Bill 260 sets forth a list of funds and accounts to which the proceeds from the coal producers' license tax are allocated. There are presently two yet unfunded projects that I am proposing be added to this list. One is a presidential preference primary in Montana to be held to coincide with the proposed Western Regional Presidential Preference Primary Election, still under consideration in House Bill 490. The other involves the ongoing planning and building of industrial infrastructure by tax increment financing industrial districts.

The reductions in taxable value on business equipment in Senate Bill 200 have created a unique problem for tax increment financing industrial districts which have been developing critically important industrial infrastructure based upon the revenue flow from business equipment taxes. The payment for and creation of that industrial infrastructure is a critical component of the broad economic development programs and job creation that are the ultimate purpose

for the funding that is in House Bill 260.

These amendments will provide the funding for House Bill 490's presidential preference primary election in Montana and will provide targeted funds to allow existing tax increment financing industrial districts to continue to develop infrastructure in an effort to support vitally needed economic development for Montana.

In accordance with the power vested in me as Governor by the Constitution and laws of the State of Montana, I hereby return with an amendment House Bill 321, "**AN ACT REQUIRING THE DEPARTMENT OF COMMERCE TO INSPECT ELEVATORS, ESCALATORS, DUMBWAITERS, INCLUDING DUMBWAITERS WITH AUTOMATIC TRANSFER DEVICES, MOVING WALKS, MATERIAL LIFTS, WHEELCHAIR LIFTS, AND STAIRWAY CHAIR LIFTS TO ENSURE COMPLIANCE WITH THE STATE BUILDING CODE; EXCEPTING PRIVATE RESIDENCES AND FARM AND RANCH OPERATIONS FROM THE REQUIREMENT; AND AMENDING SECTIONS 50-60-701, 50-60-702, AND 50-60-703, MCA; AND PROVIDING AN EFFECTIVE DATE,**" for the following reasons.

House Bill 321 expands the elevator inspection program to make the inspection mandatory and to include freight elevators. The existing inspection program is permissive and is limited to passenger elevators. The fiscal note states that because of the additional estimated 1,000 freight elevators to be inspected, the workload of the program will increase by 80%, and an additional 1.5 FTE will be required.

While the expanded program is to be funded by inspection fees, there is no spending authority in House Bill 2, nor does House Bill 2 provide for the 1.5 FTE needed to carry out the inspections. The existing program cannot handle the increased workload nor can it absorb the additional costs within its existing budget. Consequently, I am proposing that House Bill 321 be rendered void if adequate resources are not provided in House Bill 2.

It is my understanding that Representative Fuchs, the sponsor of the bill, understands the need for the proposed amendment.

In accordance with the power vested in me as Governor by the Constitution and laws of the State of Montana, I hereby return with amendments Senate Bill 186, "**AN ACT PROVIDING FOR BREATH TESTS FOR PERSONS SUSPECTED OF CARRYING A CONCEALED WEAPON WHILE UNDER THE INFLUENCE OF ALCOHOL; REGULATING TEST ADMINISTRATION AND USE; PROVIDING FOR REVOCATION OF A PERMIT FOR REFUSAL TO TAKE A TEST; REVISING THE PLACES INSIDE OF WHICH A CONCEALED WEAPON MAY NOT BE CARRIED; AND AMENDING SECTIONS 45-8-327 AND 45-8-328, MCA,**" for the following reasons.

Senate Bill 186 changes current law to permit the carrying of concealed weapons in, among other places, bars and restaurants where alcohol is served. The problems that may arise from such a relaxation of the law as it pertains to bars and restaurants where alcohol is served, seem obvious. In an effort to address such concerns, the bill gives peace officers permission to request breath tests of those in bars and restaurants who appear to be under the influence of an alcoholic beverage.

The current prohibition against carrying a concealed weapon in a bar or restaurant has been on the books since 1991. Since that time Montana's population has increased, more alcohol is served and more permits are issued for concealed weapons. Although I can understand the reasons for changing the law as it pertains to those places other than a bar or restaurant where alcohol is served, I feel strongly that these amendments, as they pertain to carrying a concealed weapon in a bar or restaurant where alcohol is served, are ill-advised.

My proposed amendments would keep in place the prohibition on carrying concealed weapons into bars and

restaurants where alcohol is served. Without the ability to carry concealed weapons in bars and restaurants where alcohol is served, there is no need for Section 1 of the Senate Bill 186, which authorizes breath tests in these establishments, and so I am proposing that Section 1 be struck from the bill as well. The amendments leave in place the provisions in the bill that permit carrying concealed weapons while using a drive-up bank window, an automatic teller machine or unstaffed financial services locations.

For these reasons I am returning Senate Bill 186 with proposed amendments.
