The rules must require that the primitive fishing access sites designated by the commission may not be developed beyond what is necessary to maintain the site for public use. The rules must specifically prohibit the new development or new installation of:

(a) fencing of the perimeter unless it is necessary for the security of the site or for preventing conflicts near

the site:

- (b) access roads beyond those that are maintained to prevent degradation of the site and provide reasonable and safe vehicular access;
 - (c) paved roads or parking areas;
- (d) signs beyond those that are necessary to provide directions from the nearest public road and those that provide regulation, public safety, or interpretive information;
- (e) latrines unless determined necessary for health or sanitation as determined by the regional park manager or county sanitarian;
 - (f) potable water stations;
 - (g) boat ramps larger than a single lane;
 - (h) camping or picnic areas; and
 - (i) barriers beyond those necessary to prevent unauthorized off-road travel.
- (2) The rules may allow for replacement of existing facilities and maintenance of existing improvements." **Insert:** "Section 3. Section 23-1-105, MCA, is amended to read:
- "23-1-105. Fees and charges. (1) The department shall have power to may levy and collect reasonable fees or other charges for the use of privileges and conveniences as may be provided and to grant concessions as it considers advisable, except as provided in subsection subsections (2) and (5). All money derived from the activities of the department must be deposited in the state treasury in a state special revenue fund to the credit of the department.
- (2) Overnight camping fees established by the department under subsection (1) must be discounted 50% for a campsite rented by a person who is a resident of Montana, as defined in 87-2-102, and either 62 years of age or older or certified as disabled in accordance with rules adopted by the department.
- (3) For a violation of any fee collection rule involving a vehicle, the registered owner of the vehicle at the time of the violation is personally responsible if an adult is not in the vehicle at the time the violation is discovered by an authorized officer. A defense that the vehicle was driven into the fee area by another person is not allowable unless it is shown that at that time the vehicle was being used without the consent of the registered owner.
- (4) Money received from the collection of fees and charges is not subject to the deposit requirements of 17-6-105. The department shall deposit money collected under this section within a reasonable time after receipt.
- (5) A person who possesses a valid state parks passport is not required to pay a fee for noncommercial day use or for camping at any primitive fishing access site designated pursuant to [section 2].""

MESSAGES FROM THE GOVERNOR

March 29, 1999

Dear President Crippen and Speaker Mercer:

In accordance with the power vested in me as Governor by the Constitution and laws of the State of Montana, I hereby return Senate Bill No. 166, "AN ACT REVISING COUNTY SHERIFF AND CITY POLICE RESPONSIBILITIES FOR HANDLING ABANDONED VEHICLES; PROVIDING FOR PAYMENT OF CERTAIN ABANDONED VEHICLE REMOVAL CHARGES FROM MOTOR VEHICLE DISPOSAL FEES, SUBJECT TO THE AVAILABILITY OF FUNDING; TRANSFERRING RESPONSIBILITY FOR DETERMINING VALUE OF A JUNK VEHICLE FROM THE STATE TO COUNTIES; AMENDING SECTIONS 61-12-401, 61-12-402, 61-12-403, 61-12-404, 75-10-503, AND 75-10-532, MCA; AND PROVIDING AN EFFECTIVE DATE," for the following reasons.

Senate Bill 166 amends the motor vehicle recycling and disposal statutes contained in Title 75, Chapter 10, part 5, MCA. Section 75-10-532, MCA, currently provides that money from the sale or recycling of junk vehicles, from motor vehicle wrecking facility license fees, and from motor vehicle disposal fees must be used for the control, collection, recycling, and disposal of junk vehicles. Section 75-10-534, MCA, requires the Department of Environmental Quality to fund approved budgets for the counties' junk vehicle programs. The Department provides this funding to the counties from the junk vehicle license fees and sale revenues.

Senate Bill 166 amends 75-10-532 by authorizing the Department of Environmental Quality to also use junk vehicle revenues to reimburse sheriffs and police departments for the costs of removing abandoned vehicles. However, House Bill 2, as currently written, does not appropriate enough funding to the Department of Environmental Quality to pay for both the county junk vehicle programs and the costs of removing abandoned vehicles. Senate Bill 166 anticipates this contingency by providing that the abandoned vehicle funding authorization is "subject to the availability of funding." This language does not, however, clearly indicate whether the Department in this situation must totally fund the junk vehicle programs and not fund the removal programs or whether it must fund a portion of each.

I believe that the intent of the Legislature is to ensure that the junk vehicle programs are always fully funded. I agree with this intent. I am therefore proposing amendments that would clearly so provide by requiring separate appropriations for junk vehicles and for abandoned vehicles.

It is my understanding that Senator Lynch, the sponsor of Senate Bill 166, is aware of and agreeable to this amendment.

A PROCLAMATION OF THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE STATE OF MONTANA

WHEREAS, from 1993 to 1996, Dr. Jeff Baker served as Commissioner of Higher Education for the Montana University System. In addition to his position as Commissioner, Dr. Baker served as chief executive officer for Montana's six 4-year institutions and five colleges of technology, as chief executive officer of the Montana Guaranteed Student Loan program, and as president of the Montana Higher Education Student Assistance Corporation. Prior to his selection as Commissioner, Dr. Baker served from 1988 to 1993 as dean and vice president for academic affairs at Carroll College in Helena, Montana. From 1996 until the time of his death, Dr. Baker served as president of Luther College in Decorah, Iowa; and

WHEREAS, as Commissioner of Higher Education, Dr. Baker was responsible for planning and implementing the restructuring of the Montana University System and worked diligently to establish the Montana Tuition Assistance program, which provides cash assistance to low-income working students enrolled in the Montana

University System. In tribute to his commitment to the needs of these students, the Board of Regents has appropriately renamed its scholarship program the "Baker grants"; and

WHEREAS, as the primary representative of the Montana University System before the Senate and House of Representatives, Dr. Baker confronted many contentious and controversial issues, yet consistently treated everyone with respect and dignity. Before legislative committees, Dr. Baker earned a reputation for honesty, forthrightness, good humor, and never-ending enthusiasm and together with his wife, Shirley, bestowed kindness and graciousness on all who came to know them; and

WHEREAS, Dr. Jeff Baker was a true friend to the Legislature and the citizens of Montana and through his unselfish service, made Montana a better place.

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE STATE OF MONTANA:

That the Legislature hereby honor Dr. Jeff Baker for his dedicated service, scholarship, and unwavering commitment to students and to the improvement of education in the State of Montana.
