Dear Representative Wanzenried:

Yesterday you asked me what the intentions of the majority are with regard to HB 74. The answer very quickly becomes enigmatic.

It is now apparent to everyone that the vast majority of House Democrats are not, under any circumstances, going to support using the Coal Tax Trust Fund. That being the case, I find myself for the first time this session, asking you to do something and then to get back to me.

Since your caucus finds itself unable to support any use of the Coal Tax Trust Fund, I would ask you, upon return from the coming transmittal break, to meet with me and present your proposals for balancing the 2004-2005 budget. Please provide me with appropriate specifics as to what budget reductions you would recommend, and what revenue enhancements (taxes, transfers, etc.) you would also recommend.

My understanding of a reasonable compromise is as follows: If I take a position at the number one and you take a position at the number ten, the complete compromise is found around five and one-half, not nine and not two.

To return to your original question, what happens to Representative Lewis' HB 74 depends to a large degree upon the quality of your upcoming proposals. HB 74 may be gone, or it could return. I do not know.

I look forward to meeting with you after the transmittal break.
