SENATE BILL NO. 220

INTRODUCED BY F. THOMAS, R. BROWN, DEPRATU, ELLINGSON, FUCHS, KEENAN, LASZLOFFY, MCNUTT, STONINGTON, STORY, TESTER, WHEAT, BRUEGGEMAN

A BILL FOR AN ACT ENTITLED: "AN ACT REVISING THE PUBLIC SERVICE COMMISSION DISTRICTS FOR THE PURPOSE OF POPULATION EQUALITY; PROVIDING FOR TRANSITION; AND AMENDING SECTION 69-1-104, MCA."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

Section 1. Section 69-1-104, MCA, is amended to read:

"69-1-104. Public service commission districts. In this state there are five public service commission districts, with one commissioner elected from each district, distributed as follows:

(1) first district: Blaine, <u>Cascade</u>, Chouteau, Daniels, Dawson, Fergus, Garfield, Glacier, Golden Valley,
Hill, <u>Judith Basin</u>, Liberty, McCone, Musselshell, Petroleum, Phillips, Pondera, Prairie, Richland, Roosevelt,
Sheridan, Toole, <u>and</u> Valley, and Wibaux, <u>AND WIBAUX</u> Counties;

 (2) second district: Big Horn, Carbon, Carter, Custer, Fallon, <u>Musselshell</u>, Powder River, <u>Prairie</u>, Rosebud, Stillwater, Sweet Grass, Treasure, <u>Wibaux</u>, and Yellowstone Counties;

(3) third district: <u>Beaverhead</u>, Broadwater, Cascade, <u>Deer Lodge</u>, <u>Gallatin</u>, <u>Golden Valley</u>, Jefferson, Judith Basin, Lewis and Clark, <u>Madison</u>, Meagher, Teton, <u>MUSSELSHELL</u>, <u>Park</u>, <u>Silver Bow</u>, <u>Stillwater</u>, <u>Sweet</u> <u>Grass</u>, and Wheatland Counties;

 (4) fourth district: Beaverhead, Deer Lodge, Gallatin, Granite, Madison, Park, <u>Lake LINCOLN, Mineral,</u> <u>Missoula</u>, Powell, Ravalli, and <u>Silver Bow</u> <u>Sanders</u> Counties;

(5) fifth district: Flathead, Lake, Glacier, LAKE, Lewis and Clark, Lincoln, Mineral, Missoula, and Sanders Pondera, and Teton Counties."

<u>NEW SECTION.</u> Section 2. Transition. For the purposes of the 2004 election, the secretary of state shall declare which district a sitting commissioner represents for any public service commissioner whose district is not up for election and shall use as criteria the residence of the respective commissioner on [the effective date of this act].

NEW SECTION. Section 3. Saving clause. [This act] does not affect rights and duties that matured,

penalties that were incurred, or proceedings that were begun before [the effective date of this act].
