## A PROCLAMATION OF THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE STATE OF MONTANA March 12, 2005

WHEREAS, East Valley Middle School in East Helena, Montana, won top prize -- a Book Fair shopping spree for the entire school -- in Scholastic's national "Student Crew Contest." The program is designed to excite young people about reading.

WHEREAS, the East Valley Student Crew helped plan and produce a Scholastic Student Exchange Book Fair. They collected donations during their week-long book fair and used the proceeds to purchase books for family members serving in our military overseas.

WHEREAS, crew members also paid tribute to servicemen and women by dressing in camouflage fatigues, decorating their book fair with American flags and yellow ribbons, and inviting local veterans to visit the school and share their stories. A luncheon was held in their honor with all staff invited.

(5)(e) report immediately in writing to the governor any instances of misfeasance, malfeasance, or nonfeasance by a state officer or employee disclosed by the audit of a state agency;

(6)(f) report immediately to the surety upon the bond of an official or employee when an audit discloses

a shortage in the accounts of the official or employee. Failure to notify the surety does not release the surety from any obligation under the bond.

(7)(g) during regularly scheduled audits of state agencies, audit and report on agency compliance with the provision of 2-6-211(1) regarding the transfer and storage of public records.

(7)(2) have The legislative auditor has the authority to audit records of organizations and individuals receiving grants from or on behalf of the state to determine that the grants are administered in accordance with the grant terms and conditions. Whenever a state agency enters into an agreement to grant resources under its control to others, the agency shall obtain the written consent of the grantee to the audit provided for in this subsection." **Renumber:** subsequent sections
