Dear President Tester and Speaker Matthews:

In accordance with the power vested in me as Governor by the Constitution and the laws of the State of Montana, I hereby return with amendments House Bill 11, "AN ACT REVISING THE LAWS GOVERNING THE TREASURE STATE ENDOWMENT PROGRAM; REVISING THE USES OF THE TREASURE STATE ENDOWMENT STATE SPECIAL REVENUE ACCOUNT AND THE TREASURE STATE ENDOWMENT REGIONAL WATER SYSTEM SPECIAL REVENUE ACCOUNT; AUTHORIZING EMERGENCY GRANTS AND MATCHING GRANTS FOR PRELIMINARY ENGINEERING STUDIES; ELIMINATING ANNUAL DEBT SERVICE SUBSIDIES ON LOCAL INFRASTRUCTURE PROJECTS, LOANS FROM THE PROCEEDS OF COAL SEVERANCE TAX BONDS AT A SUBSIDIZED INTEREST RATE, AND DEFERRED LOANS FOR PRELIMINARY ENGINEERING STUDY COSTS; REQUIRING REPORTS TO THE GOVERNOR AND THE LEGISLATURE; APPROPRIATING MONEY TO THE DEPARTMENT OF COMMERCE FOR FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT INFRASTRUCTURE PROJECTS THROUGH THE TREASURE STATE ENDOWMENT PROGRAM; APPROPRIATING MONEY FROM THE TREASURE STATE ENDOWMENT REGIONAL WATER SYSTEM STATE SPECIAL REVENUE ACCOUNT TO THE DEPARTMENT OF NATURAL RESOURCES AND CONSERVATION FOR FINANCIAL ASSISTANCE TO REGIONAL WATER AUTHORITIES FOR REGIONAL WATER PROJECTS; AUTHORIZING GRANTS FROM THE TREASURE STATE ENDOWMENT STATE SPECIAL REVENUE ACCOUNT; PLACING CONDITIONS UPON GRANTS AND FUNDS; APPROPRIATING MONEY TO THE DEPARTMENT OF COMMERCE FOR EMERGENCY GRANTS; APPROPRIATING MONEY TO THE DEPARTMENT OF COMMERCE FOR

PRELIMINARY ENGINEERING GRANTS; TERMINATING A PRIOR TREASURE STATE ENDOWMENT GRANT; AMENDING SECTIONS 90-6-703, 90-6-710, AND 90-6-715, MCA, AND SECTION 1, CHAPTER 435, LAWS OF 2001; AND PROVIDING AN EFFECTIVE DATE", for the following reasons.

House Bill 11 is a bill that I support, however it has a serious technical error. House Bill 11, section 13 has a coordination instruction. Language in House Bill 11 is crucial to the operation of House Bill 748, general obligation bonds for water resource projects. House Bill 748 has been sent to the Governor for signature. In HB 11, section 13 the coordination language is incorrect. It strikes Section 9 that allows the payment of debt service. Without correction, bonds authorized in HB 748 cannot be paid with regional water funds, and thus will become an obligation of the general fund. My proposed amendment solves this serious technical error. My proposed amendment is attached to this letter.

In accordance with the power vested in me as Governor by the Constitution and the laws of the State of Montana, I hereby return with amendments House Bill 728, "AN ACT REVISING FUNDING FOR THE STATE VETERANS'

CEMETERY PROGRAM; PROVIDING FOR A STATE VETERANS' CEMETERY IN YELLOWSTONE COUNTY; PROVIDING A STATUTORY APPROPRIATION OF SPECIAL REVENUE; AMENDING SECTIONS 10-2-601, 10-2-603, AND 17-7-502, MCA; AND PROVIDING AN EFFECTIVE DATE," for the following reasons.

House Bill 728 provides for a veteran's cemetery in Yellowstone County. However, the federal VA veteran's grant is not yet secured. More important, the state veteran's cemetery special revenue account that has some limited funds for the operation, maintenance and administration of the funds will be depleted within five years. An early draft of the bill had \$100,000.00 in funding and that has been stricken.

My proposed amendment requires that the bill is contingent on funding. My proposed amendment is attached to this letter.

Dear President Tester and Speaker Matthews:

In accordance with the power vested in me as Governor by the Constitution and the laws of the State of Montana, I hereby return with amendments Senate Bill 428, "AN ACT PROVIDING FOR A STATEWIDE 2-1-1 TELEPHONE NUMBER FOR ACCESS AND REFERRAL TO COMMUNITY DISASTER, EMERGENCY, SAFETY, HEALTH, AND HUMAN SERVICES INFORMATION; PROVIDING FOR A MONTANA 2-1-1 COMMUNITY COALITION TO SERVE IN AN ADVISORY CAPACITY; PROVIDING THAT ANY AGENCY THAT SEEKS A NEW PUBLIC INFORMATION TELEPHONE LINE OR HOTLINE SHALL CONSULT WITH THE DEPARTMENT FOR USE OF THE 2-1-1 SYSTEM; PROVIDING FOR SERVICE PROVIDERS AND SCOPE OF SERVICE; PROVIDING FOR A STATE SPECIAL REVENUE ACCOUNT; PROVIDING FOR ELIGIBLE ACTIVITIES; REQUIRING BIENNIAL REPORTS TO THE LEGISLATURE; AND PROVIDING AN EFFECTIVE DATE," for the following reasons.

Senate Bill 428 establishes a 2-1-1 telephone number for public access to information and referral for safety, health, or human services and for information about access to services after a disaster or emergency. The bill directs the appointment of a twenty member coalition. Establishment of the 2-1-1 program will require the use of additional staff and impose additional expenses upon the Department of Public Health and Human Services ("DPHHS"). The fiscal note accompanying the bill explains that the new program would require an appropriation of \$63,000 over the next biennium.

However, section 11 of Senate Bill 428 directs that the new program be conducted with existing employees and within existing funding levels. This provision of Senate Bill 428 turns the bill into an unfunded mandate. Even the bill, in its original form, recognized the need for funding, as it established a special account in the state special revenue fund (section 8 of the bill). DPHHS simply cannot establish this program with existing staff and funding levels.

My proposed amendment eliminates the requirement that the program operate within existing staffing and funding levels and, instead, provides the program shall not operate without an appropriation for that purpose. My proposed amendment is attached to this letter.

Dear President Tester and Speaker Matthews:

In accordance with the powers vested in me as Governor by the Constitution and the laws of the State of Montana, I hereby return with amendments House Bill 769, "AN ACT CREATING THE RAIL SERVICE COMPETITION COUNCIL; ESTABLISHING THE MEMBERSHIP AND DUTIES OF THE COUNCIL; PROVIDING AN APPROPRIATION; AND PROVIDING AN EFFECTIVE DATE."

The amendments cover two issues:

restoring the Director of the Department of Revenue to the Rail Service Competition Council, and insuring that the private sector members bring experience related to transportation to the Rail Service Competition Council.

The sponsor of the bill, Rep. George Golie, agrees with the amendments.

Restoring the Director of the Department of Revenue to the Rail Service Competition Council

The Director of the Department of Revenue (DOR) was on the Council in the bill as introduced because the issue of taxes came to the fore as an issue of importance in the rail competition study conducted pursuant to SB 315 from the 2003 Session.

Because those taxation issues remain a critical element of rail competitiveness according to the study, I believe that it is imperative that the Director of DOR be on the Council.

The addition of the Director will not add to the costs of Council operations, nor make administration of the effort any more difficult.

Private Sector Members Bringing Transportation Experience to the Rail Service Competition Council The bill calls for private members who are to represent transportation expertise related to farm commodities, trucking, minerals and wood products. The language I have added is to make sure that the persons need to have "substantial knowledge and experience related to transportation" as it affects each of those areas.

I respectfully request that the legislature agree to these amendments so that we may be able to construct the best possible membership for this important Rail Service Competition Council.
