He stated that funding for the new sculpture would be raised by the sale of medallions at eighty dollars a piece. Senator Grimes stated that seventy-five limited edition reproductions of the sculpture would be available for sale at a price of \$3,500 dollars.

Senator Laslovich stood and gave an update on the Tsunami relief fund for the Montana Legislature. He reported that the Senate had given \$762.40 thus far. He also stated that a communication would be sent to the House of Representatives to encourage the body to contribute as well.
