

## HOUSE BILL NO. 180

INTRODUCED BY G. HOLLENBAUGH

BY REQUEST OF THE DEPARTMENT OF JUSTICE

A BILL FOR AN ACT ENTITLED: "AN ACT GENERALLY REVISING LAWS GOVERNING DRIVER'S LICENSES, COMMERCIAL DRIVER'S LICENSES, AND IDENTIFICATION CARDS; CLARIFYING REQUIREMENTS FOR AN INSTRUCTION PERMIT AND REMOVING THE AUTHORITY OF THE DEPARTMENT OF JUSTICE TO ISSUE CERTAIN TEMPORARY PERMITS; REQUIRING PAYMENT OF A NONREFUNDABLE DRIVER'S LICENSE APPLICATION FEE; REQUIRING LICENSING TO BE COMPLETED WITHIN 1 YEAR OF PAYMENT OF THE FEES; REVISING WHAT A DRIVER'S LICENSE APPLICATION MUST INCLUDE; REMOVING A REQUIREMENT THAT THE DEPARTMENT OF JUSTICE REQUEST AN APPLICANT'S DRIVING RECORD FROM OTHER JURISDICTIONS; ELIMINATING THE OPTION OF USING A LICENSEE'S SOCIAL SECURITY NUMBER AS A DRIVER'S LICENSE DISTINGUISHING NUMBER; PROVIDING FOR A MOTORCYCLE-ONLY DRIVER'S LICENSE; REVISING FEES FOR REPLACEMENT LICENSES; REVISING THE DEFINITION OF "CONVICTION" FOR CERTAIN PURPOSES; INCLUDING PROVISIONS FOR TESTING COMMERCIAL MOTOR VEHICLE OPERATORS FOR THE PRESENCE OF DRUGS OR A COMBINATION OF DRUGS AND ALCOHOL; REQUIRING CERTAIN NOTIFICATION PROCEDURES AND DRIVING RECORD EXCHANGES UPON ACTIONS TAKEN AFFECTING COMMERCIAL DRIVER'S LICENSES; ALLOWING THE DEPARTMENT OF JUSTICE TO ADOPT RULES GOVERNING ISSUANCE OF IDENTIFICATION CARDS; ESTABLISHING FEES AND PROCEDURES FOR ISSUANCE OF IDENTIFICATION CARDS; AMENDING SECTIONS 61-1-101, 61-3-116, 61-5-106, 61-5-107, 61-5-111, 61-5-114, 61-5-119, 61-5-121, 61-5-126, 61-5-211, 61-5-213, 61-6-102, 61-8-801, 61-8-803, 61-8-806, 61-8-808, 61-8-812, 61-8-817, 61-11-101, 61-11-102, 61-12-501, 61-12-502, AND 61-12-504, MCA; REPEALING SECTION 61-12-503, MCA; AND PROVIDING AN EFFECTIVE DATE."

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

**Section 1.** Section 61-1-101, MCA, is amended to read:

**"61-1-101. Definitions.** As used in this title, unless the context indicates otherwise, the following definitions apply:

(1) (a) "Authorized agent" means a person who has executed a written agreement with the department

1 and is specifically authorized by the department to electronically access and update the department's motor  
2 vehicle titling, registration, or driver records, using an approved automated interface, for specific functions or  
3 purposes upon behalf of a third party.

4 (b) For purposes of this subsection (1), "person" means an individual, corporation, partnership, limited  
5 partnership, limited liability company, association, joint venture, state agency, local government unit, another state  
6 government, the United States, a political subdivision of this or another state, or any other legal or commercial  
7 entity.

8 (2) "Authorized agent agreement" means the written agreement executed between an authorized agent  
9 and the department that sets the technical and operational program standards, compliance criteria, payment  
10 options, and service expectations by which the authorized agent must operate in performing specific motor  
11 vehicle or driver-related record functions.

12 (3) "Bus" means a motor vehicle designed for carrying more than 10 passengers and used for the  
13 transportation of persons and any other motor vehicle, other than a taxicab, designed and used for the  
14 transportation of persons for compensation.

15 (4) (a) "Camper" means a structure designed to be mounted in the cargo area of a truck or attached to  
16 an incomplete vehicle for the purpose of providing shelter for persons. The term includes but is not limited to a  
17 cab-over, half cab-over, noncab-over, telescopic, and telescopic cab-over.

18 (b) The term does not include a truck canopy cover or topper.

19 (5) "Certificate of title" means the paper record issued by the department or by the appropriate agency  
20 of another jurisdiction that establishes a verifiable record of ownership between an identified person or persons  
21 and the motor vehicle specifically described in the record and that provides notice of a perfected security interest  
22 in the motor vehicle.

23 (6) "Commercial driver's license" means:

24 (a) a driver's license issued under or granted by the laws of this state that authorizes a person to operate  
25 a class of commercial motor vehicle; and

26 (b) the privilege of a person to drive a commercial motor vehicle, whether or not the person holds a valid  
27 commercial driver's license.

28 (7) (a) "Commercial motor vehicle" means a motor vehicle or combination of motor vehicles used in  
29 commerce to transport passengers or property if the vehicle:

30 (i) has a gross combination weight rating or a gross combination weight of 26,001 pounds or more,

1   whichever is greater, inclusive of a towed unit with a gross vehicle weight rating of more than 10,000 pounds;  
2       (ii) has a gross vehicle weight rating or a gross vehicle weight of 26,001 pounds or more, whichever is  
3   greater;

4       (iii) is designed to transport at least 16 passengers, including the driver;

5       (iv) is a school bus; or

6       (v) is of any size and is used in the transportation of hazardous materials as defined in 61-8-801.

7       (b) The following vehicles are not commercial motor vehicles:

8       (i) an authorized emergency service vehicle:

9           (A) equipped with audible and visual signals as required under 61-9-401 and 61-9-402; and

10          (B) entitled to the exemptions granted under 61-8-107;

11       (ii) a vehicle:

12          (A) controlled and operated by a farmer, family member of the farmer, or person employed by the farmer;

13          (B) used to transport farm products, farm machinery, or farm supplies to or from the farm within Montana  
14   within 150 miles of the farm or, if there is a reciprocity agreement with a state adjoining Montana, within 150 miles  
15   of the farm, including any area within that perimeter that is in the adjoining state; and

16          (C) not used to transport goods for compensation or for hire; or

17       (iii) a vehicle operated for military purposes by active duty military personnel, a member of the military  
18   reserves, a member of the national guard on active duty, including personnel on full-time national guard duty,  
19   personnel in part-time national guard training, and national guard military technicians, or active duty United States  
20   coast guard personnel.

21       (c) For purposes of this subsection (7):

22       (i) "farmer" means a person who operates a farm or who is directly involved in the cultivation of land or  
23   crops or the raising of livestock owned by or under the direct control of that person;

24       (ii) "gross combination weight rating" means the value specified by the manufacturer as the loaded weight  
25   of a combination or articulated vehicle;

26       (iii) "gross vehicle weight rating" means the value specified by the manufacturer as the loaded weight of  
27   a single vehicle; and

28       (iv) "school bus" has the meaning provided in 49 CFR 383.5.

29       (8) "Commission" means the state transportation commission.

30       (9) "County where a vehicle is domiciled" means the county in which the vehicle owner permanently

1 resides or, if a vehicle is owned by a corporation or is leased or used for commercial purposes, the county in  
2 which the vehicle is permanently assigned or most frequently used, dispatched, or controlled.

3 (10) "Custom vehicle" means a motor vehicle other than a motorcycle that:

4 (a) (i) was manufactured with a model year after 1948 and that is at least 25 years old; or

5 (ii) was built to resemble a vehicle manufactured after 1948 and at least 25 years before the current  
6 calendar year, including a kit vehicle intended to resemble a vehicle manufactured after 1948 and that is at least  
7 25 years old; and

8 (b) has been altered from the manufacturer's original design or has a body constructed from nonoriginal  
9 materials.

10 (11) (a) "Dealer" means a person, firm, association, or corporation that, for commission or profit, engages  
11 in whole or in part in the business of buying, selling, exchanging, accepting on consignment, or acting as a broker,  
12 as defined in 61-4-131, of new or used motor vehicles, trailers, semitrailers, or pole trailers that are not registered  
13 in the name of the person, firm, association, or corporation and that are required to be licensed under chapter  
14 4 of this title.

15 (b) The term does not include the following:

16 (i) receivers, trustees, administrators, executors, guardians, or other persons appointed by or acting  
17 under a judgment or order of any court of competent jurisdiction;

18 (ii) employees of the persons included in subsection (11)(b)(i) when engaged in the specific performance  
19 of their duties as employees; or

20 (iii) public officers while performing or in the operation of their duties.

21 (12) "Declared weight" means the total unladen weight of a vehicle plus the weight of the maximum load  
22 to be carried on the vehicle as stated by the registrant in the application for registration.

23 (13) "Department" means the department of justice acting directly or through its duly authorized officers  
24 or agents.

25 (14) "Dolly or converter gear" means a device consisting of one or two axles with a fifth wheel and trailer  
26 tongue used to support the forward end of a semitrailer, converting a semitrailer into a trailer.

27 (15) "Driver" means a person who drives or is in actual physical control of a vehicle.

28 (16) "Driver's license" means a license or permit to operate a motor vehicle issued under or granted by  
29 the laws of this state, including:

30 (a) any ~~temporary license or~~ instruction permit;

1 (b) the privilege of any person to drive a motor vehicle, whether or not the person holds a valid license;

2 (c) any nonresident's driving privilege;

3 (d) a ~~motorcycle endorsement~~ motorcycle-only driver's license, as defined in 61-5-119; or

4 (e) a commercial driver's license.

5 (17) "Electric personal assistive mobility device" means a device that has two nontandem wheels, is  
6 self-balancing, and is designed to transport only one person with an electric propulsion system that limits the  
7 maximum speed of the device to 12 1/2 miles an hour.

8 (18) "For hire" means an action performed for remuneration of any kind, whether paid or promised, either  
9 directly or indirectly, or received or obtained through leasing, brokering, or buy-and-sell arrangements from which  
10 a remuneration is obtained or derived for transportation service.

11 (19) "Gross vehicle weight" means the weight of a vehicle without load plus the weight of any load on the  
12 vehicle.

13 (20) "Highway" or "public highway" means the entire width between the boundary lines of every publicly  
14 maintained way when any part of the publicly maintained way is open to the use of the public for purposes of  
15 vehicular travel.

16 (21) "Highway patrol officer" means a state officer authorized to direct or regulate traffic or to make  
17 arrests for violations of traffic regulations.

18 (22) "Implement of husbandry" means a vehicle that is designed for agricultural purposes and exclusively  
19 used by the owner of the vehicle in the conduct of the owner's agricultural operations.

20 (23) "Kit vehicle" is a motor vehicle assembled from a manufactured kit either as:

21 (a) a complete kit, consisting of a prefabricated body and chassis, to construct a new motor vehicle; or

22 (b) a kit with a prefabricated body to be mounted to an existing motor vehicle chassis and drivetrain,  
23 commonly referred to as a donor vehicle.

24 (24) "Light vehicle" means a motor vehicle commonly referred to as an automobile, van, sport utility  
25 vehicle, or truck having a manufacturer's rated capacity of 1 ton or less.

26 (25) "Manufactured home" has the meaning provided in 15-1-101.

27 (26) "Manufacturer" includes any person, firm, corporation, or association engaged in the manufacture  
28 of motor vehicles, trailers, or semitrailers as a regular business.

29 (27) "Manufacturer's certificate of origin" means the original paper record produced and issued by the  
30 manufacturer of a vehicle or, if in a medium authorized by the department, an electronic record created and

transmitted by the manufacturer of a vehicle to the manufacturer's agent or a licensed dealer. The record must establish the origin of the vehicle specifically described in the record and, upon assignment, transfers of ownership of the vehicle to the person or persons named in the certificate.

(28) "Mobile home" or "housetrailer" has the meaning provided in 15-1-101.

(29) (a) "Motorboat" means a vessel, including a personal watercraft or pontoon, propelled by any machinery, motor, or engine of any description, whether or not the machinery, motor, or engine is the principal source of propulsion. The term includes boats temporarily equipped with detachable motors or engines.

(b) The term does not include a vessel that has a valid marine document issued by the U.S. coast guard or any successor federal agency.

(30) (a) "Motor carrier" means a person or corporation or its lessees, trustees, or receivers appointed by a court that are operating motor vehicles upon a public highway in this state for the transportation of property for hire on a commercial basis.

(b) The term does not include motor carriers regulated under Title 69, chapter 12.

(31) (a) "Motorcycle" means a motor vehicle having not more than three wheels in contact with the ground and a saddle on which the operator sits or a platform on which the operator stands and a driving wheel in contact with the ground in addition to the wheels of the vehicle itself. A motorcycle may carry one or more attachments and a seat for the conveyance of a passenger.

(b) The term does not include a tractor, a bicycle as defined in 61-8-102, a motorized nonstandard vehicle, or a two- or three-wheeled all-terrain vehicle that is used exclusively on private property.

(32) (a) "Motor-driven cycle" means a motorcycle, including a motor scooter, with a motor that produces 5 horsepower or less.

(b) The term does not include a bicycle, as defined in 61-8-102, or a motorized nonstandard vehicle.

(33) "Motor home" means a motor vehicle:

(a) designed to provide temporary living quarters, built as an integral part of or permanently attached to a self-propelled motor vehicle chassis or van;

(b) containing permanently installed independent life support systems that meet the ANSI/A119.2 standard; and

(c) providing at least four of the following types of facilities:

(i) cooking, refrigeration, or icebox;

(ii) self-contained toilet;

1 (iii) heating or air-conditioning, or both;

2 (iv) potable water supply, including a faucet and sink; or

3 (v) separate 110-volt or 125-volt electrical power supply or a liquefied petroleum gas supply; or both.

4 (34) (a) "Motorized nonstandard vehicle" means a vehicle, upon or by which a person may be  
5 transported, that:

6 (i) is propelled by its own power, using an internal combustion engine or an electric motor;

7 (ii) has a wheelbase of less than 40 inches and a wheel diameter of less than 10 inches; and

8 (iii) does not display a manufacturer's certification in accordance with 49 CFR, part 567, or have a  
9 17-character vehicle identification number assigned by the manufacturer in accordance with 49 CFR, part 565.

10 (b) The term includes but is not limited to a motorized skateboard and a vehicle commonly known as a  
11 "pocket rocket".

12 (c) The term does not include an electric personal assistive mobility device or a motorized wheelchair  
13 or other low-powered, mechanically propelled vehicle designed specifically for use by a physically disabled  
14 person.

15 (35) (a) "Motor vehicle" means a vehicle propelled by its own power and designed or used to transport  
16 persons or property upon the highways of the state.

17 (b) The term does not include a bicycle as defined in 61-8-102 or a motorized wheelchair or other  
18 low-powered, mechanically propelled vehicle that is designed specifically for use by a physically disabled person  
19 and that is used as a means of mobility for that person.

20 (36) "New motor vehicle" means a motor vehicle, regardless of the mileage of the vehicle, the legal or  
21 equitable title to which has never been transferred by a manufacturer, distributor, or dealer to another person as  
22 the result of a retail sale.

23 (37) "Nonresident" means a person who is not a resident of this state.

24 (38) (a) "Not used for general transportation purposes" means the operation of a motor vehicle, registered  
25 as a collector's item, a custom vehicle, or a street rod, to or from a car club activity or event or an exhibit, show,  
26 cruise night, or parade, or other occasional transportation activity.

27 (b) The term does not include operation of a motor vehicle for routine or ordinary household  
28 maintenance, employment, education, or other similar purposes.

29 (39) (a) "Off-highway vehicle" means a self-propelled vehicle used for recreation or cross-country travel  
30 on public lands, trails, easements, lakes, rivers, or streams. The term includes but is not limited to motorcycles,

1 quadricycles, dune buggies, amphibious vehicles, air cushion vehicles, and any other means of land  
2 transportation deriving motive power from any source other than muscle or wind.

3 (b) The term does not include:

4 (i) vehicles designed primarily for travel on, over, or in the water;

5 (ii) snowmobiles; or

6 (iii) vehicles otherwise issued a certificate of title and registered under the laws of the state, unless the  
7 vehicle is used for off-road recreation on public lands.

8 (40) "Operator" means a person who is in actual physical control of a motor vehicle.

9 (41) "Owner" means a person who holds the legal title to a vehicle. If a vehicle is the subject of an  
10 agreement for the conditional sale of the vehicle with the right of purchase upon performance of the conditions  
11 stated in the agreement and with an immediate right of possession vested in the conditional vendee, or in the  
12 event a vehicle is subject to a lease, contract, or other legal arrangement vesting right of possession or control,  
13 for security or otherwise, or in the event a mortgagor of a vehicle is entitled to possession, then the owner is the  
14 person in whom is vested the right of possession or control.

15 (42) "Person" means an individual, corporation, partnership, association, firm, or other legal entity.

16 (43) "Personal watercraft" means a vessel that uses an outboard motor or an inboard engine powering  
17 a water jet pump as its primary source of propulsion and that is designed to be operated by a person sitting,  
18 standing, or kneeling on the vessel rather than by the conventional method of sitting or standing in the vessel.

19 (44) "Pole trailer" means a vehicle without power designed to be drawn by another vehicle and attached  
20 to the towing vehicle by means of a reach or pole or by being boomed or otherwise secured to the towing vehicle  
21 and ordinarily used for transporting long or irregularly shaped loads such as poles, pipes, or structural members  
22 capable generally of sustaining themselves as beams between the supporting connections.

23 (45) "Police officer" means an officer authorized to direct or regulate traffic or to make arrests for  
24 violations of traffic regulations.

25 (46) (a) "Quadricycle" means a four-wheeled motor vehicle, designed for on-road or off-road use, having  
26 a seat or saddle upon which the operator sits and a motor capable of producing not more than 50 horsepower.

27 (b) The term does not include golf carts.

28 (47) "Railroad" means a carrier of persons or property upon cars, other than streetcars, operated upon  
29 stationary rails.

30 (48) (a) "Railroad train" or "train" means a steam engine or electric or other motor, with or without cars

1 coupled to the engine, that is operated upon rails.

2 (b) The term does not include streetcars.

3 (49) "Recreational vehicle" includes self-propelled vehicles originally designed or permanently altered  
4 to provide temporary facilities for recreational, travel, or camping use.

5 (50) "Registration" or "register" means the act or process of creating an electronic record, maintained by  
6 the department, of the assignment of a license plate or a set of license plates to and the issuance of a registration  
7 decal for a specific vehicle, the ownership of which has been established or is presumed in department records.

8 (51) "Registration decal" means an adhesive sticker produced by the department and issued by the  
9 department, its authorized agent, or a county treasurer to the owner of a motor vehicle, trailer, semitrailer, or pole  
10 trailer as proof of payment of all fees imposed for the registration period indicated on the sticker as recorded by  
11 the department under 61-3-101.

12 (52) "Registration receipt" means a paper record that is produced and issued or, if authorized by the  
13 department, an electronic record that is transmitted by the department, its authorized agent, or a county treasurer  
14 to the owner of a vehicle that identifies a vehicle, based on information maintained in the electronic record of title  
15 for the vehicle, and that provides evidence of the payment of all fees required to be paid for the registration of the  
16 vehicle for the registration period indicated in the receipt.

17 (53) "Retail sale" means the sale of a new motor vehicle or used motor vehicle, a recreational vehicle,  
18 a trailer, a travel trailer, a motorcycle, a quadricycle, or special mobile equipment by a dealer to a person for  
19 purposes other than resale.

20 (54) "Revocation" means that the driver's license and privilege to drive a motor vehicle on the public  
21 highways are terminated and may not be renewed or restored. An application for a new license may be presented  
22 and acted upon by the department after the expiration of the period of the revocation.

23 (55) "Roadway" means that portion of a highway improved, designed, or ordinarily used for vehicular  
24 travel, exclusive of the berm or shoulder. In the event that a highway includes two or more separate roadways,  
25 the term refers to any roadway separately but not to all roadways collectively.

26 (56) (a) "Sailboat" means a vessel that uses a sail and wind as its primary source of propulsion.

27 (b) The term does not include a canoe or kayak propelled by wind.

28 (57) "Semitrailer" means a vehicle, with or without motive power, other than a pole trailer, designed for  
29 carrying property and for being drawn by a motor vehicle and constructed so that some part of its weight and that  
30 of its load rests upon or is carried by another vehicle.

(58) "Snowmobile" means a self-propelled vehicle of an overall width of 48 inches or less, excluding accessories, that is designed primarily for travel on snow or ice, that may be steered by skis or runners, and that is not otherwise registered or licensed under the laws of the state of Montana.

(59) "Special mobile equipment" means a vehicle not designed for the transportation of persons or property on the highways but incidentally operated or moved over the highways, including road construction or maintenance machinery, ditch-digging apparatus, and well-boring apparatus. The fact that equipment is permanently attached to a vehicle does not make the vehicle special mobile equipment. The enumeration in this subsection is partial and does not exclude other vehicles that are within the general terms of this subsection.

(60) (a) "Specially constructed vehicle" means a motor vehicle, including a motorcycle, that:

(i) was not originally constructed under a distinctive make, model, or type by a generally recognized manufacturer of motor vehicles;

(ii) has been structurally modified so that it does not have the same appearance as similar vehicles from a generally recognized manufacturer of motor vehicles;

(iii) has been constructed or assembled entirely from custom-built parts and materials not obtained from other vehicles;

(iv) has been constructed or assembled by using major component parts from one or more manufactured vehicles and that cannot be identified as a specific make or model; or

(v) has been constructed by the use of a kit that cannot be visually identified as a specific make or model.

(b) The term does not include a motor vehicle that has been repaired or restored to its original design by replacing parts.

(61) (a) "Sport utility vehicle" means a light vehicle designed to transport 10 or fewer persons that is constructed on a truck chassis or that has special features for occasional off-road use.

(b) The term does not include trucks having a manufacturer's rated capacity of 1 ton or less.

(62) (a) "Stop", when required, means complete cessation from movement.

(b) "Stop", "stopping", or "standing", when prohibited, means any stopping or standing of a vehicle, whether occupied or not, except when necessary to avoid conflict with other traffic or in compliance with the directions of a police officer, highway patrol officer, or traffic control sign or signal.

(63) "Street" means the entire width between the boundary lines of every publicly maintained way when any part of the publicly maintained way is open to the use of the public for purposes of vehicular travel.

(64) "Street rod" means a motor vehicle, other than a motorcycle, that:

1 (a) was manufactured prior to 1949 or was built to resemble a vehicle manufactured before 1949,  
2 including a kit vehicle intended to resemble a vehicle manufactured before 1949; and

3 (b) has been altered from the manufacturer's original design or has a body constructed from nonoriginal  
4 materials.

5 (65) "Suspension" means that the driver's license and privilege to drive a motor vehicle on the public  
6 highways are temporarily withdrawn, but only during the period of suspension.

7 (66) "Temporary registration permit" means a paper record:

8 (a) issued by the department, an authorized agent, a county treasurer, or a person, using a  
9 department-approved electronic interface after an electronic record has been transmitted to the department, that  
10 contains:

11 (i) required vehicle and owner information; and

12 (ii) the purpose for which the record was generated; and

13 (b) that, when placed in a durable license-plate style plastic pouch approved by the department and  
14 displayed as prescribed in 61-3-224, authorizes a person to operate the described motor vehicle, motorboat,  
15 sailboat that is 12 feet in length or longer, snowmobile, or off-highway vehicle for 40 days from the date the record  
16 is issued or until the vehicle is registered under Title 23 or this title, whichever first occurs.

17 (67) "Traffic" means pedestrians, ridden or herded animals, vehicles, streetcars, and other conveyances  
18 either singly or together while using any highways for purposes of travel.

19 (68) (a) "Trailer" means a vehicle, with or without motive power, other than a pole trailer, designed for  
20 carrying property and for being drawn by a motor vehicle and constructed so that no part of its weight rests upon  
21 the towing vehicle.

22 (b) The term does not include a mobile home or a manufactured home, as defined in 15-1-101.

23 (69) "Transaction summary receipt" means an electronic record produced and issued by the department,  
24 its authorized agent, or a county treasurer for which a paper receipt is issued. The record may be created by the  
25 department and transmitted to the owner of a vehicle, a secured party, or a lienholder. The record must contain  
26 a unique transaction record number and summarize and verify the electronic filing of the transaction described  
27 in the receipt on the electronic record of title maintained under 61-3-101.

28 (70) "Travel trailer" means a vehicle:

29 (a) that is 40 feet or less in length;

30 (b) that is of a size or weight that does not require special permits when towed by a motor vehicle;

1 (c) with gross trailer area of less than 320 square feet; and

2 (d) that is designed to provide temporary facilities for recreational, travel, or camping use and not used  
3 as a principal residence.
