House convened at 1:00 p.m. Mr. Speaker in the Chair. Invocation by Representative Windy Boy. Pledge of Allegiance to the Flag.

**SPECIAL ORDERS OF THE DAY**

Sergeant-at-Arms Clark escorted the Senate into the House Chambers.

Speaker Sales introduced President Cooney and yielded the chair to him.

Senator Williams moved that the body resolve itself into a joint session for the purpose of receiving the State of the Tribal Nations' address from the Honorable Carl Venne, Chairman of the Montana Crow Nation speaking on behalf of the Montana-Wyoming Tribal Leaders Council. Motion carried.

Senator Williams moved that President Cooney be authorized to appoint a committee of four to notify Chairman Venne that the House was in joint session and ready to receive his State of the Tribal Nations address. Motion carried.

President Cooney appointed Senator Pease, Senator Stapleton, Representative Small-Eastman and Representative Glaser and discharged them to escort the tribal leaders and Chairman Venne into the House Chambers.

President Cooney welcomed Dr. Barney Old Coyote, Darrin Old Coyote and Senate Chaplain Father Jerry Lowney.

The posting of the colors was presented by members of the Montana National Guard.

The women of the Crow Nation led the assembly in the Pledge of Allegiance.

On behalf of the members of House and Senate, President Cooney presented the gift of sacred herbs to Dr. Old Coyote.

The invocation was given by Dr. Barney Old Coyote of the Apsaalooke Nation.

Sergeant-at-Arms Scott admitted the tribal leaders, the Native American Caucus and the Lodge Grass Junior ROTC into the Chamber.

The committee escorted Chairman Venne of the Crow Nation and his brother Tex Hall into the Chamber.

Flag Song sung by the Apsaalooke Nation and Lodge Grass High School students.

After being presented to the members of both houses by President Cooney, Chairman Venne gave the State of the Tribal Nations address.

President Cooney thanked Chairman Venne for his address and presented him with sacred herbs. Darrin Old Coyote gave the benediction. The committee escorted Chairman Venne and guests from the Joint Session.

The Sergeants-at-Arms escorted the tribal leaders and guests from the Chamber.

**Insert:** "NEW SECTION. Section 6. Wolf predation mitigation and reimbursement trust fund. (1) The legislature shall provide for a fund, to be known as the wolf predation mitigation and reimbursement trust fund, to be funded as provided by law.

(2) The principal of the wolf predation mitigation and reimbursement trust fund shall forever remain inviolate in an amount of \$5 million unless appropriated by a vote of three-fourths of the members of each house of the legislature.

(3) The interest and income generated from the wolf predation mitigation and reimbursement trust fund must be deposited in the wolf predation mitigation and reimbursement state special revenue account provided for in [section 5]. The interest and income may be appropriated by a majority vote of each house of the legislature. Appropriations of the interest and income may be used only to fund the livestock loss reduction program and the livestock loss mitigation program as provided in [sections 2 and 3].

(4) (a) Until the principal of the fund reaches \$5 million, at the end of each biennium, any amount of interest and income from the trust fund that is not used for the livestock loss reduction program or the livestock loss mitigation program must be deposited in the trust fund as principal.

(b) After the principal of the trust fund reaches \$5 million, at the end of each biennium, any amount of interest and income that is not used for the livestock loss reduction program or the livestock loss mitigation program must be deposited in the general fund."
