4 A BILL FOR AN ACT ENTITLED: "AN ACT REQUIRING CERTAIN STATE AND LOCAL GOVERNMENT  
5 EMPLOYEES, BEGINNING JULY 1, 2010, TO BE MEMBERS OF THE DEFINED CONTRIBUTION  
6 RETIREMENT PLAN WITHIN THE PUBLIC EMPLOYEES' RETIREMENT SYSTEM; FREEZING THE  
7 MEMBERSHIP OF CERTAIN DEFINED BENEFIT RETIREMENT PLANS AS OF JUNE 30, 2010;  
8 ESTABLISHING DEFINED CONTRIBUTION RETIREMENT PLAN CONTRIBUTION REQUIREMENTS AND  
9 OPTIONS FOR CERTAIN PUBLIC EMPLOYEES; ESTABLISHING DEFINED CONTRIBUTION RETIREMENT  
10 PLAN CONTRIBUTIONS REQUIREMENTS FOR CERTAIN PUBLIC EMPLOYERS; PROVIDING FOR THE  
11 TRANSITION BY EMPLOYERS AND EMPLOYEES FROM CERTAIN DEFINED BENEFIT RETIREMENT PLANS  
12 TO THE DEFINED CONTRIBUTION RETIREMENT PLAN WITHIN THE PUBLIC EMPLOYEES' RETIREMENT  
13 SYSTEM; PROVIDING AN APPROPRIATION; REQUIRING THE PUBLIC EMPLOYEES' RETIREMENT BOARD  
14 TO SEEK A RULING OR OPINION; AMENDING SECTIONS 2-15-1009, 2-18-704, 17-7-502, 19-2-303, 19-2-405,  
15 19-2-407, 19-2-704, 19-3-315, 19-3-316, 19-3-401, 19-3-412, 19-3-2101, 19-3-2102, 19-3-2106, 19-3-2111,  
16 19-3-2112, 19-3-2113, 19-3-2114, 19-3-2115, 19-3-2116, 19-3-2117, 19-3-2121, 19-3-2141, 19-3-2143, 19-5-301,  
17 19-6-301, 19-7-301, 19-7-302, 19-8-301, 19-8-302, 19-9-301, 19-13-301, 19-20-101, 19-20-302, 20-9-501, AND  
18 20-15-404, MCA; AND PROVIDING AN EFFECTIVE DATE AND APPLICABILITY DATES."

19  
20 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

21  
22 NEW SECTION. **Section 1. Member contributions.** (1) Each member:  
23 (a) shall contribute 6.9% of the member's compensation; and  
24 (b) may contribute an additional amount of the member's compensation that will not, when combined  
25 with the amount required to be contributed under subsection (1)(a), exceed the maximum amount allowed under  
26 section 415(c) of the Internal Revenue Code, 26 U.S.C. 415(c).  
27 (2) The employer's payment of salary or wages less the contribution required in subsection (1)(a) is full  
28 and complete discharge and acquittance of all claims and demands for the service rendered by the member  
29 during the period covered by the payment, except the employee's claim to the benefits to which the employee  
30 may be entitled under the provisions of this chapter.

1 (3) Each employer, pursuant to section 414(h)(2) of the Internal Revenue Code, 26 U.S.C. 414(h)(2),  
2 shall pick up and pay the contributions that would be payable by the member under subsection (1)(a).

3 (4) The member's contributions picked up by the employer must be designated for all purposes of the  
4 plan as the member's contributions, except for the determination of a tax upon a distribution from the plan. The  
5 contributions must be allocated as provided in 19-3-2117(1).

6 (5) The member's contributions picked up by the employer must be paid from the same source that is  
7 used to pay compensation to the member and must be included in the member's compensation. The employer  
8 shall deduct from the member's compensation an amount equal to the amount of the member's contributions  
9 picked up by the employer under subsection (1)(a) and remit the total of the contributions to the board.

10  
11 **NEW SECTION. Section 2. Employer contributions.** (1) Each employer shall contribute to the plan  
12 6.9% of each member's compensation for each of the employer's employees who became plan members on or  
13 after [the applicability date of this section] except those properly excluded from membership.

14 (2) Employer contributions determined under subsection (1) must be allocated as provided in  
15 19-3-2117(2)(b).

16 (3) If in any fiscal year the total amount of all employers' contributions paid under subsection (1) exceeds  
17 the total amount of all employers' contributions allocated to members' accounts, the excess amount must be used  
18 by the board:

19 (a) to pay the administrative expenses of the plan; and

20 (b) if any money remains after paying administrative expenses, to pay down any unfunded actuarial  
21 liabilities determined under [section 6] in shares proportionate to the unfunded actuarial liabilities of each of the  
22 defined benefit plans by transferring the money to the appropriate fund.

23  
24 **NEW SECTION. Section 3. Plan transition contributions.** (1) Within 6 months after [the effective date  
25 of this section], the board shall consult with covered employers, members, and others about the most prudent  
26 and beneficial approach to paying off the unfunded actuarial liabilities determined under [section 6] resulting from  
27 the transition to the defined contribution plan as the only retirement plan available to future public employees,  
28 except those properly excluded from membership, and shall adopt schedules by which the unfunded actuarial  
29 liabilities of each defined benefit plan provided for in this title on [the effective date of this section] and determined  
30 under [section 6] must be paid. The duration of time within which the unfunded actuarial liabilities must be paid

1 in full under the schedules may not be more than 30 years.

2 (2) (a) Except as provided in subsection (2)(b), based on the schedules adopted under subsection (1),  
3 the board shall determine annually the amount to be paid as plan transition contributions by each employer during  
4 the ensuing year. The board shall calculate the percentage of compensation of each of the employers' employees  
5 needed to pay the amount determined from the schedules and shall notify each employer of the percentage  
6 amount before March 1 of each year.

7 (b) The amount to be paid by each employer for the fiscal year that begins [the applicability date of this  
8 section] is one-thirtieth of the amount of the unfunded actuarial liability reported in the actuarial valuation most  
9 recently completed prior to [the effective date of this section] multiplied by the ratio that the number of the  
10 employers' employees who are members of the defined benefit plan on [the effective date of this section] bears  
11 to the total number of employees who are members of that defined benefit plan on [the effective date of this  
12 section]. For the purposes of this subsection (2)(b), employees who are members of the defined contribution plan  
13 prior to [the effective date of this section] may not be included in either the numerator or denominator of the ratio.

14 (3) (a) Each employer shall budget for the employer's contributions determined under subsection (2) and  
15 shall pay the amount to the board at the times specified by the board.

16 (b) The amounts paid to the board under this subsection (3) must be deposited to the appropriate  
17 retirement trust funds for the single purpose of paying off the unfunded actuarial liabilities.

18 (4) Amounts paid by an employer under this section must be considered to be employer contributions  
19 for the purposes of the plan.

20  
21 **NEW SECTION. Section 4. Employers to include retirement contribution costs in budget.** (1) A  
22 covered state employer shall include in the employer's budget and request a legislative appropriation for an  
23 amount necessary to pay for the state's share of the costs of this part for the employer's employees so that the  
24 legislature may make definite appropriations for the costs incurred by each employer with employees who are  
25 members of the plan.

26 (2) A covered employer, except state employers included under subsection (1), shall budget for an  
27 amount necessary to pay for the employer's share of the costs of this part for the employer's employees so that  
28 the employer's governing body or budgeting authority may make definite appropriations or provision for the costs  
29 incurred by each employer with employees who are members of the plan.

30

1            **NEW SECTION. Section 5. Credit of contributions made after member becomes inactive.**

2 Contributions made on the basis of compensation earned by members after they are considered to be inactive  
3 members, as provided in 19-3-403(4), must be credited to the employer.

4  
5            **NEW SECTION. Section 6. Determination of unfunded actuarial liability -- allocations.** (1) For the  
6 purposes of this section, "defined benefit plan" means the defined benefit plans provided for in Title 19, chapters  
7 3, 5 through 9, 13, and 20, as applicable.

8            (2) Each year, the board shall determine for each defined benefit plan, as of the most recently completed  
9 actuarial valuation of the defined benefit plan, the share of the unfunded actuarial liability attributable to the  
10 individuals assumed by the actuary to be current and future members of the defined contribution plan whose  
11 membership in the defined contribution plan represents a portion of the unfunded actuarial liability of the defined  
12 benefit plan. For the purposes of this subsection, members who were members of the defined contribution plan  
13 before [the applicability date of this section] are not considered to be current and future members.

14            (3) Based on the amount determined under subsection (2), each year the board shall determine the  
15 amount of the unfunded liability that must be paid each fiscal year to maintain the actuarial soundness of the  
16 defined benefit plan.

17  
18            **NEW SECTION. Section 7. Implementation team -- state agency assistance.** The board shall create  
19 an implementation team to assist in the transition from the defined benefit plans to the defined contribution plan.  
20 Upon request of the board, other state agencies may provide technical and professional assistance to support  
21 the implementation of the transition to the defined contribution plan. The board may also request the assistance  
22 of other contracting employers and school districts and may provide compensation for personal services and  
23 other costs incurred by an agency, contracting employer, or school district in supporting the board pursuant to  
24 this section.

25  
26            **NEW SECTION. Section 8. Payment of local government and school administration expenses.**  
27 To the extent that a local government unit, including a school district or community college district, is required to  
28 incur administrative expenses to transition from an existing defined benefit plan to the defined contribution plan,  
29 the expenses must be paid by the public employees' retirement board from the appropriation provided in [section  
30 46].

1  
2           **NEW SECTION. Section 9. Loan authorized -- repayment -- statutory appropriation.** (1) If the  
3 administrative costs of implementing [this act] prior to July 1, 2011, exceed the appropriation provided in [section  
4 46], the board is authorized to take a loan from the department of administration. The department of  
5 administration shall provide for the loan from the investment fund type provided for in 17-2-102. The loan must  
6 be repaid with interest under terms and conditions determined by the department.

7           (2) Money borrowed by the board under this section is appropriated to the board to pay the administrative  
8 costs of implementing [this act] prior to July 1, 2011, including the costs incurred under [section 8].

9           (3) If the board has insufficient funds to repay the loan before July 1, 2011, the money for repayment of  
10 the loan is statutorily appropriated from the general fund, as provided in 17-7-502.

11  
12           **Section 10.** Section 2-15-1009, MCA, is amended to read:

13           **"2-15-1009. Public employees' retirement board -- terms -- allocation.** (1) There is a public  
14 employees' retirement board.

15           (2) The board consists of ~~seven~~ eight members appointed by the governor with the consent of the  
16 senate. The members are:

17           (a) ~~three~~ four public employees who are active members of a public retirement system. Not more than  
18 one of these members may be an employee of the same department and at least ~~one~~ two of these members  
19 must, no later than ~~July 1, 2003~~ [the applicability date of this section], be ~~a member~~ members of the defined  
20 contribution plan created pursuant to Title 19, chapter 3, part 21.

21           (b) one retired public employee who is a member of the public employees' retirement system;

22           (c) two members at large; and

23           (d) one member who has experience in investment management, counseling, or financial planning or  
24 who has other similar experience.

25           (3) The term of office for each member is 5 years.

26           (4) The board is allocated to the department for administrative purposes only as prescribed in 2-15-121.  
27 The board shall hire necessary employees as provided in 19-2-404.

28           (5) Members of the board must be compensated and receive travel expenses as provided for in  
29 2-15-124."

1           **Section 11.** Section 2-18-704, MCA, is amended to read:

2           **"2-18-704. Mandatory provisions.** (1) An insurance contract or plan issued under this part must contain  
3 provisions that permit:

4           (a) the member of a group who retires from active service under the appropriate retirement provisions  
5 of a defined benefit plan provided by law or, in the case of the defined contribution plan provided in Title 19,  
6 chapter 3, part 21, a member with at least 5 years of service and who is at least age 50 while in covered  
7 employment to remain a member of the group until the member becomes eligible for medicare under the federal  
8 Health Insurance for the Aged Act, 42 U.S.C. 1395, as amended, unless the member is a participant in another  
9 group plan with substantially the same or greater benefits at an equivalent cost or unless the member is employed  
10 and, by virtue of that employment, is eligible to participate in another group plan with substantially the same or  
11 greater benefits at an equivalent cost;

12           (b) the surviving spouse of a member to remain a member of the group as long as the spouse is eligible  
13 for retirement benefits accrued by the deceased member as provided by law unless the spouse is eligible for  
14 medicare under the federal Health Insurance for the Aged Act or unless the spouse has or is eligible for  
15 equivalent insurance coverage as provided in subsection (1)(a);

16           (c) the surviving children of a member to remain members of the group as long as they are eligible for  
17 retirement benefits accrued by the deceased member as provided by law unless they have equivalent coverage  
18 as provided in subsection (1)(a) or are eligible for insurance coverage by virtue of the employment of a surviving  
19 parent or legal guardian.

20           (2) An insurance contract or plan issued under this part must contain the provisions of subsection (1)  
21 for remaining a member of the group and also must permit:

22           (a) the spouse of a retired member the same rights as a surviving spouse under subsection (1)(b);

23           (b) the spouse of a retiring member to convert a group policy as provided in 33-22-508; and

24           (c) continued membership in the group by anyone eligible under the provisions of this section,  
25 notwithstanding the person's eligibility for medicare under the federal Health Insurance for the Aged Act.

26           (3) (a) A state insurance contract or plan must contain provisions that permit a legislator to remain a  
27 member of the state's group plan until the legislator becomes eligible for medicare under the federal Health  
28 Insurance for the Aged Act, 42 U.S.C. 1395, as amended, if the legislator:

29           (i) terminates service in the legislature and is a vested member of a state retirement system provided  
30 by law; and

1 (ii) notifies the department of administration in writing within 90 days of the end of the legislator's  
2 legislative term.

3 (b) A former legislator may not remain a member of the group plan under the provisions of subsection  
4 (3)(a) if the person:

5 (i) is a member of a plan with substantially the same or greater benefits at an equivalent cost; or

6 (ii) is employed and, by virtue of that employment, is eligible to participate in another group plan with  
7 substantially the same or greater benefits at an equivalent cost.

8 (c) A legislator who remains a member of the group under the provisions of subsection (3)(a) and  
9 subsequently terminates membership may not rejoin the group plan unless the person again serves as a  
10 legislator.

11 (4) (a) A state insurance contract or plan must contain provisions that permit continued membership in  
12 the state's group plan by a member of the judges' retirement system or by a district court judge, supreme court  
13 justice, or chief water judge, provided for in 3-7-221, who is a member of the defined contribution plan provided  
14 for in Title 19, chapter 3, part 21, who leaves judicial office but continues to be an inactive vested member of the  
15 judges' retirement system or the defined contribution plan as provided by 19-5-301 or 19-3-2111. The judge shall  
16 notify the department of administration in writing within 90 days of the end of the judge's judicial service of the  
17 judge's choice to continue membership in the group plan.

18 (b) A former judge may not remain a member of the group plan under the provisions of this subsection  
19 (4) if the person:

20 (i) is a member of a plan with substantially the same or greater benefits at an equivalent cost;

21 (ii) is employed and, by virtue of that employment, is eligible to participate in another group plan with  
22 substantially the same or greater benefits at an equivalent cost; or

23 (iii) becomes eligible for medicare under the federal Health Insurance for the Aged Act, 42 U.S.C. 1395,  
24 as amended.

25 (c) A judge who remains a member of the group under the provisions of this subsection (4) and  
26 subsequently terminates membership may not rejoin the group plan unless the person again serves in a position  
27 covered by the state's group plan.

28 (5) A person electing to remain a member of the group under subsection (1), (2), (3), or (4) shall pay the  
29 full premium for coverage and for that of the person's covered dependents.

30 (6) An insurance contract or plan issued under this part that provides for the dispensing of prescription

1 drugs by an out-of-state mail service pharmacy, as defined in 37-7-702:

2 (a) must permit any member of a group to obtain prescription drugs from a pharmacy located in Montana  
3 that is willing to match the price charged to the group or plan and to meet all terms and conditions, including the  
4 same professional requirements that are met by the mail service pharmacy for a drug, without financial penalty  
5 to the member; and

6 (b) may only be with an out-of-state mail service pharmacy that is registered with the board under Title  
7 37, chapter 7, part 7, and that is registered in this state as a foreign corporation.

8 (7) An insurance contract or plan issued under this part must include coverage for treatment of inborn  
9 errors of metabolism, as provided for in 33-22-131.

10 (8) An insurance contract or plan issued under this part must include substantially equivalent or greater  
11 coverage for outpatient self-management training and education for the treatment of diabetes and certain diabetic  
12 equipment and supplies as provided in 33-22-129.

13 (9) (a) An insurance contract or plan issued under this part that provides coverage for an individual in  
14 a member's family must provide coverage for well-child care for children from the moment of birth through 7 years  
15 of age. Benefits provided under this coverage are exempt from any deductible provision that may be in force in  
16 the contract or plan.

17 (b) Coverage for well-child care under subsection (9)(a) must include:

18 (i) a history, physical examination, developmental assessment, anticipatory guidance, and laboratory  
19 tests, according to the schedule of visits adopted under the early and periodic screening, diagnosis, and treatment  
20 services program provided for in 53-6-101; and

21 (ii) routine immunizations according to the schedule for immunization recommended by the immunization  
22 practice advisory committee of the U.S. department of health and human services.

23 (c) Minimum benefits may be limited to one visit payable to one provider for all of the services provided  
24 at each visit as provided for in this subsection (9).

25 (d) For purposes of this subsection (9):

26 (i) "developmental assessment" and "anticipatory guidance" mean the services described in the  
27 Guidelines for Health Supervision II, published by the American academy of pediatrics; and

28 (ii) "well-child care" means the services described in subsection (9)(b) and delivered by a physician or  
29 a health care professional supervised by a physician.

30 (10) (a) Except as provided in subsection (10)(b), upon renewal, an insurance contract or plan issued



1 under this part under which coverage of a dependent terminates at a specified age must, as provided in  
 2 33-22-152, continue to provide coverage for any unmarried dependent, as defined in 33-22-140(5)(b), until the  
 3 dependent reaches 25 years of age or marries, whichever occurs first. For insurance contracts or plans issued  
 4 under this part, the premium charged for the additional coverage of a dependent, as defined in 33-22-140(5)(b),  
 5 may be required to be paid by the insured and not by the employer.

6 (b) An insurance contract or plan issued under this part for the state employee group insurance program  
 7 and the university system group insurance program is not subject to subsection (10)(a).

8 (11) Prior to issuance of an insurance contract or plan under this part, written informational materials  
 9 describing the contract's or plan's cancer screening coverages must be provided to a prospective group or plan  
 10 member."

12 **Section 12.** Section 17-7-502, MCA, is amended to read:

13 **"17-7-502. Statutory appropriations -- definition -- requisites for validity.** (1) A statutory  
 14 appropriation is an appropriation made by permanent law that authorizes spending by a state agency without the  
 15 need for a biennial legislative appropriation or budget amendment.

16 (2) Except as provided in subsection (4), to be effective, a statutory appropriation must comply with both  
 17 of the following provisions:

18 (a) The law containing the statutory authority must be listed in subsection (3).

19 (b) The law or portion of the law making a statutory appropriation must specifically state that a statutory  
 20 appropriation is made as provided in this section.

21 (3) The following laws are the only laws containing statutory appropriations: 2-17-105; 5-11-120;  
 22 5-11-407; 5-13-403; 7-4-2502; 10-1-1202; 10-1-1303; 10-2-603; 10-3-203; 10-3-310; 10-3-312; 10-3-314;  
 23 10-4-301; 15-1-121; 15-1-218; 15-23-706; 15-31-906; 15-35-108; 15-36-332; 15-37-117; 15-39-110; 15-65-121;  
 24 15-70-101; 15-70-369; 15-70-601; 16-11-509; 17-3-106; 17-3-212; 17-3-222; 17-3-241; 17-6-101; 17-7-304;  
 25 18-11-112; [section 9]; 19-3-319; 19-6-404; 19-6-410; 19-9-702; 19-13-604; 19-17-301; 19-18-512; 19-19-305;

2 (4) There is a statutory appropriation to pay the principal, interest, premiums, and costs of issuing,  
3 paying, and securing all bonds, notes, or other obligations, as due, that have been authorized and issued  
4 pursuant to the laws of Montana. Agencies that have entered into agreements authorized by the laws of Montana  
5 to pay the state treasurer, for deposit in accordance with 17-2-101 through 17-2-107, as determined by the state  
6 treasurer, an amount sufficient to pay the principal and interest as due on the bonds or notes have statutory  
7 appropriation authority for the payments. (In subsection (3): pursuant to sec. 10, Ch. 360, L. 1999, the inclusion  
8 of 19-20-604 terminates when the amortization period for the teachers' retirement system's unfunded liability is  
9 10 years or less; pursuant to sec. 4, Ch. 497, L. 1999, the inclusion of 15-38-202 terminates July 1, 2014;  
10 pursuant to sec. 10(2), Ch. 10, Sp. L. May 2000, and secs. 3 and 6, Ch. 481, L. 2003, the inclusion of 15-35-108  
11 terminates June 30, 2010; pursuant to sec. 17, Ch. 593, L. 2005, the inclusion of 15-31-906 terminates January  
12 1, 2010; pursuant to sec. 73, Ch. 44, L. 2007, the inclusion of 19-6-410 terminates upon the death of the last  
13 recipient eligible under 19-6-709(2) for the supplemental benefit provided by 19-6-709; and pursuant to sec. 6,  
14 Ch. 2, Sp. L. September 2007, the inclusion of 76-13-150 terminates June 30, 2009.)"

16 **Section 13.** Section 19-2-303, MCA, is amended to read:

17 **"19-2-303. Definitions.** Unless the context requires otherwise, for each of the retirement systems  
18 subject to this chapter, the following definitions apply:

19 (1) "Accumulated contributions" means the sum of all the regular and any additional contributions made  
20 by a member in a defined benefit plan, together with the regular interest on the contributions.

21 (2) "Active member" means a member who is a paid employee of an employer, is making the required  
22 contributions, and is properly reported to the board for the most current reporting period.

23 (3) "Actuarial cost" means the amount determined by the board in a uniform and nondiscriminatory  
24 manner to represent the present value of the benefits to be derived from the additional service to be credited  
25 based on the most recent actuarial valuation for the system and the age, years until retirement, and current salary  
26 of the member.

27 (4) "Actuarial equivalent" means a benefit of equal value when computed upon the basis of the mortality  
28 table and interest rate assumptions adopted by the board.

29 (5) "Actuarial liabilities" means the excess of the present value of all benefits payable under a defined  
30 benefit retirement plan over the present value of future normal costs in that retirement plan.

1 (6) "Actuary" means the actuary retained by the board in accordance with 19-2-405.

2 (7) "Additional contributions" means contributions made by a member of a defined benefit plan to  
3 purchase various types of optional service credit as allowed by the applicable retirement plan.

4 (8) "Annuity" means:

5 (a) in the case of a defined benefit plan, equal and fixed payments for life that are the actuarial equivalent  
6 of a lump-sum payment under a retirement plan and as such are not benefits paid by a retirement plan and are  
7 not subject to periodic or one-time increases; or

8 (b) in the case of the defined contribution plan, a payment of a fixed sum of money at regular intervals.

9 (9) "Benefit" means:

10 (a) the service retirement benefit, early retirement benefit, or disability retirement or survivorship benefit  
11 payment provided by a defined benefit retirement plan; or

12 (b) a payment or distribution under the defined contribution retirement plan, including a disability payment  
13 under 19-3-2141, for the exclusive benefit of a plan member or the member's beneficiary or an annuity purchased  
14 under 19-3-2124.

15 (10) "Board" means the public employees' retirement board provided for in 2-15-1009.

8        **NEW SECTION. Section 48. Codification instruction.** [Sections 1 through 9] are intended to be  
9 codified as an integral part of Title 19, chapter 3, part 21, and the provisions of Title 19, chapter 3, part 21, apply  
10 to [sections 1 through 9].

11  
12        **NEW SECTION. Section 49. Saving clause.** [This act] does not affect rights and duties that matured,  
13 penalties that were incurred, or proceedings that were begun before [the applicability date of this act].

14  
15        **NEW SECTION. Section 50. Severability.** If a part of [this act] is invalid, all valid parts that are  
16 severable from the invalid part remain in effect. If a part of [this act] is invalid in one or more of its applications,  
17 the part remains in effect in all valid applications that are severable from the invalid applications.

18  
19        **NEW SECTION. Section 51. Contract of employment -- applicability.** Contract rights of employment  
20 are not applicable with regard to the right to participation in the defined contribution retirement plan of the public  
21 employees' retirement system as revised pursuant to [this act] until the provisions of [this act] are effective and  
22 applicable as provided in [this act]. Contract rights of employment are not applicable with regard to rights in the  
23 defined contribution retirement plan of the public employees' retirement system as revised pursuant to [this act]  
24 until the provisions of [this act] are effective and applicable as provided in [this act].

25  
26        **NEW SECTION. Section 52. Contingent voidness.** If the defined contribution retirement plan of the  
27 public employees' retirement system as revised pursuant to [this act] cannot be implemented because of an  
28 unfavorable determination or ruling from the internal revenue service, then [this act] is void.

29  
30        **NEW SECTION. Section 53. Effective date -- applicability.** (1) [This act] is effective July 1, 2009.

1 (2) (a) Except as provided in subsection (2)(b), [this act] applies to individuals hired on or after July 1,  
2 2009.

3 (b) [Sections 1 through 5, 10 through 14, and 16 through 45] apply to individuals hired on or after July  
4 1, 2010.
