"NEW SECTION. Section 2. Exceptions to report contents. (1) If a utility, a competitive electricity supplier, or an owner of an electrical generation facility operating in Montana required to file the report pursuant to [section 1] buys or sells a renewable energy credit in a market where the price of a renewable energy credit is not publicly disclosed, the utility, competitive electricity supplier, or owner of an electrical generation facility operating in Montana is not required to disclose the price.

(2) The utility, competitive electricity supplier, or owner of an electrical generation facility operating in Montana shall report the number of credits bought or sold and whether the energy and renewable energy credits were bought or sold together or separately as a bundled or unbundled product."
