January 21, 2011

WHEREAS, YMCAs throughout America have provided immeasurable benefits to people of all ages for 160 years and the Montana Alliance of YMCAs has served our communities since 1885 when the first Y was organized in Helena; and

WHEREAS, thousands of families in Montana benefit directly from the YMCA's extensive programming for all ages through their focus on youth development, healthy living, and social responsibility; and

WHEREAS, more than 300 Montana high school students learn about civic responsibility by participating in the annual YMCA Youth in Government program which includes the student legislature program; and

WHEREAS, no person is turned away for inability to pay, the Montana YMCAs provide more than \$2.3 million of annual support to our communities; and

WHEREAS, more than 3,640 individuals volunteer at the Y each year making the Montana Alliance of YMCAs one of the largest volunteer-driven organizations in Montana.
