10	<u>NEW SECTION.</u> Section 1. Unlawful operation of golf cart exception required equipment. (1)	
11	A person may not operate a golf cart on a public street or highway open to the public unless the operation is	
12	specifically authorized by ordinance or regulation passed by the local governing body of the county, city, or town	
13	for a public street or highway under its jurisdiction.	
14	(2) A PERSON OPERATING A GOLF CART UNDER THIS SECTION MUST HAVE A VALID DRIVER'S LICENSE.	
15	(2)(3) A golf cart may not be operated on a public street or highway when permitted by this section	
16	unless it is equipped with:	
17	(a) at least one and not more than two headlamps;	
18	(b) at least one taillamp;	
19	(c) at least one reflector;	
20	(d) stop lamps;	
21	(e) a horn; and	
22	(f) a mirror that reflects to the driver a view of the highway.

24	Section 2. Section 61-1-101, MCA, is amended to read:

5 (2) "Authorized agent agreement" means the written agreement executed between an authorized agent 6 and the department that sets the technical and operational program standards, compliance criteria, payment 7 options, and service expectations by which the authorized agent is required to operate in performing specific 8 motor vehicle or driver-related record functions.

9 (3) "Bus" means a motor vehicle designed for carrying more than 10 passengers and used for the 10 transportation of persons and any other motor vehicle, other than a taxicab, designed and used for the 11 transportation of persons for compensation.

12 (4) (a) "Business entity" means a corporation, association, partnership, limited liability partnership, limited 13 liability company, or other legal entity recognized under state law.

14 (b) The term does not include an individual.

15 (5) (a) "Camper" means a structure designed to be mounted in the cargo area of a truck or attached to 16 an incomplete vehicle for the purpose of providing shelter for persons. The term includes but is not limited to a 17 cab-over, half cab-over, noncab-over, telescopic, and telescopic cab-over.

18

(b) The term does not include a truck canopy cover or topper.

19 (6) "Certificate of title" means the paper record issued by the department or by the appropriate agency 20 of another jurisdiction that establishes a verifiable record of ownership between an identified person or persons 21 and the motor vehicle specifically described in the record and that provides notice of a perfected security interest 22 in the motor vehicle.

23 (7) "Commercial driver's license" means:

24 (a) a driver's license issued under or granted by the laws of this state that authorizes a person to operate

25 a class of commercial motor vehicle; and

26 (b) the privilege of a person to drive a commercial motor vehicle, whether or not the person holds a valid 27 commercial driver's license.

28 (8) (a) "Commercial motor vehicle" means a motor vehicle or combination of motor vehicles used in 29 commerce to transport passengers or property if the vehicle:

(i) has a gross combination weight rating or a gross combination weight of 26,001 pounds or more,

8 calendar year, including a kit vehicle intended to resemble a vehicle manufactured after 1948 and that is at least

(b) has been altered from the manufacturer's original design or has a body constructed from nonoriginal
materials.

12 (12) "Customer identification number" means:

(a) a driver's license or identification card number when the customer is an individual who has been
issued a driver's license or identification card by a state driver licensing authority;

(b) a federal employer or tax identification number when the customer is a business entity that has been
issued a federal employer or tax identification number;

(c) the identification number assigned by the secretary of state to a business entity authorized to do
business in this state under Title 35 if the customer is a business entity that does not have a federal employer
or tax identification number other than a social security number; or

(d) if the customer has not been issued one of the numbers described in subsections (12)(a) through
 (12)(c), a number assigned to the customer by the department when a transaction is initiated under this title.

(13) (a) "Dealer" means a person that, for commission or profit, engages in whole or in part in the
business of buying, selling, exchanging, or accepting on consignment new or used motor vehicles, trailers,
semitrailers, pole trailers, travel trailers, motorboats, sailboats, snowmobiles, off-highway vehicles, or special
mobile equipment that is not registered in the name of the person.

26 (b) The term does not include the following:

(i) receivers, trustees, administrators, executors, guardians, or other persons appointed by or acting
 under a judgment or order of any court of competent jurisdiction;

(ii) employees of the persons included in subsection (13)(b)(i) when engaged in the specific performance
 of their duties as employees; or

2	(14) "Declared weight" means the total unladen weight of a vehicle plus the weight of the maximum load
3	to be carried on the vehicle as stated by the registrant in the application for registration.
4	(15) "Department" means the department of justice acting directly or through its duly authorized officers
5	or agents.
6	(16) "Dolly or converter gear" means a device consisting of one or two axles with a fifth wheel and trailer
7	tongue used to support the forward end of a semitrailer, converting a semitrailer into a trailer.
8	(17) "Domiciled" means a place where:
9	(a) an individual establishes residence;
10	(b) a business entity maintains its principal place of business;
11	(c) the business entity's registered agent maintains an address; or
12	(d) a business entity most frequently uses, dispatches, or controls a motor vehicle, trailer, semitrailer,
13	or pole trailer that it owns or leases.
14	(18) "Driver" means a person who drives or is in actual physical control of a vehicle.
15	(19) "Driver's license" means a license or permit to operate a motor vehicle issued under or granted by
16	the laws of this state, including:
17	(a) any temporary license or instruction permit;
18	(b) the privilege of any person to drive a motor vehicle, whether or not the person holds a valid license;
19	(c) any nonresident's driving privilege;
20	(d) a motorcycle endorsement; or
21	(e) a commercial driver's license.
22	(20) "Electric personal assistive mobility device" means a device that has two nontandem wheels, is
23	self-balancing, and is designed to transport only one person with an electric propulsion system that limits the
24	maximum speed of the device to 12 1/2 miles an hour.
25	(21) "For hire" means an action performed for remuneration of any kind, whether paid or promised, either
26	directly or indirectly, or received or obtained through leasing, brokering, or buy-and-sell arrangements from which
27	a remuneration is obtained or derived for transportation service.
28	(22) "Golf cart" means a motor vehicle that is designed for use on a golf course to carry a person or
29	persons and golf equipment and that has an average speed of less than 15 miles per hour.
30	(22)(23) "Gross vehicle weight" means the weight of a vehicle without load plus the weight of any load

(23)(24) "Highway" or "public highway" means the entire width between the boundary lines of every
 publicly maintained way when any part of the publicly maintained way is open to the use of the public for purposes
 of vehicular travel.

5 (24)(25) "Highway patrol officer" means a state officer authorized to direct or regulate traffic or to make
 6 arrests for violations of traffic regulations.

7 (25)(26) "Implement of husbandry" means a vehicle that is designed for agricultural purposes and
8 exclusively used by the owner of the vehicle in the conduct of the owner's agricultural operations.

9 (26)(27) "Kit vehicle" is a motor vehicle assembled from a manufactured kit either as:

10 (a) a complete kit, consisting of a prefabricated body and chassis, to construct a new motor vehicle; or

(b) a kit with a prefabricated body to be mounted to an existing motor vehicle chassis and drivetrain,
 commonly referred to as a donor vehicle.

(27)(28) "Light vehicle" means a motor vehicle commonly referred to as an automobile, van, sport utility
 vehicle, or truck having a manufacturer's rated capacity of 1 ton or less.

15 (28)(29) "Manufactured home" has the meaning provided in 15-24-201.

(29)(30) "Manufacturer" includes any person engaged in the manufacture of motor vehicles, trailers,
 semitrailers, pole trailers, travel trailers, motorboats, sailboats, snowmobiles, or off-highway vehicles as a regular
 business.

19 (30)(31) "Manufacturer's certificate of origin" means the original paper record produced and issued by 20 the manufacturer of a vehicle or, if in a medium authorized by the department, an electronic record created and 21 transmitted by the manufacturer of a vehicle to the manufacturer's agent or a licensed dealer. The record must 22 establish the origin of the vehicle specifically described in the record and, upon assignment, transfers of 23 ownership of the vehicle to the person or persons named in the certificate.

(31)(32) (a) "Medium-speed electric vehicle" is a motor vehicle, upon or by which a person may be
 transported, that:

26 (i) has a maximum speed of 45 miles an hour as certified by the manufacturer;

(ii) is propelled by its own power, using an electric motor or other device that transforms stored electrical
energy into the motion of the vehicle;

(iii) stores electricity in batteries, ultracapacitors, or similar devices, which are charged from the power
 grid or from renewable electrical energy sources;

(v) has a wheelbase of 40 inches or greater and a wheel diameter of 10 inches or greater;
(vi) exhibits a manufacturer's compliance with 49 CFR, part 565, or displays a 17-character vehicle
identification number as provided in 49 CFR, part 565;
(vii) bears a sticker, affixed by the manufacturer or dealer, on the left side of the rear window that
indicates the vehicle's maximum speed rating; and

(iv) is fully enclosed and includes at least one door for entry;

(viii) as certified by the manufacturer, is equipped as provided in 61-9-432.

8 (b) A medium-speed electric vehicle must be treated as a light vehicle for purposes of titling and 9 registration under Title 61, chapter 3.

10 (c) A medium-speed electric vehicle may not have a gross vehicle weight in excess of 5,000 pounds.

11 (32)(33) "Mobile home" or "housetrailer" has the meaning provided in 15-24-201.

12 (33)(34) "Montana resident" means:

13 (a) an individual who resides in Montana as determined under 1-1-215;

(b) for the purposes of chapter 3, a business entity that maintains a principal place of business or a
 registered agent in this state.

(34)(35) (a) "Motorboat" means a vessel, including a personal watercraft or pontoon, propelled by any
 machinery, motor, or engine of any description, whether or not the machinery, motor, or engine is the principal
 source of propulsion. The term includes boats temporarily equipped with detachable motors or engines.

(b) The term does not include a vessel that has a valid marine document issued by the U.S. coast guardor any successor federal agency.

(35)(36) (a) "Motor carrier" means a person or corporation or its lessees, trustees, or receivers appointed
 by a court that are operating motor vehicles upon a public highway in this state for the transportation of property
 for hire on a commercial basis.

24

(b) The term does not include motor carriers regulated under Title 69, chapter 12.

(36)(37) (a) "Motorcycle" means a motor vehicle that has a seat or saddle for the use of the operator and
 that is designated to travel on not more than three wheels in contact with the ground. A motorcycle may carry one
 or more attachments and a seat for the conveyance of a passenger.

(b) The term does not include a tractor, a bicycle as defined in 61-8-102, a motorized nonstandard
vehicle, or a two- or three-wheeled all-terrain vehicle that is used exclusively on private property.

30 (37)(38) (a) "Motor-driven cycle" means a motorcycle, including a motor scooter, with a motor that

3 (41)(42) "New motor vehicle" means a motor vehicle, regardless of the mileage of the vehicle, the legal
4 or equitable title to which has never been transferred by a manufacturer, distributor, or dealer to another person
5 as the result of a retail sale.

(42)(43) "Nonresident" means a person who is not a Montana resident.

7 (43)(44) (a) "Not used for general transportation purposes" means the operation of a motor vehicle,
 8 registered as a collector's item, a custom vehicle, a street rod, or a custom-built motorcycle to or from a car or
 9 motorcycle club activity or event or an exhibit, show, cruise night, or parade, or other occasional transportation
 10 activity.

(b) The term does not include operation of a motor vehicle for routine or ordinary household
 maintenance, employment, education, or other similar purposes.

(44)(45) (a) "Off-highway vehicle" means a self-propelled vehicle designed for recreation or cross-country
 travel on public lands, trails, easements, lakes, rivers, or streams. The term includes but is not limited to
 motorcycles, quadricycles, dune buggies, amphibious vehicles, air cushion vehicles, and any other means of land
 transportation deriving motive power from any source other than muscle or wind.

17 (b) The term does not include:

18 (i) vehicles designed primarily for travel on, over, or in the water;

19 (ii) snowmobiles; or

(iii) motor vehicles designed to transport persons or property upon the highways unless the vehicle is
used for off-road recreation on public lands.

22 (45)(46) "Operator" means a person who is in actual physical control of a motor vehicle.

23 (46)(47) "Owner" means a person who holds the legal title to a vehicle. If a vehicle is the subject of an 24 agreement for the conditional sale of the vehicle with the right of purchase upon performance of the conditions 25 stated in the agreement and with an immediate right of possession vested in the conditional vendee, or in the 26 event a vehicle is subject to a lease, contract, or other legal arrangement vesting right of possession or control, 27 for security or otherwise, or in the event a mortgagor of a vehicle is entitled to possession, then the owner is the 28 person in whom is vested the right of possession or control.

(47)(48) "Person" means an individual, corporation, partnership, association, firm, or other legal entity.
 (48)(49) "Personal watercraft" means a vessel that uses an outboard motor or an inboard engine



powering a water jet pump as its primary source of propulsion and that is designed to be operated by a person
 sitting, standing, or kneeling on the vessel rather than by the conventional method of sitting or standing in the
 vessel.

4 (49)(50) "Pole trailer" means a vehicle without power designed to be drawn by another vehicle and
5 attached to the towing vehicle by means of a reach or pole or by being boomed or otherwise secured to the
6 towing vehicle and ordinarily used for transporting long or irregularly shaped loads such as poles, pipes, or
7 structural members capable generally of sustaining themselves as beams between the supporting connections.

8 (50)(51) "Police officer" means an officer authorized to direct or regulate traffic or to make arrests for
 9 violations of traffic regulations.

(51)(52) (a) "Quadricycle" means a four-wheeled motor vehicle, designed for on-road or off-road use,
 having a seat or saddle upon which the operator sits and a motor capable of producing not more than 50
 horsepower.

13 (b) The term does not include golf carts.

(52)(53) "Railroad" means a carrier of persons or property upon cars, other than streetcars, operated
 upon stationary rails.

(53)(54) (a) "Railroad train" or "train" means a steam engine or electric or other motor, with or without cars
 coupled to the engine, that is operated upon rails.

18 (b) The term does not include streetcars.

19 (54)(55) "Recreational vehicle" includes a motor home, travel trailer, or camper.

(55)(56) "Registration" or "register" means the act or process of creating an electronic record, maintained
 by the department, of the assignment of a license plate or a set of license plates to and the issuance of a
 registration decal for a specific vehicle, the ownership of which has been established or is presumed in
 department records.

(56)(57) "Registration decal" means an adhesive sticker produced by the department and issued by the
 department, its authorized agent, or a county treasurer to the owner of a motor vehicle, trailer, semitrailer, pole
 trailer, motorboat, sailboat, personal watercraft, or snowmobile as proof of payment of all fees imposed for the
 registration period indicated on the sticker as recorded by the department under 61-3-101.

(57)(58) "Registration receipt" means a paper record that is produced and issued or, if authorized by the
 department, an electronic record that is transmitted by the department, its authorized agent, or a county treasurer
 to the owner of a vehicle that identifies a vehicle, based on information maintained in the electronic record of title

for the vehicle, and that provides evidence of the payment of all fees required to be paid for the registration of the
 vehicle for the registration period indicated in the receipt.

3 (58)(59) "Retail sale" means the sale of a motor vehicle, trailer, semitrailer, pole trailer, travel trailer,
4 motorboat, snowmobile, off-highway vehicle, or special mobile equipment by a dealer to a person for purposes
5 other than resale.

6 (59)(60) "Revocation" means the termination by action of the department of a person's driver's license,
7 privilege to drive a motor vehicle on the public highways, and privilege to apply for and be issued a driver's license
8 for a period of time designated by law, during which the license or privilege may not be renewed, restored, or
9 exercised. An application for a new license may be presented and acted upon by the department after the
10 expiration of the period of the revocation.

(60)(61) "Roadway" means that portion of a highway improved, designed, or ordinarily used for vehicular
 travel, exclusive of the berm or shoulder. In the event that a highway includes two or more separate roadways,
 the term refers to any roadway separately but not to all roadways collectively.

14 (61)(62) (a) "Sailboat" means a vessel that uses a sail and wind as its primary source of propulsion.

15 (b) The term does not include a canoe or kayak propelled by wind.

(62)(63) "School zone" means an area near a school beginning at the school's front door, encompassing
 the campus and school property, and including the streets directly adjacent to the school property and for as
 many blocks surrounding the school as determined by the local authority establishing a special speed limit under
 61-8-310(1)(d).

20 (63)(64) "Sell" means to transfer ownership from one person to another person or from a dealer to
 21 another person for consideration.

(64)(65) "Semitrailer" means a vehicle, with or without motive power, other than a pole trailer, designed
 for carrying property and for being drawn by a motor vehicle and constructed so that some part of its weight and
 that of its load rests upon or is carried by another vehicle.

(65)(66) "Snowmobile" means a self-propelled vehicle of an overall width of 48 inches or less, excluding
 accessories, that is designed primarily for travel on snow or ice, that may be steered by skis or runners, and that
 is not otherwise registered or licensed under the laws of the state of Montana.

(66)(67) "Special mobile equipment" means a vehicle not designed for the transportation of persons or
 property on the highways but incidentally operated or moved over the highways, including road construction or
 maintenance machinery, ditch-digging apparatus, and well-boring apparatus. The fact that equipment is

1 permanently attached to a vehicle does not make the vehicle special mobile equipment. (73)(74) "Suspension" means the temporary withdrawal by action of the department of a person's driver's

6 (a) issued by the department, an authorized agent, a county treasurer, or a person, using a 7 department-approved electronic interface after an electronic record has been transmitted to the department, that 8 contains:

 any narcotic drug or who is under the influence of any other drug to a degree that renders the person incapable
 of safely operating a vehicle within the incorporated limits of any city or town;
- (12) regulating or prohibiting a person who is under the influence of intoxicating liquor from operating or
 being in actual physical control of a vehicle within the incorporated limits of a city or town;
- (13) regulating or prohibiting the operation of a vehicle by a person in willful or wanton disregard for the
 safety of persons or property within the incorporated limits of a city or town;
- (14) enacting as ordinances any provisions of chapter 8 or 9 and any other law regulating traffic,
 pedestrians, vehicles, and operators of vehicles that are not in conflict with state law or federal regulations and
 enforcing the ordinances; and
- (15) regulating the operation of motorized nonstandard vehicles, as defined in 61-1-101, on sidewalks,
 streets, and highways; and
