11	NEW SECTION. Section 1. Liability of sports officials and persons who train them. (1) A sports	
12	official in an athletic contest, and a person who has educated, trained, or assigned the sports official for the	
13	purposes of officiating at the athletic contest, is not liable for injury or damage sustained by a person because	
14	of an alleged action or inaction of the official unless the injury or damage was sustained because of the gross	
15	negligence or the willful, wanton, or intentional action or inaction of the official in the athletic contest.	
16	(2) As used in this section, the following definitions apply:	
17	(a) "Athletic contest" means:	
18	(i) a game, set, match, round, or other competition or sporting event played by participants at any	
19	educational level, including grade school, junior high school, high school, junior college, or college, or at the	
20	semiprofessional or professional level; or	
21	(ii) a scrimmage, practice, training session, or drill undertaken in preparation for the contest described	
22	in subsection (2)(a)(i).	
23	(b) "Sports official" or "official" means an individual who:	
24	(i) serves as a designated umpire or referee and is a member of a local, state, regional, or national	
25	organization that educates, trains, or assigns individuals to act as umpires or referees;	
26	(ii) serves as a designated umpire or referee without compensation and is not a member of ar	
27	organization listed in subsection (2)(b)(i);	
28	(iii) serves as an official similar to those listed in subsection (2)(b)(i) or (2)(b)(ii) but under a different title
