2 INTRODUCED BY R. RIPLEY

3  
4 A BILL FOR AN ACT ENTITLED: "AN ACT REORGANIZING AND RECODIFYING FISH AND GAME CODE  
5 CRIMINAL STATUTES AND DEFINITIONS; CLARIFYING PENALTIES; AMENDING SECTIONS 45-6-101,

17  
18 WHEREAS, the 2007 Legislature passed House Joint Resolution No. 16, urging that revision of the  
19 criminal codes within Title 87 of the Montana Code Annotated be given priority; and

20 WHEREAS, House Joint Resolution No. 16 noted that practitioners, judges, and citizens find that the  
21 criminal codes intertwined within the fish and game laws in Title 87 are difficult to read, understand, and  
22 prosecute; and

23 WHEREAS, House Joint Resolution No. 16 directed that revision of the Title 87 criminal code should not  
24 include policy changes to current laws and should adhere to the intent of the legislatures that crafted the laws;  
25 and

26 WHEREAS, in 2008, the Director of Fish, Wildlife, and Parks appointed a Title 87 criminal code revision  
27 working group, consisting of Justices of the Peace, County Attorneys, an Assistant Attorney General, legal  
28 counsel and the enforcement administrator of the Department of Fish, Wildlife, and Parks, and legislative staff;  
29 and

30 WHEREAS, the working group met numerous times and spent countless hours crafting a revision that

1 makes the Title 87 criminal code more understandable without making substantive or policy changes to present  
2 law; and

3 WHEREAS, revision of the fish and game criminal statutes will benefit the hunting and fishing public,  
4 magistrates, and prosecutors by codifying crimes and penalties in a separate chapter of Montana law, rather than  
5 being intertwined throughout Title 87.

7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

8

9 NEW SECTION. **Section 1. Definitions.** Unless the context requires otherwise, in [sections 1 through  
10 80], the following definitions apply:

11 (1) "Alternative livestock" means a privately owned caribou, white-tailed deer, mule deer, elk, moose,  
12 antelope, mountain sheep, or mountain goat indigenous to the state of Montana, a privately owned reindeer, or  
13 any other cloven-hoofed ungulate as classified by the department. Black bear and mountain lion must be  
14 regulated pursuant to Title 87, chapter 4, part 8.

15 (2) "Alternative livestock ranch" means the enclosed land area upon which alternative livestock may be  
16 kept for purposes of obtaining, rearing in captivity, keeping, or selling alternative livestock or parts of alternative  
17 livestock, as authorized under Title 87, chapter 4, part 4.

18 (3) (a) "Bait" means any animal matter, vegetable matter, or natural or artificial scent placed in an area  
19 inhabited by wildlife for the purpose of attracting game animals or game birds.

20 (b) The term does not include:

21 (i) decoys, silhouettes, or other replicas of wildlife body forms;

22 (ii) scents used only to mask human odor; or

23 (iii) types of scents that are approved by the commission for attracting game animals or game birds.

24 (4) "Closed season" means the time during which game birds, fish, game animals, and fur-bearing  
25 animals may not be lawfully taken.

26 (5) "Cloven-hoofed ungulate" means an animal of the order Artiodactyla, except a member of the families  
27 Suidae, Camelidae, or Hippopotamidae. The term does not include domestic pigs, domestic cows, domestic yaks,  
28 domestic sheep, domestic goats that are not naturally occurring in the wild in their country of origin, or bison.

29 (6) "Field trial" means an examination to determine the ability of dogs to point, flush, or retrieve game  
30 birds.

1 (7) "Fishing" means to take fish or the act of a person possessing any instrument, article, or substance  
2 for the purpose of taking fish in any location that a fish might inhabit.

3 (8) (a) "Fur dealer" means a person engaging in, carrying on, or conducting wholly or in part the business  
4 of buying or selling, trading, or dealing within the state of Montana in the skins or pelts of fur-bearing animals or  
5 predatory animals.

6 (b) If a fur dealer resides in Montana or if the fur dealer's principal place of business is within the state  
7 of Montana, the fur dealer is considered a resident fur dealer. All other fur dealers are considered nonresident  
8 fur dealers.

9 (9) "Fur farm" means enclosed land upon which furbearers are kept for purposes of obtaining, rearing  
10 in captivity, keeping, and selling furbearers or parts of furbearers.

11 (10) (a) "Fur-bearing animal" or "furbearer" means marten or sable, otter, muskrat, fisher, mink, bobcat,  
12 lynx, wolverine, northern swift fox, and beaver.

13 (b) As used in Title 87, chapter 4, part 10, "furbearer" does not include fox or mink.

14 (11) "Game animal" means deer, elk, moose, antelope, caribou, mountain sheep, mountain goat,  
15 mountain lion, bear, and wild buffalo.

16 (12) "Game fish" means all species of the family Salmonidae (chars, trout, salmon, grayling, and  
17 whitefish); all species of the genus Stizostedion (sandpike or sauger and walleyed pike or yellowpike perch); all  
18 species of the genus Esox (northern pike, pickerel, and muskellunge); all species of the genus Micropterus  
19 (bass); all species of the genus Polyodon (paddlefish); all species of the family Acipenseridae (sturgeon); all  
20 species of the genus Lota (burbot or ling); the species *Perca flavescens* (yellow perch); all species of the genus  
21 *Pomoxis* (crappie); and the species *Ictalurus punctatus* (channel catfish).

22 (13) "Hunt" means to pursue, shoot, wound, kill, chase, lure, possess, or capture or the act of a person  
23 possessing a weapon, as defined in 45-2-101, or using a dog or a bird of prey for the purpose of shooting,  
24 wounding, killing, possessing, or capturing wildlife protected by the laws of this state in any location that wildlife  
25 may inhabit, whether or not the wildlife is then or subsequently taken. The term includes an attempt to take by  
26 any means, including but not limited to pursuing, shooting, wounding, killing, chasing, luring, possessing, or  
27 capturing.

28 (14) "Knowingly" has the meaning provided in 45-2-101.

29 (15) "Livestock" includes ostriches, rheas, and emus.

30 (16) "Migratory game bird" means waterfowl, including wild ducks, wild geese, brant, and swans; cranes,

1 including little brown and sandhill; rails, including coots; Wilson's snipes or jacksnipes; and mourning doves.

2 (17) "Negligently" has the meaning provided in 45-2-101.

3 (18) "Nongame wildlife" means any wild mammal, bird, amphibian, reptile, fish, mollusk, crustacean, or  
4 other animal not otherwise legally classified by statute or regulation of this state.

5 (19) "Open season" means the time during which game birds, fish, and game and fur-bearing animals  
6 may be lawfully taken.

7 (20) "Participating state" means any state that enacts legislation to become a member of the Interstate  
8 Wildlife Violator Compact.

9 (21) "Person" means an individual, association, partnership, and corporation.

10 (22) "Predatory animal" means coyote, weasel, skunk, and civet cat.

11 (23) "Purposely" has the meaning provided in 45-2-101.

12 (24) "Raptor" means all birds of the orders Falconiformes and Strigiformes, commonly called falcons,  
13 hawks, eagles, ospreys, and owls.

14 (25) "Resident" has the meaning provided in 87-2-102.

15 (26) "Roadside menagerie" means any place where one or more wild animals are kept in captivity for  
16 the evident purpose of exhibition or attracting trade, on or off the facility premises. It does not include the  
17 exhibition of any animal by an educational institution or by a traveling theatrical exhibition or circus based outside  
18 of Montana.

19 (27) "Sale" means a contract by which a person:

20 (a) transfers an interest in either game or fish for a price; or

21 (b) transfers, barter, or exchanges an interest either in game or fish for an article or thing of value.

22 (28) "Supplemental feed attractant" means any food, garbage, or other attractant for game animals. The  
23 term does not include growing plants or plants harvested for the feeding of livestock.

24 (29) "Taxidermist" means a person who conducts a business for the purpose of mounting, preserving,  
25 or preparing all or part of the dead bodies of any wildlife.

26 (30) "Trap" means to take or participate in the taking of any wildlife protected by state law by setting or  
27 placing any mechanical device, snare, deadfall, pit, or device intended to take wildlife or to remove wildlife from  
28 any of these devices.

29 (31) "Upland game birds" means sharptailed grouse, blue grouse, spruce (Franklin) grouse, prairie  
30 chicken, sage hen or sage grouse, ruffed grouse, ring-necked pheasant, Hungarian partridge, ptarmigan, wild

1 turkey, and chukar partridge.

2 (32) "Wild animal" means an animal that is wild by nature as distinguished from common domestic  
3 animals, whether the animal was bred or reared in captivity, and includes birds and reptiles.

4 (33) "Wild animal menagerie" means any place where one or more bears or large cats, including  
5 cougars, lions, tigers, jaguars, leopards, pumas, cheetahs, ocelots, and hybrids of those large cats, are kept in  
6 captivity for use other than public exhibition.

7 (34) "Wild buffalo" means buffalo or bison that have not been reduced to captivity.

8 (35) "Zoo" means any zoological garden chartered as a nonprofit corporation by the state or any facility  
9 participating in the American zoo and aquarium association accreditation program for the purpose of exhibiting  
10 wild animals for public viewing.

11  
12 **NEW SECTION. Section 2. Designation of violations.** A person who purposely, knowingly, or  
13 negligently violates a provision of this title or any other state law pertaining to fish and game is guilty of a  
14 misdemeanor unless a felony is expressly provided by law.

15  
16 **NEW SECTION. Section 3. Fish and game violation as inchoate offense.** Any violation of this title  
17 is an offense for purposes of the crimes of attempt, solicitation, and conspiracy set out in Title 45, chapter 4.

18  
19 **NEW SECTION. Section 4. Fish and game code not to supersede criminal code -- statute of**  
20 **limitations.** (1) The penalty provisions of this title are intended to supplement but not supersede the provisions  
21 of Title 45. Nothing in this title limits the prosecution of any conduct defined as an offense in Title 45.

22 (2) Unless otherwise provided, the general time limitations for prosecutions for violations of any offense  
23 under this title are those time limitations specified in 45-1-205.

24  
25 **NEW SECTION. Section 5. Penalties in addition to Title 37.** Notwithstanding the provision of this  
26 chapter, the penalties provided by this chapter are in addition to any penalties provided in Title 37, chapter 47.

27  
28 **NEW SECTION. Section 6. Lawful taking to protect livestock or person.** (1) [Sections 1 through 80]  
29 may not be construed to impose, by implication or otherwise, criminal liability for the taking of wildlife protected  
30 by this title if the wildlife is attacking, killing, or threatening to kill a person or livestock. However, for purposes of

1 protecting livestock, a person may not kill or attempt to kill a grizzly bear unless the grizzly bear is in the act of  
2 attacking or killing livestock.

3 (2) A person may kill or attempt to kill a wolf or mountain lion that is in the act of attacking or killing a  
4 domestic dog.

5 (3) A person who, under this section, takes wildlife protected by this title shall notify the department within  
6 72 hours and shall surrender or arrange to surrender the wildlife to the department.

7  
8 **NEW SECTION. Section 7. Violation of commission or department order or rule.** A person who  
9 purposely, knowingly, or negligently violates an order or rule of the commission or department shall be fined not  
10 less than \$50 or more than \$500. In addition, the person, upon conviction or forfeiture of bond or bail, may be  
11 subject to forfeiture of any current hunting, fishing, or trapping license issued by this state and the privilege to  
12 hunt, fish, or trap in this state or to use state lands, as defined in 77-1-101, for recreational purposes for a period  
13 of time set by the court.

14  
15 **NEW SECTION. Section 8. Unlawful possession, shipping, or transportation of game fish, bird,**  
16 **game animal, or fur-bearing animal.** (1) A person may not possess, ship, or transport all or part of any game  
17 fish, bird, game animal, or fur-bearing animal that was unlawfully killed, captured, or taken, whether killed,  
18 captured, or taken in Montana or outside of Montana.

19 (2) This section does not prohibit the possession, shipping, or transportation of:

20 (a) hides, heads, or mounts of lawfully killed, captured, or taken game fish, birds, game animals, or  
21 fur-bearing animals, except that the sale or purchase of a hide, head, or mount of a grizzly bear is prohibited,  
22 except as provided in [section 13];

23 (b) naturally shed antlers or the antlers with a skull or portion of a skull attached from a game animal that  
24 has died from natural causes and that has not been unlawfully killed, captured, or taken or accidentally killed;

25 (c) the bones of an elk, antelope, moose, or deer that has died from natural causes and that has not  
26 been unlawfully killed, captured, or taken or accidentally killed;

27 (d) paddlefish roe as caviar under the provisions of 87-4-601; or

28 (e) captive-reared migratory waterfowl.

29 (3) A person may not possess, ship, or transport live fish away from the body of water in which the fish  
30 were taken except:

- 1 (a) as provided in Title 87, chapter 4, part 6, or as specifically permitted by the laws of this state;
- 2 (b) fish species approved by the commission for use as live bait and subject to any restrictions imposed  
3 by the commission; or
- 4 (c) within the boundaries of the eastern Montana fishing district, as established by commission  
5 regulations.
- 6 (4) The possession of all or part of a dead game fish, bird, game animal, or fur-bearing animal is prima  
7 facie evidence that the person or persons in whose possession the fish, bird, or animal is found killed, captured,  
8 or took the fish, bird, or animal.
- 9 (5) The value of a game fish, bird, game animal, or fur-bearing animal that is unlawfully possessed,  
10 shipped, or transported must be determined from the schedules of restitution values in [sections 68 and 69]. The  
11 value of game fish, birds, game animals, or fur-bearing animals that are unlawfully possessed, shipped, or  
12 transported pursuant to a common scheme, as defined in 45-2-101, or as part of the same transaction, as defined  
13 in 46-1-202, may be aggregated in determining the value.
- 14 (6) The following penalties apply for a violation of this section:
- 15 (a) If a person is convicted or forfeits bond or bail after being charged with unlawful possession, shipping,  
16 or transportation of a game fish or bird and if the value of all or part of the game fish or bird or combination thereof  
17 does not exceed \$1,000, the person shall be fined not less than \$50 or more than \$1,000 or be imprisoned in the  
18 county detention center for not more than 6 months, or both. In addition, the person may be subject to forfeiture  
19 of any current hunting, fishing, or trapping license issued by this state and the privilege to hunt, fish, or trap in this  
20 state or to use state lands, as defined in 77-1-101, for recreational purposes for a period of time set by the court.
- 21 (b) If a person is convicted or forfeits bond or bail after being charged with unlawful possession or  
22 transportation of a mountain sheep, moose, wild buffalo, caribou, mountain goat, black bear, or grizzly bear or  
23 any part of these animals and if the value of all or part of the animal or combination thereof does not exceed  
24 \$1,000, the person shall be fined not less than \$500 or more than \$2,000 or be imprisoned in the county detention  
25 center for not more than 6 months, or both. In addition, the person shall forfeit any current hunting, fishing,  
26 recreational use, or trapping license issued by this state and the privilege to hunt, fish, or trap in this state for 30  
27 months from the date of conviction or forfeiture unless the court imposes a longer period.
- 28 (c) If a person is convicted or forfeits bond or bail after being charged with unlawful possession or  
29 transportation of a deer, antelope, elk, or mountain lion or any part of these animals and if the value of all or part  
30 of the animal or combination thereof does not exceed \$1,000, the person shall be fined not less than \$300 or

1 more than \$1,000 or be imprisoned in the county detention center for not more than 6 months, or both. In addition,  
2 the person shall forfeit any current hunting, fishing, or trapping license issued by this state and the privilege to  
3 hunt, fish, or trap in this state for 24 months from the date of conviction or forfeiture unless the court imposes a  
4 longer period.

5 (d) If a person is convicted or forfeits bond or bail after being charged with unlawful shipping of a  
6 mountain sheep, moose, wild buffalo, caribou, mountain goat, black bear, grizzly bear, deer, antelope, elk, or  
7 mountain lion or any part of these animals and if the value of all or part of the animal or combination thereof does  
8 not exceed \$1,000, the person shall be fined not less than \$50 or more than \$1,000 or be imprisoned in the  
9 county detention center for not more than 6 months, or both. In addition, the person may be subject to forfeiture  
10 of any current hunting, fishing, or trapping license issued by this state and the privilege to hunt, fish, or trap in this  
11 state or to use state lands, as defined in 77-1-101, for recreational purposes for a period of time set by the court.

12 (e) If a person is convicted or forfeits bond or bail after being charged with unlawful possession, shipping,  
13 or transportation of a fur-bearing animal or pelt of a fur-bearing animal and if the value of all or part of the animal  
14 or combination thereof does not exceed \$1,000, the person shall be fined not less than \$100 or more than \$1,000  
15 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person shall  
16 forfeit any current hunting, fishing, or trapping license issued by this state and the privilege to hunt, fish, or trap  
17 in this state for 24 months from the date of conviction or forfeiture unless the court imposes a longer period, and  
18 any pelts possessed unlawfully must be confiscated.

19 (f) If a person is convicted under this section or forfeits bond or bail after being charged with a violation  
20 of this section and if the value of all or part of the game fish, bird, game animal, or fur-bearing animal or  
21 combination thereof exceeds \$1,000, the person shall be fined not more than \$50,000 or be imprisoned in the  
22 state prison for a term not to exceed 5 years, or both. In addition, the person shall forfeit any current hunting,  
23 fishing, or trapping license or permit issued by this state and the privilege to hunt, fish, or trap in this state for not  
24 less than 3 years up to a revocation for life from the date of conviction.

25 (7) A person convicted of unlawful possession of more than double the legal bag limit may be subject to  
26 the additional penalties provided in [section 63].

27 (8) As used in this section:

28 (a) "lawfully killed, captured, or taken" means killed, captured, or taken in conformance with this title, the  
29 regulations adopted by the commission, and the rules adopted by the department under authority of this title; and

30 (b) "unlawfully killed, captured, or taken" means not lawfully killed, captured, or taken.



1 (9) A violation of this section may also result in an order to pay restitution pursuant to [sections 67  
2 through 69].

3  
4 **NEW SECTION. Section 9. Unlawful taking, killing, trapping, labeling, or packaging of fur-bearing**  
5 **animal or pelt.** (1) A person convicted of purposely, knowingly, or negligently taking, killing, trapping, labeling,  
6 or packaging a fur-bearing animal or the pelt of a fur-bearing animal in violation of any provision of this title shall  
7 be fined not less than \$100 or more than \$1,000 or be imprisoned in the county detention center for not more than  
8 6 months, or both. In addition, the person, upon conviction or forfeiture of bond or bail, shall forfeit any current  
9 hunting, fishing, or trapping license issued by this state and the privilege to hunt, fish, or trap in this state for 24  
10 months from the date of conviction or forfeiture unless the court imposes a longer period, and any pelts  
11 possessed unlawfully must be confiscated.

12 (2) A person convicted of unlawful taking of more than double the legal bag limit of a fur-bearing animal  
13 may be subject to the additional penalties provided in [sections 63 and 64].

14 (3) A violation of this section may also result in an order to pay restitution pursuant to [sections 67 and  
15 68].

16  
17 **NEW SECTION. Section 10. Hunting or fishing during closed season.** (1) A person may not hunt  
18 or attempt to hunt:

19 (a) any game animal or game bird or fish for or catch any fish during the closed season on any species  
20 of game animal, game bird, or fish; or

21 (b) an upland game bird until the commission provides an open season on that upland game bird. The  
22 open season on mourning doves is restricted to the open season on upland game birds.

23 (2) A person convicted of a violation of this section shall be fined not less than \$50 or more than \$1,000  
24 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person, upon  
25 conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping  
26 license issued by this state and the privilege to hunt, fish, or trap in this state or to use state lands, as defined in  
27 77-1-101, for recreational purposes for a period of time set by the court.

28 (3) A person convicted of hunting during a closed season may be subject to the additional penalties  
29 provided in [sections 63 and 64].

30

1            **NEW SECTION. Section 11. Waste of game animal, game bird, or game fish.** (1) Except as  
2 provided in subsection (3), a person responsible for the death of any game animal, game bird, or game fish  
3 suitable for food may not purposely or knowingly waste the game by:

4            (a) detaching or removing only the head, hide, antlers, tusks, or teeth or any or all of these parts from  
5 the carcass of a game animal;

6            (b) transporting, hanging, or storing the carcass in a manner that renders it unfit for human consumption;  
7 or

8            (c) abandoning the carcass of a game animal or any portion of the carcass suitable for food in the field.

9            (2) A person in possession of a game animal or game animal parts, a game bird, or a game fish suitable  
10 for food may not purposely or knowingly waste the game by:

11            (a) transporting, storing, or hanging the animal, bird, or fish in a manner that renders it unfit for human  
12 consumption; or

13            (b) disposing of or abandoning any portion of the animal, bird, or fish that is suitable for food.

14            (3) A person responsible for the death of a mountain lion or wolf, except as provided in [section 6], may  
15 not abandon the head or hide in the field.

16            (4) A person responsible for the death of a grizzly bear wastes the game if the person abandons the  
17 head or hide or any parts required by department or commission regulation for scientific purposes pursuant to  
18 87-3-110.

19            (5) For the purposes of this section, the meat of a grizzly bear or a black bear that is found to be infected  
20 with trichinosis is not considered to be suitable for food.

21            (6) A person convicted of a violation of this section may be fined not less than \$50 or more than \$1,000  
22 or be imprisoned in the county jail for a term not to exceed 6 months, or both. In addition, the person, upon  
23 conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping  
24 license issued by this state and the privilege to hunt, fish, or trap in this state for 24 months from the date of  
25 conviction or forfeiture unless the court imposes a longer period.

26            (7) A person convicted of waste of game by abandonment in the field may be subject to the additional  
27 penalties provided in [section 63].

28

29            **NEW SECTION. Section 12. Unlawful sale of game fish, bird, game animal, or fur-bearing animal.**

30 (1) A person may not purposely or knowingly sell, purchase, or exchange all or part of any game fish, bird, game

1 animal, or fur-bearing animal.

2 (2) The value of the game fish, bird, game animal, or fur-bearing animal must be determined from the  
3 schedules of restitution values set out in [sections 68 and 69]. The value of game fish, birds, game animals, or  
4 fur-bearing animals that are sold, purchased, or exchanged pursuant to a common scheme, as defined in  
5 45-2-101, or as part of the same transaction, as defined in 46-1-202, may be aggregated in determining the value.

6 (3) This section does not prohibit the:

7 (a) sale, purchase, or exchange of hides, heads, or mounts of game fish, birds, game animals, or  
8 fur-bearing animals that have been lawfully killed, captured, or taken, except that the sale or purchase of a hide,  
9 head, or mount of a grizzly bear is prohibited, except as provided in [section 13];

10 (b) sale, purchase, or exchange of naturally shed antlers or the antlers with a skull or portion of a skull  
11 attached from a game animal that has died from natural causes and that has not been unlawfully killed, captured,  
12 or taken or accidentally killed;

13 (c) sale, purchase, or exchange of the bones of an elk, antelope, moose, or deer that has died from  
14 natural causes and that has not been unlawfully killed, captured, or taken or accidentally killed;

15 (d) donation, sale, purchase, or exchange of paddlefish roe as caviar under the provisions of 87-4-601;

16 or

17 (e) sale, purchase, or exchange of captive-reared migratory waterfowl.

18 (4) If a person is convicted or forfeits bond or bail after being charged with a violation of this section and  
19 if the value of all or part of the game fish, bird, game animal, or fur-bearing animal or combination thereof does  
20 not exceed \$1,000, then the person shall be fined not less than \$50 or more than \$1,000 or be imprisoned in the  
21 county detention center for not more than 6 months, or both. In addition, the person may be subject to forfeiture  
22 of any current hunting, fishing, or trapping license or permit issued by this state and the privilege to hunt, fish, or  
23 trap in this state for a period set by the court.

24 (5) If a person is convicted or forfeits bond or bail after being charged with a violation of this section and  
25 if the value of all or part of the game fish, bird, game animal, or fur-bearing animal or combination thereof exceeds  
26 \$1,000, then the person shall be fined not more than \$50,000 or be imprisoned in the state prison for not more  
27 than 5 years, or both. In addition, the person shall forfeit any current hunting, fishing, or trapping license or permit  
28 issued by this state and the privilege to hunt, fish, or trap in this state for not less than 3 years up to a revocation  
29 for life from the date of conviction.

30 (6) As used in this section:

1 (a) "lawfully killed, captured, or taken" means killed, captured, or taken in conformance with this title, the  
2 regulations adopted by the commission, and the rules adopted by the department under authority of this title; and

3 (b) "unlawfully killed, captured, or taken" means not lawfully killed, captured, or taken.  
4

5 **NEW SECTION. Section 13. Unlawful sale of grizzly bear.** (1) A person in possession of a lawfully  
6 killed grizzly bear or a hide, head, or mount of a grizzly bear may not sell it if it has not been registered with the  
7 department pursuant to 87-3-110.

8 (2) A person convicted of a violation of this section shall be fined not less than \$500 or more than \$2,000  
9 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person, upon  
10 conviction or forfeiture of bond or bail, shall forfeit any current hunting, fishing, recreational use, or trapping  
11 license issued by this state and the privilege to hunt, fish, or trap in this state for 30 months from the date of  
12 conviction or forfeiture unless the court imposes a longer period.  
13

14 **NEW SECTION. Section 14. Unlawful use of aircraft or boat.** (1) Except as provided in 87-3-126, a  
15 person may not:

16 (a) kill, take, or shoot at any game bird, game animal, or fur-bearing animal from an aircraft, including a  
17 helicopter;

18 (b) use an aircraft or helicopter for the purpose of concentrating, pursuing, driving, rallying, or stirring up  
19 any game bird, migratory bird, game animal, or fur-bearing animal; or

20 (c) if in an aircraft, including a helicopter, spot or locate any game animal or fur-bearing animal and  
21 communicate the location of the game animal or fur-bearing animal to any person on the ground by means of any  
22 air-to-ground communication signal or other device as an aid to hunting or pursuing wildlife.

23 (2) Unless permitted by the department, a person may not use an aircraft, including a helicopter, for  
24 hunting purposes within the boundaries of a national forest except when persons or cargo are loaded and  
25 unloaded at federal aviation agency approved airports, aircraft landing fields, or heliports that have been  
26 established on private property or that have been established by any federal, state, county, or municipal  
27 governmental body. Hunting purposes include the transportation of hunters or wildlife and hunting equipment and  
28 supplies. The provisions of this subsection do not apply:

29 (a) during emergency situations;

30 (b) when search and rescue operations are being conducted; or

1 (c) for predator control as permitted by the department of livestock.

2 (3) A person may not use a powerboat, sailboat, or any boat under sail or any floating device towed by  
3 a powerboat, sailboat, or any boat under sail for the purpose of killing, capturing, taking, pursuing, concentrating,  
4 driving, or stirring up any upland game bird, game animal, or fur-bearing animal.

5 (4) The following penalties apply for a violation of this section:

6 (a) Unless otherwise provided in this subsection (4), a person convicted of a violation of this section shall  
7 be fined not less than \$50 or more than \$1,000 or be imprisoned in the county detention center for not more than  
8 6 months, or both. In addition, the person, upon conviction or forfeiture of bond or bail, may be subject to forfeiture  
9 of any current hunting, fishing, or trapping license issued by this state and the privilege to hunt, fish, or trap in this  
10 state or to use state lands, as defined in 77-1-101, for recreational purposes for a period of time set by the court.

11 (b) If a person is convicted or forfeits bond or bail after being charged with unlawful use of aircraft or boat  
12 to kill or take a mountain sheep, moose, wild buffalo, caribou, mountain goat, black bear, or grizzly bear, the  
13 person shall be fined not less than \$500 or more than \$2,000 or be imprisoned in the county detention center for  
14 not more than 6 months, or both. In addition, the person shall forfeit any current hunting, fishing, recreational use,  
15 or trapping license issued by this state and the privilege to hunt, fish, or trap in this state for 30 months from the  
16 date of conviction or forfeiture unless the court imposes a longer period.

17 (c) If a person is convicted or forfeits bond or bail after being charged with unlawful use of aircraft or boat  
18 to kill or take a deer, antelope, elk, or mountain lion, the person shall be fined not less than \$300 or more than  
19 \$1,000 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the  
20 person shall forfeit any current hunting, fishing, recreational use, or trapping license issued by this state and the  
21 privilege to hunt, fish, or trap in this state for 24 months from the date of conviction or forfeiture unless the court  
22 imposes a longer period.

23 (d) If a person is convicted or forfeits bond or bail after being charged with unlawful use of aircraft or boat  
24 to kill or take a fur-bearing animal, the person shall be fined not less than \$100 or more than \$1,000 or be  
25 imprisoned in the county detention center for not more than 6 months, or both. In addition, the person shall forfeit  
26 any current hunting, fishing, recreational use, or trapping license issued by this state and the privilege to hunt,  
27 fish, or trap in this state for 24 months from the date of conviction or forfeiture unless the court imposes a longer  
28 period, and any pelts possessed unlawfully must be confiscated.

29

30 NEW SECTION. **Section 15. Unlawful contest or prize.** (1)(a) Except as provided in subsections (1)(b)

1 and (1)(c), a person, firm, or club may not offer or give a prize, gift, or anything of value in connection with or as  
2 a bag limit prize for the taking, capturing, killing, or in any manner acquiring any game, fowl, or fur-bearing animal  
3 or any bird or animal protected by law.

4 (b) A prize may be awarded for any one game bird or fur-bearing animal on the basis of size, quality, or  
5 rarity.

6 (c) A person may conduct or sponsor a contest for which the monetary prize, certificate, or award does  
7 not exceed \$50 for a person who kills a game animal possessing the largest antlers or horns, carrying the  
8 greatest weight, or having the longest body or any similar contest based upon the size or weight of a game animal  
9 or part of a game animal. The monetary restriction provided in this subsection (1)(c) does not apply to recognition  
10 given by a nationally established and recognized Boone and Crockett trophy institute.

11 (2) A person convicted of a violation of this section shall be fined not less than \$50 or more than \$1,000  
12 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person, upon  
13 conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping  
14 license issued by this state and the privilege to hunt, fish, or trap in this state or to use state lands, as defined in  
15 77-1-101, for recreational purposes for a period of time set by the court.

16

17 **NEW SECTION. Section 16. Harassment.** (1) (a) A person may not:

18 (i) intentionally interfere with the lawful taking of a wild animal or fishing by another;

19 (ii) with intent to prevent or hinder its lawful taking or its capture, disturb a wild animal or engage in an  
20 activity or place in its way any object or substance that will tend to disturb or otherwise affect the behavior of a  
21 wild animal; or

22 (iii) disturb an individual engaged in the lawful taking of a wild animal or fishing with intent to prevent the  
23 taking of the animal or the capture of the fish.

24 (b) This subsection (1) does not:

25 (i) prohibit a landowner or lessee from taking reasonable measures to prevent imminent danger to  
26 domestic livestock and equipment; or

27 (ii) prohibit or curtail normal landowner operations or lawful uses of water.

28 (2) A person convicted of a violation of this section shall be fined not more than \$500 or be imprisoned  
29 for not more than 30 days, or both. A person convicted of a second or subsequent violation shall be fined not  
30 more than \$1,000 or be imprisoned for not more than 1 year, or both.

1 (3) A court of general jurisdiction may enjoin conduct in violation of this section upon petition by a person  
2 affected or who reasonably may be affected by that conduct and upon a showing that the conduct is threatened  
3 or that it has occurred on a particular premises in the past and that it is not unreasonable to expect that under  
4 similar circumstances it will be repeated.

5 (4) As used in this section:

6 (a) "fishing" means the lawful means of fishing as described in [section 45];

7 (b) "taking" means the pursuit, hunting, trapping, shooting, or killing of a wild animal on land upon which  
8 the affected person has the right or privilege to pursue, hunt, trap, shoot, or kill the wild animal; and

9 (c) "wild animal" means a game animal, migratory game bird, upland game bird, fur-bearing animal,  
10 predatory animal, or fish.

11

12 **NEW SECTION. Section 17. Unlawful supplemental feeding.** (1) A person may not provide  
13 supplemental feed attractants to game animals by:

14 (a) purposely or knowingly attracting any cloven-hoofed ungulates, bears, or mountain lions with  
15 supplemental feed attractants;

16 (b) after having received a previous warning, negligently failing to properly store supplemental feed  
17 attractants and allowing any cloven-hoofed ungulates, bears, or mountain lions access to the supplemental feed  
18 attractants; or

19 (c) purposely or knowingly providing supplemental feed attractants in a manner that results in an artificial  
20 concentration of game animals that may potentially contribute to the transmission of disease or that constitutes  
21 a threat to public safety.

22 (2) A person is not subject to civil or criminal liability under this section if the person is engaged in:

23 (a) the normal feeding of livestock;

24 (b) a normal agricultural practice;

25 (c) cultivation of a lawn or garden;

26 (d) the commercial processing of garbage; or

27 (e) recreational feeding of birds unless, after having received a previous warning by the department, the  
28 person continues to feed birds in a manner that attracts cloven-hoofed ungulates or bears and that may contribute  
29 to the transmission of disease or constitute a threat to public safety.

30 (3) This section does not apply to supplemental feeding activities conducted by the department for

1 disease control purposes.

2 (4) A person convicted of a violation of this section shall be fined not less than \$50 or more than \$1,000  
3 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person, upon  
4 conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping  
5 license issued by this state and the privilege to hunt, fish, or trap in this state or to use state lands, as defined in  
6 77-1-101, for recreational purposes for a period of time set by the court.

7  
8 **NEW SECTION. Section 18. Shooting at simulated wildlife.** (1) A person may not discharge a firearm  
9 or other hunting implement at a simulated wildlife decoy in violation of any state statute or commission rule  
10 regulating the hunting of the wildlife being simulated when the decoy is being used by a certified peace officer.

11 (2) A person convicted of a violation of this section is subject to the same penalty as prescribed for the  
12 state statute or commission rule violated during the attempted hunting of the actual wildlife being simulated. In  
13 addition, the person shall pay restitution of \$50 to the department for the repair of damages to simulated wildlife  
14 decoys.

15  
16 **NEW SECTION. Section 19. Checking station offenses.** (1) A person, upon the request of the  
17 director, the director's authorized representative, or any game warden, shall produce for inspection any current  
18 fish and game license that has been issued to the person and any game animals, birds, fish, or fur-bearing  
19 animals in the person's possession. Hunters or anglers entering or leaving areas for which checking stations have  
20 been established shall stop and report if a checking station is on the hunter's or angler's route of travel to or from  
21 the hunting or fishing area and personnel are on duty.

22 (2) A person convicted of a violation of this section shall be fined not less than \$50 or more than \$1,000  
23 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person, upon  
24 conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping  
25 license issued by this state and the privilege to hunt, fish, or trap in this state or to use state lands, as defined in  
26 77-1-101, for recreational purposes for a period of time set by the court.

27  
28 **NEW SECTION. Section 20. Unlawful relocation of fish.** (1) A person or firm may not:  
29 (a) place or cause to be placed caged live fish in any of the public waters of the state of Montana, except  
30 as provided by department regulation;



1 (b) without written department approval, move live or dead salmonid fish or eggs from one in-state  
2 location to another when the fish or eggs are known to be infected with fish pathogens specified by the  
3 department as posing a threat to fisheries;

4 (c) import live salmonid fish or eggs into Montana without meeting the requirements of 87-3-221; or

5 (d) discard, place, or allow uncertified salmonid fish, parts, or eggs that have been transported into  
6 Montana to enter into surface waters other than sewage or disposal systems pursuant to 87-3-222(2).

7 (2) A person convicted of a violation of this section shall be fined not less than \$50 or more than \$1,000  
8 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person, upon  
9 conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping  
10 license issued by this state and the privilege to hunt, fish, or trap in this state or to use state lands, as defined in  
11 77-1-101, for recreational purposes for a period of time set by the court.

12

13 **NEW SECTION. Section 21. Field trial offenses.** (1) A person may not conduct a field trial unless the  
14 person has a permit under 87-4-915.

15 (2) An applicant receiving a permit to conduct a field trial may not violate or authorize violation of any  
16 of the terms of the permit.

17 (3) A person convicted of a violation of this section shall be fined not less than \$50 or more than \$1,000  
18 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person, upon  
19 conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping  
20 license issued by this state and the privilege to hunt, fish, or trap in this state or to use state lands, as defined in  
21 77-1-101, for recreational purposes for a period of time set by the court.

22

23 **NEW SECTION. Section 22. Hunting, fishing, or trapping without license.** (1) Except as provided  
24 in subsection (2), a person may not:

25 (a) hunt or trap or attempt to hunt or trap any game animal, game bird, or fur-bearing animal or fish for  
26 any fish within this state or possess within this state any game animal, game bird, fur-bearing animal, game fish,  
27 or parts of those animals or birds except as provided by law or as provided by the department;

28 (b) hunt or trap or attempt to hunt or trap any game animal, game bird, or fur-bearing animal or fish for  
29 any fish, except at the places and during the periods and in the manner established by law or as prescribed by  
30 the department;

1 (c) hunt or trap or attempt to hunt or trap any game animal, game bird, or fur-bearing animal or fish for  
2 any fish within this state or possess, sell, purchase, ship, or reship any imported or other fur-bearing animal or  
3 parts of fur-bearing animals without first having obtained a proper and valid license or permit from the department  
4 to do so;

5 (d) trap or attempt to trap predatory animals or nongame wildlife without a license, as prescribed in  
6 87-2-603, if that person is not a resident; or

7 (e) hunt migratory game birds without first having obtained a valid migratory game bird license from the  
8 department if the person is 16 years of age or older.

9 (2) The provisions of this section do not require a person who accompanies a licensed disabled hunter,  
10 as authorized under 87-2-803(4), to be licensed in order to kill or attempt to kill a game animal that has been  
11 wounded by a disabled hunter when the disabled hunter is unable to pursue and kill the wounded game animal.  
12 However, the person must meet the qualifications for a license in the person's state of residence.

13 (3) A person convicted of a violation of this section shall be fined not less than \$50 or more than \$1,000  
14 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person, upon  
15 conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping  
16 license issued by this state and the privilege to hunt, fish, or trap in this state or to use state lands, as defined in  
17 77-1-101, for recreational purposes for a period of time set by the court.

18 (4) A person convicted of hunting without a license may be subject to the additional penalties provided  
19 in [sections 63 and 64].

20 (5) A violation of this section may also result in an order to pay restitution pursuant to [sections 67 through  
21 69].

22  
23 **NEW SECTION. Section 23. Unlawful procurement of license, permit, or tag.** (1) A person may not:

24 (a) subscribe to or make any materially false statement on an application or license. Any material false  
25 statement contained in an application renders the license issued pursuant to it void.

26 (b) purchase a hunting, fishing, or trapping license without first having obtained a wildlife conservation  
27 license pursuant to 87-2-201; or

28 (c) purposely or knowingly assist an unqualified applicant in obtaining a resident license.

29 (2) A license agent may not sell any hunting, fishing, or trapping license to:

30 (a) an applicant who fails to produce the required identification at the time of application for licensure

1 pursuant to 87-2-106(1) and 87-2-202(1); or

2 (b) a person who does not present the person's wildlife conservation license at the time of application  
3 for the licenses.

4 (3) A person convicted of a violation of this section shall be fined not less than \$50 or more than \$1,000  
5 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person, upon  
6 conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping  
7 license issued by this state and the privilege to hunt, fish, or trap in this state or to use state lands, as defined in  
8 77-1-101, for recreational purposes for a period of time set by the court.

9

10 **NEW SECTION. Section 24. Nonresident license or permit offenses.** (1) A person who is not a  
11 resident may not:

12 (a) apply for or purchase for a nonresident's use the following resident licenses and permits:

13 (i) wildlife conservation license;

14 (ii) hunting license or permit; or

15 (iii) fishing license or permit;

16 (b) affirm to or make a false statement to obtain a resident license.

17 (2) A person convicted of a violation of this section shall be fined not less than the greater of \$100 or  
18 twice the cost of the nonresident license that authorized the sought-after privilege or more than \$1,000 or  
19 be imprisoned in the county jail for not more than 6 months, or both. In addition, the person, upon conviction or  
20 forfeiture of bond or bail, shall forfeit any current hunting, fishing, or trapping license issued by this state and the  
21 privilege to hunt, fish, or trap in this state for not less than 18 months.

22

23 **NEW SECTION. Section 25. License, permit, or tag offenses.** (1) A person may not apply for,  
24 purchase, or possess more than one license, permit, or tag of any one class or more than one special license  
25 for any one species listed in 87-2-701. This provision does not apply to Class B-4 or Class B-5 licenses or to  
26 licenses issued under 87-2-104(2) for game management purposes. However, when more than one license,  
27 permit, or tag is authorized by the commission, a person may not apply for, purchase, or possess more licenses,  
28 permits, or tags than are authorized.

29 (2) The holder of a replacement license, permit, or tag may not make the replacement license, permit,  
30 or tag available for use by another person.

1 (3) Except as provided in [section 26(2)], a person to whom a license or permit has been issued may not  
2 fish, hunt for any game bird or game animal, or attempt to hunt for any fur-bearing animal in this state unless the  
3 person is carrying the required license or permit at the time.

4 (4) A person may not refuse to exhibit a license or permit and the identification used in purchasing a  
5 license or permit for inspection to a warden or other officer requesting to see it.

6 (5) A person may not at any time alter or change a license in any material manner or loan or transfer any  
7 license to another person. A person other than the person to whom a license is issued may not use the license.  
8 A person may not attach the person's license to a game animal killed by another person.

9 (6) A person convicted of a violation of this section shall be fined not less than \$50 or more than \$1,000  
10 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person, upon  
11 conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping  
12 license issued by this state and the privilege to hunt, fish, or trap in this state or to use state lands, as defined in  
13 77-1-101, for recreational purposes for a period of time set by the court.

14  
15 **NEW SECTION. Section 26. Unlawful possession of hunting or fishing license or permit.** (1)

16 Except as provided in subsection (2), a person commits the offense of unlawful possession of a hunting or fishing  
17 license or permit if the person knowingly carries or has physical control over a valid and unused:

18 (a) hunting license or permit issued to another person while in any location that the species to be hunted  
19 may inhabit;

20 (b) resident hunting license or permit or resident fishing license or permit issued to a nonresident; or

21 (c) hunting license or permit or fishing license or permit that was issued in violation of applicable law or  
22 rule.

23 (2) The prohibition in subsection (1) does not apply:

24 (a) to a person who is carrying or has physical control over a license or permit issued to that person's  
25 spouse or to any minor when the spouse or minor is hunting with that person; and

26 (b) when a properly obtained and validated license or permit is attached to a lawfully killed game animal.

27 (3) Except as provided in subsection (4), a person who violates this section shall be fined not less than  
28 \$50 or more than \$1,000 or be imprisoned in the county detention center for not more than 6 months, or both.  
29 In addition, the person, upon conviction or forfeiture of bond or bail, may be subject to forfeiture of any current  
30 hunting, fishing, or trapping license issued by this state and the privilege to hunt, fish, or trap in this state or to

1 use state lands, as defined in 77-1-101, for recreational purposes for a period of time set by the court.

2 (4) A person who violates this section while engaged in a commercial activity, such as taxidermy, meat  
3 processing, outfitting, or guiding by carrying or having physical control over three or more hunting licenses that  
4 are issued to another person or persons and that are used or intended to be used on game animals not taken  
5 by the person or persons to whom the licenses were issued or by knowingly carrying, having physical control of,  
6 or selling two or more licenses or permits that were issued in violation of applicable law or rule is guilty of a felony  
7 and upon conviction shall be fined not more than \$50,000 or be imprisoned in the state prison for not more than  
8 5 years, or both. In addition, the person shall forfeit any current hunting, fishing, or trapping license or permit  
9 issued by this state and lose the privilege to hunt, fish, or trap in this state for not less than 3 years up to a  
10 revocation for life from the date of conviction.

11  
12 **NEW SECTION. Section 27. Hunting, fishing, or trapping while privileges or licenses forfeited**  
13 **or suspended.** (1) A person may not hunt, fish, or trap while the person's license or privilege to hunt, fish, or trap  
14 in this state is forfeited for a violation of this title or any other law pertaining to fish and game in this state. A  
15 person convicted of a violation of this section may be fined not less than \$500 or more than \$2,000 and shall be  
16 imprisoned in the county detention center for not less than 5 days or more than 6 months.

17 (2) A person whose privilege to hunt, fish, or trap in this state has been suspended for a violation of fish  
18 and game law in a participating state, pursuant to 87-1-803, may not hunt, fish, or trap in this state while that  
19 privilege is suspended. A person convicted of a violation of this section shall be fined not less than \$500 or more  
20 than \$2,000 or be imprisoned in the county jail for not more than 60 days, or both.

21  
22 **NEW SECTION. Section 28. Unlawful procurement of license while privileges forfeited or**  
23 **suspended.** (1) A person whose privilege to hunt, fish, or trap in this state is forfeited for a conviction or forfeiture  
24 of bail or bond for a violation under [sections 1 through 80] in this state may not purchase, acquire, obtain,  
25 possess, or apply for a hunting, fishing, or trapping license or permit while that privilege is forfeited.

26 (2) A person whose privilege to hunt, fish, or trap in this state has been suspended for a violation of fish  
27 and game law in a participating state, pursuant to 87-1-803, may not apply for or purchase any license to hunt,  
28 fish, or trap in this state while that privilege is suspended.

29 (3) A person convicted of a violation of this section shall be fined not less than \$500 or more than \$2,000  
30 or be imprisoned in the county jail for not more than 60 days, or both.

1  
2           **NEW SECTION. Section 29. Failure to surrender license for violation in participating state.** A  
3 person whose privilege to hunt, fish, or trap in this state has been suspended for a violation of fish and game law  
4 in a participating state, pursuant to 87-1-803, and who refuses to surrender any current hunting, fishing, or  
5 trapping license as required shall be fined not less than \$500 or more than \$2,000 or be imprisoned in the county  
6 jail for not more than 60 days, or both.

7  
8           **NEW SECTION. Section 30. Offense of noncompliance in Montana.** A person who hunts, fishes,  
9 traps, purchases licenses, or refuses to surrender any current hunting, fishing, or trapping license in violation of  
10 [section 76] shall be fined not less than \$50 or more than \$1,000 or be imprisoned in the county detention center  
11 for not more than 6 months, or both. In addition, the person, upon conviction or forfeiture of bond or bail may be  
12 subject to forfeiture of any current hunting, fishing, or trapping license issued by this state and the privilege to  
13 hunt, fish, or trap in this state or to use state lands, as defined in 77-1-101, for recreational purposes for a period  
14 of time set by the court.

15  
16           **NEW SECTION. Section 31. Offense of noncompliance in participating state.** A person who hunts,  
17 fishes, or traps, who applies for or purchases licenses or permits, or who refuses to surrender any current  
18 hunting, fishing, or trapping license in violation of 87-1-804 shall be fined not less than \$500 or more than \$2,000  
19 or be imprisoned in the county jail for not more than 60 days, or both.

20  
21           **NEW SECTION. Section 32. Unlawful special application or entry.** A person convicted of unlawfully  
22 applying for or entering a drawing for any special license or permit in violation of [section 75] shall be fined not  
23 less than \$500 or more than \$2,000 or be imprisoned in the county detention center for not more than 60 days,  
24 or both.

25  
26           **NEW SECTION. Section 33. Unlawful use of equipment while hunting.** (1) A person may not:  
27           (a) hunt or attempt to hunt any game animal or game bird by the aid or with the use of any snare, except  
28 as allowed in 87-3-127 and 87-3-128, set gun, projected artificial light, trap, salt lick, or bait;  
29           (b) use any recorded or electrically amplified bird or animal calls or sounds or recorded or electrically  
30 amplified imitations of bird or animal calls or sounds to assist in the hunting, taking, killing, or capturing of wildlife

1 except predatory animals and those birds not protected by state or federal law;

2 (c) while hunting, take into a field or forest or have in the person's possession any device or mechanism  
3 devised to silence, muffle, or minimize the report of any firearm, whether the device or mechanism is operated  
4 from or attached to any firearm;

5 (d) while hunting, possess any electronic motion-tracking device or mechanism, as defined by  
6 commission rule, that is designed to track the motion of a game animal and relay information on the animal's  
7 movement to the hunter. A radio-tracking collar attached to a dog that is used by a hunter engaged in lawful  
8 hunting activities is not considered a motion-tracking device or mechanism for purposes of this subsection (1)(d).

9 (e) while hunting, use archery equipment that has been prohibited by rule of the commission;

10 (f) use a shotgun to hunt deer or elk except with weapon type and loads as specified by the department;

11 (g) use a rifle to hunt or shoot upland game birds unless the use of rifles is permitted by the department.

12 This does not prohibit the shooting of wild waterfowl from blinds over decoys with a shotgun only, not larger than  
13 a number 10 gauge, fired from the shoulder.

14 (h) use a rifle to hunt or shoot wild turkey during the spring wild turkey season.

15 (2) A person convicted of a violation of this section shall be fined not less than \$50 or more than \$1,000  
16 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person, upon  
17 conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping  
18 license issued by this state and the privilege to hunt, fish, or trap in this state or to use state lands, as defined in  
19 77-1-101, for recreational purposes for a period of time set by the court.

20 (3) A person convicted of hunting while using projected artificial light as described in subsection (1)(a)  
21 may be subject to the additional penalties provided in [sections 63 and 64].

22 (4) A violation of this section may also result in an order to pay restitution pursuant to [sections 67  
23 through 69].

24

25 **NEW SECTION. Section 34. Unlawful hunting within city or town.** (1) A person may not hunt or  
26 attempt to hunt any deer within the boundaries of any incorporated or unincorporated city or town of this state  
27 except as allowed under a plan developed by a city or town and approved by the department pursuant to  
28 7-3-1105, 7-3-1222, or 7-31-4110.

29 (2) A person convicted of a violation of this section shall be fined not less than \$50 or more than \$1,000  
30 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person, upon

1 conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping  
2 license issued by this state and the privilege to hunt, fish, or trap in this state or to use state lands, as defined in  
3 77-1-101, for recreational purposes for a period of time set by the court.

4 (3) A violation of this section may also result in an order to pay restitution pursuant to [sections 67  
5 through 69].

6  
7 **NEW SECTION. Section 35. Unlawful hunting from public highway.** (1) Except as provided in  
8 87-2-803(4), a person may not hunt or attempt to hunt any game animal or game bird on, from, or across any  
9 public highway or the shoulder, berm, or barrow pit right-of-way of any public highway, as defined in 61-1-101,  
10 in the state.

11 (2) A person convicted of a violation of this section shall be fined not less than \$50 or more than \$1,000  
12 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person, upon  
13 conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping  
14 license issued by this state and the privilege to hunt, fish, or trap in this state or to use state lands, as defined in  
15 77-1-101, for recreational purposes for a period of time set by the court.

16 (3) A violation of this section may also result in an order to pay restitution pursuant to [sections 67  
17 through 69].

18  
19 **NEW SECTION. Section 36. Unlawful use of dog while hunting.** (1) Except as provided in  
20 subsections (3) through (5), a person may not:

21 (a) chase any game animal or fur-bearing animal with a dog; or

22 (b) purposely, knowingly, or negligently permit a dog to chase, stalk, pursue, attack, or kill a hooved game  
23 animal. If the dog is not under the control of an adult at the time of the violation, the owner of the dog is personally  
24 responsible. A defense that the dog was allowed to run at large by another person is not allowable unless it is  
25 shown that at the time of the violation, the dog was running at large without the consent of the owner and that the  
26 owner took reasonable precautions to prevent the dog from running at large.

27 (2) Except as provided in subsection (3)(d), a peace officer, game warden, or other person authorized  
28 to enforce the Montana fish and game laws who witnesses a dog chasing, stalking, pursuing, attacking, or killing  
29 a hooved game animal may destroy that dog on public land or on private land at the request of the landowner  
30 without criminal or civil liability.



1 (3) A person may:

2 (a) take game birds during the appropriate open season with the aid of a dog;

3 (b) hunt mountain lions during the winter open season, as established by the commission, with the aid  
4 of a dog or dogs;

5 (c) hunt bobcats during the trapping season, as established by the commission, with the aid of a dog or  
6 dogs; and

7 (d) use trained or controlled dogs to chase or herd away game animals or fur-bearing animals to protect  
8 humans, lawns, gardens, livestock, or agricultural products, including growing crops and stored hay and grain.

9 The dog may not be destroyed pursuant to subsection (2).

10 (4) A resident who possesses a Class D-3 resident hound training license may pursue mountain lions  
11 and bobcats with a dog or dogs during a training season from December 2 of each year to April 14 of the following  
12 year.

13 (5) Any person or association organized for the protection of game may run field trials at any time upon  
14 obtaining written permission from the director.

15 (6) A person convicted of a violation of this section shall be fined not less than \$50 or more than \$1,000  
16 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person, upon  
17 conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping  
18 license issued by this state and the privilege to hunt, fish, or trap in this state or to use state lands, as defined in  
19 77-1-101, for recreational purposes for a period of time set by the court.

20 (7) A violation of this section may also result in an order to pay restitution pursuant to [sections 67  
21 through 69].

22

23 **NEW SECTION. Section 37. Unlawful use of vehicle while hunting.** (1) Except as provided in  
24 87-2-803(4), a person may not:

25 (a) hunt or attempt to hunt any game animal or game bird from any self-propelled or drawn vehicle; or

26 (b) use a self-propelled vehicle to intentionally concentrate, drive, rally, stir up, or harass wildlife, except  
27 predators of this state. This subsection (1)(b) does not apply to landowners and their authorized agents engaged  
28 in the immediate protection of that landowner's property.

29 (2) Except as provided in 87-2-803(4), a person may not, while hunting a game animal or bird:

30 (a) drive or attempt to drive, run or attempt to run, molest or attempt to molest, flush or attempt to flush,

1 or harass or attempt to harass a game animal or game bird with the use or aid of a motor-driven vehicle;

2 (b) use a motor-driven vehicle other than on an established road or trail unless the person has reduced  
3 a big game animal to possession and cannot easily retrieve the big game animal. In that case, a motor-driven  
4 vehicle may be used to retrieve the big game animal, except in areas where more restrictive regulations apply  
5 or where the landowner has not granted permission. After the retrieval, the motor-driven vehicle must be returned  
6 to an established road or trail by the shortest possible route. For purposes of safety and allowing normal travel,  
7 a motor-driven vehicle may be parked on the roadside or directly adjacent to a road or trail.

8 (c) drive through any retired cropland, brush area, slough area, timber area, open prairie, or unharvested  
9 or harvested cropland, except upon an established road or trail, unless written permission has been given by the  
10 landowner and is in possession of the hunter.

11 (3) The restrictions in subsection (2) on motor-driven vehicle use off an established road or trail apply  
12 only to hunting on state or private land and not to hunting on federal land unless the federal agency specifically  
13 requests or approves state enforcement.

14 (4) A person convicted of a violation of this section shall be fined not less than \$50 or more than \$1,000  
15 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person, upon  
16 conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping  
17 license issued by this state and the privilege to hunt, fish, or trap in this state or to use state lands, as defined in  
18 77-1-101, for recreational purposes for a period of time set by the court.

19 (5) A violation of this section may also result in an order to pay restitution pursuant to [sections 67  
20 through 69].

21  
22 **NEW SECTION. Section 38. Unlawful destruction of evidence of sex.** (1) A person who kills a big  
23 game animal in this state may not destroy evidence of the sex of the big game animal so as to make the  
24 determination of the sex of the big game animal uncertain.

25 (2) A person convicted of a violation of this section shall be fined not less than \$50 or more than \$1,000  
26 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person, upon  
27 conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping  
28 license issued by this state and the privilege to hunt, fish, or trap in this state or to use state lands, as defined in  
29 77-1-101, for recreational purposes for a period of time set by the court.

30

1            **NEW SECTION. Section 39. Migratory game bird offenses.** A person who violates any provision of  
2 87-3-403 related to migratory game birds shall be fined not less than \$50 or more than \$1,000 or be imprisoned  
3 in the county detention center for not more than 6 months, or both. In addition, the person, upon conviction or  
4 forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping license issued  
5 by this state and the privilege to hunt, fish, or trap in this state or to use state lands, as defined in 77-1-101, for  
6 recreational purposes for a period of time set by the court.

7  
8            **NEW SECTION. Section 40. Tagging of game animal offenses.** (1) Each license issued by the  
9 department authorizing the holder of the license to hunt game animals, whether issued to a resident or a  
10 nonresident, must provide any tags, coupons, or markers as the department prescribes. When a person kills a  
11 game animal under the license, the person shall immediately cut out from the tag, coupon, or other marker the  
12 date the animal was killed and attach the tag, coupon, or other marker to the animal, completely filled out with  
13 the name of the license holder, the license holder's address, and any other information requested on the tag,  
14 coupon, or other marker. The tag, coupon, or other marker must be kept attached to the carcass as long as any  
15 considerable portion of the carcass remains unconsumed. When a game animal has been lawfully killed and the  
16 proper tag, coupon, or other marker is attached to the game animal that was killed, the game animal becomes  
17 the property of the person who lawfully killed the animal and may be possessed, used, stored, donated to another  
18 or to a charity, or transported.

19            (2) A person who kills any game animal by authority of any license issued for the killing of the game  
20 animal may not fail or neglect to cut out the day and month of the kill or provide any other information that is  
21 required and attach the tag, coupon, or other marker provided with the license issued to the carcass of the game  
22 animal or portion of the game animal.

23            (3) A person may not fail to keep the tag, coupon, or other marker attached to the game animal or portion  
24 of the game animal while the animal is possessed by the person.

25            (4) A person may not tag a game animal with a tag restricted to a hunting district other than the hunting  
26 district where the game animal was killed.

27            (5) A person convicted of a violation of this section shall be fined not less than \$50 or more than \$1,000  
28 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person, upon  
29 conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping  
30 license issued by this state and the privilege to hunt, fish, or trap in this state or to use state lands, as defined in

1 77-1-101, for recreational purposes for a period of time set by the court.

2

3 **NEW SECTION. Section 41. Tagging of turkey offenses.** (1) A person who kills, captures, or  
4 possesses a wild turkey by authority of any turkey tag or permit may not:

5 (a) fail or neglect to attach the tag to the turkey;

6 (b) fail to validate the tag by not filling out or punch marking the tag as required; or

7 (c) fail to keep the tag attached while the turkey is possessed by the person.

8 (2) A person who takes or kills a turkey must immediately attach to the turkey's leg a valid tag in  
9 compliance with instructions on the tag.

10 (3) A person convicted of a violation of this section shall be fined not less than \$50 or more than \$1,000  
11 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person, upon  
12 conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping  
13 license issued by this state and the privilege to hunt, fish, or trap in this state or to use state lands, as defined in  
14 77-1-101, for recreational purposes for a period of time set by the court.

15

16 **NEW SECTION. Section 42. Hunting or killing over limit.** (1) A person may not attempt to kill, take,  
17 shoot, or capture or kill, take, hunt, shoot, or capture more than one game animal of any one species in any 1  
18 license year unless the killing of more than one game animal of that species has been authorized by regulations  
19 of the department.

20 (2) If a person is convicted or forfeits bond or bail after being charged with hunting or killing over the limit  
21 of:

22 (a) mountain sheep, moose, wild buffalo, caribou, mountain goat, black bear, or grizzly bear, the person  
23 shall be fined not less than \$500 or more than \$2,000 or be imprisoned in the county detention center for not  
24 more than 6 months, or both. In addition, the person shall forfeit any current hunting, fishing, recreational use,  
25 or trapping license issued by this state and the privilege to hunt, fish, or trap in this state for 30 months from the  
26 date of conviction or forfeiture unless the court imposes a longer period.

27 (b) deer, antelope, elk, or mountain lion, the person shall be fined not less than \$300 or more than \$1,000  
28 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person shall  
29 forfeit any current hunting, fishing, or trapping license issued by this state and the privilege to hunt, fish, or trap  
30 in this state for 24 months from the date of conviction or forfeiture unless the court imposes a longer period.

1 (c) fur-bearing animal, the person shall be fined not less than \$100 or more than \$1,000 or be imprisoned  
2 in the county detention center for not more than 6 months, or both. In addition, the person shall forfeit any current  
3 hunting, fishing, or trapping license issued by this state and the privilege to hunt, fish, or trap in this state for 24  
4 months from the date of conviction or forfeiture unless the court imposes a longer period, and any pelts  
5 possessed unlawfully must be confiscated.

6 (3) A person convicted of unlawful taking of more than double the legal bag limit as described in this  
7 section may be subject to the additional penalties provided in [sections 63 and 64].

8 (4) A violation of this section may also result in an order to pay restitution pursuant to [sections 67  
9 through 69].

10  
11 **NEW SECTION. Section 43. Failure to wear hunter orange while big game hunting.** (1) Except as  
12 provided in subsection (3), a person may not hunt any big game animals in this state or accompany any hunter  
13 as an outfitter or guide under any of the provisions of the laws of this state without wearing as exterior garments  
14 above the waist a total of not less than 400 square inches of hunter orange material visible at all times while  
15 hunting.

16 (2) As used in this section, "hunter orange" means a daylight fluorescent orange color.

17 (3) This section does not apply to a person hunting with a bow and arrow during the special archery  
18 season.

19 (4) The department shall make rules to implement this section.

20 (5) A person convicted of a violation of this section shall be punished by a fine of not less than \$10 or  
21 more than \$20.

22  
23 **NEW SECTION. Section 44. Failure to obtain landowner's permission for hunting.** (1) A resident  
24 or nonresident shall obtain permission of the landowner, the lessee, or their agents before taking or attempting  
25 to take nongame wildlife or predatory animals or hunting on private property.

26 (2) Except as provided in subsection (3), a person who violates this section shall, upon conviction for  
27 a first offense, be fined an amount not to exceed \$25.

28 (3) A person convicted of a violation of this section for hunting a big game animal on private property  
29 without obtaining permission of the landowner shall be fined not less than \$50 or more than \$1,000 or be  
30 imprisoned in the county detention center for not more than 6 months, or both. In addition, the person, upon

1 conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping  
2 license issued by this state and the privilege to hunt, fish, or trap in this state or to use state lands, as defined in  
3 77-1-101, for recreational purposes for a period of time set by the court.

4

5 **NEW SECTION. Section 45. Fishing offenses.** (1) Except when specifically authorized by law or by  
6 commission rule, a person may not:

7 (a) fish by any means other than by hook and single line or single rod, in hand or within immediate  
8 control. This does not prevent:

9 (i) fishing from a boat or the shore on a lake or reservoir by hook and two lines or two rods, in hand or  
10 within immediate control, in accordance with rules that the commission adopts;

11 (ii) the snagging of paddlefish, chinook salmon, and kokanee (sockeye salmon) when the commission  
12 declares an open season when paddlefish, chinook salmon, and kokanee (sockeye salmon) may be taken by  
13 snagging;

14 (iii) the taking of paddlefish, channel catfish, and nongame fish with longbow and arrow under rules and  
15 regulations that the commission adopts;

16 (iv) the use of landing net or gaff to land a game fish after the game fish has been hooked as specified  
17 in this subsection (1)(a);

18 (v) the taking of minnows other than game fish variety by the use or aid of a net not to exceed 12 feet  
19 in length and 4 feet in width in waters designated by the commission;

20 (vi) the taking of whitefish by nets or traps in the Kootenai River and in its tributary streams within 1 mile  
21 of the Kootenai River under the rules and regulations that the commission adopts;

22 (vii) the taking of any game fish through a hole in ice with an unattended line or rod as long as the angler  
23 is in the vicinity and within visual contact of the line or rod; or

24 (viii) the taking of salmon and lake trout in Fort Peck reservoir by spear or gig from December through  
25 March under rules and regulations that the commission adopts.

26 (b) unlawfully use any fishing rod and line, fishing lines, spear, gig, or barbed fork;

27 (c) take or catch fish using fishtraps, grabhooks, spears, gigs, or other similar means for catching fish;

28 (d) use any gun or trap or other device to entrap, catch, capture, or take or to attempt to entrap, catch,  
29 capture, or take any game fish;

30 (e) have in the person's possession or under the person's control a seine, net, or other similar device

1 for capturing fish. A seine or net found in a vehicle, at the camp, or on the premises of a person is prima facie  
2 evidence that the seine, net, or similar device belongs to the person or persons occupying the camp or premises.

3 This subsection (1)(e) does not apply to:

4 (i) a license holder for a private fish pond who is licensed to sell fish and eggs under 87-4-603;

5 (ii) a person with an unexpired seine or net license;

6 (iii) the use, by any person, of a landing net in connection with or in addition to a pole, line, and hooks  
7 in fishing for game fish; or

8 (iv) the possession of traps, seines, or nets when found in the vicinity of any waters in which the  
9 commission has designated that traps, seines, or nets may be used for the taking of nongame fish or game fish.

10 (f) take or catch fish with a hook baited with any poisonous substance or using any poisonous substance,  
11 including fish berries;

12 (g) use archery equipment prohibited by rule of the commission to fish; or

13 (h) use any carbide, lime, giant powder, dynamite, or other explosive compounds or any corrosive or  
14 narcotic poison or other deleterious substance or have any of the enumerated items in the person's possession  
15 within 100 feet of any stream where fish are found for the purpose of catching, stunning, or killing fish. This  
16 subsection (1)(h) does not apply to anyone authorized by the department to conduct lake or stream surveys or  
17 to control undesirable or overpopulated species of fish.

18 (2) The possession of a fishing rod and line, spear, gig, or barbed fork on the banks or shores of a  
19 stream or lake is prima facie evidence that the person or persons in whose possession these implements are  
20 found were using the implements to fish.

21 (3) A person convicted of a violation of this section shall be fined not less than \$50 or more than \$1,000  
22 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person, upon  
23 conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping  
24 license issued by this state and the privilege to hunt, fish, or trap in this state or to use state lands, as defined in  
25 77-1-101, for recreational purposes for a period of time set by the court.

26 (4) A violation of this section may also result in an order to pay restitution pursuant to [sections 67 and  
27 68].

28  
29 **NEW SECTION. Section 46. Trapping and snaring offenses.** (1) A person may not use a snare trap  
30 for the purpose of snaring a fur-bearing animal, a predatory animal, or a nongame species unless:

1 (a) the snare trap is tagged with a numbered metal device identifying the owner's name, address, and  
2 telephone number;

3 (b) the consent of the landowner has been obtained for a set on private property; and

4 (c) the snare trap is set in a manner and at a time so that it will not unduly endanger livestock. A person  
5 who injures livestock in snare traps is liable for damages to the owner of the livestock.

6 (2) A person trapping fur-bearing animals, predatory animals, or any other animals shall fasten a metal  
7 tag to all traps bearing in legible English the name and address or wildlife conservation license number of the  
8 trapper, except that a tag is not required on traps used by landowners trapping on their own land or on an  
9 irrigation ditch right-of-way contiguous to the land.

10 (3) A holder of a Class C-2 trapper's license may not trap or snare predatory animals or nongame wildlife  
11 on private property without obtaining written permission from the landowner, the lessee, or their agents.

12 (4) A person may not at any time willfully destroy, open or leave open, or partially destroy a house of any  
13 muskrat or beaver, except that trapping in the house of muskrats is not prohibited when authorized by the  
14 commission.

15 (5) (a) A person may not destroy, disturb, or remove any trap or snare belonging to another person or  
16 remove wildlife from a trap or snare belonging to another person without permission of the owner of the trap or  
17 snare, except that from March 1 to October 1 of each year a person may remove any snare from land owned or  
18 leased by the person if the snare would endanger livestock.

19 (b) This subsection (5) does not apply to a law enforcement officer acting within the scope of the officer's  
20 duty.

21 (6) A person convicted of a violation of this section shall be fined not less than \$50 or more than \$1,000  
22 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person, upon  
23 conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping  
24 license issued by the state and the privilege to hunt, fish, or trap in this state or to use state lands, as defined in  
25 77-1-101, for recreational purposes for a period of time set by the court.

26 (7) A violation of this section may also result in an order to pay restitution pursuant to [sections 67 and  
27 68].

28  
29 **NEW SECTION. Section 47. Trapping during closed season.** (1) A person may not trap or hunt or  
30 attempt to trap or hunt any fur-bearing animal until the commission provides an open season on any fur-bearing



1 animal. The furs and hides of fur-bearing animals legally taken during the open season may be possessed,  
2 bought, and sold at any time except as provided by law.

3 (2) When it is shown that muskrats or beaver are causing severe injury to or are a menace to the  
4 structures, canal banks, or other works of an irrigation project or district or to a stock water pond, any employee  
5 or resident landowner on the project or district may kill or trap or cause to be killed or trapped any muskrat or  
6 beaver upon or in menacing proximity to the structures, canal banks, or other works of the project or district or  
7 the stock water pond during the closed season on muskrats or beaver after having secured from the director a  
8 permit to do so, except that from June 1 to August 31 of each year, a permit is not required.

9 (3) A person convicted of a violation of this section shall be fined not less than \$100 or more than \$1,000  
10 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person, upon  
11 conviction or forfeiture of bond or bail, shall forfeit any current hunting, fishing, or trapping license issued by this  
12 state and the privilege to hunt, fish, or trap in this state for 24 months from the date of conviction or forfeiture  
13 unless the court imposes a longer period, and any pelts possessed unlawfully must be confiscated.

14 (4) A violation of this section may also result in an order to pay restitution pursuant to [sections 67 and  
15 68].

16  
17 **NEW SECTION. Section 48. Waste of fur-bearing animal.** (1) A person may not waste a fur-bearing  
18 animal by purposely or knowingly:

19 (a) failing to pick up traps or snares at the end of the trapping season so that the pelt of a fur-bearing  
20 animal is wasted;

21 (b) attending traps or snares so that fur-bearing animals are wasted; or

22 (c) wasting the pelt of any fur-bearing animal.

23 (2) The department shall enforce the provisions of this section.

24 (3) The following are exempt from this section:

25 (a) federal, state, and county predator control programs; and

26 (b) pelts of muskrat and beaver killed pursuant to [section 47(2)].

27 (4) As used in this section, "pelt" means the pelt, skin, or fur of a fur-bearing animal.

28 (5) A person convicted of a violation of this section shall be fined not less than \$50 or more than \$1,000  
29 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, a person, upon  
30 conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping

1 license issued by this state and the privilege to hunt, fish, or trap in this state or to use state lands, as defined in  
2 77-1-101, for recreational purposes for a period of time set by the court.

3  
4 **NEW SECTION. Section 49. Failure to report or tattoo.** (1) Any bear, wolf, tiger, mountain lion, or  
5 coyote that is captured alive to be released later or that is held in captivity for any purpose must be reported to  
6 the department within 3 days of the capture or commencement of captivity.

7 (2) Each animal reported as required in subsection (1) must be permanently tattooed or otherwise  
8 permanently identified in a manner that will provide positive individual identification of the animal. No tattoo is  
9 required if the animal is subject to a permanent, individual identification process by another state or federal  
10 agency.

11 (3) Any person holding a bear, wolf, tiger, mountain lion, or coyote in captivity shall immediately report  
12 to the department any death, escape, release, transfer of custody, or other disposition of the animal.

13 (4) A person convicted of a violation of this section shall be fined not less than \$50 or more than \$1,000  
14 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person, upon  
15 conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping  
16 license issued by this state and the privilege to hunt, fish, or trap in this state or to use state lands, as defined in  
17 77-1-101, for recreational purposes for a period of time set by the court.

18  
19 **NEW SECTION. Section 50. Outfitting without a license.** (1) (a) A person may not purposely or  
20 knowingly engage in outfitting while not licensed pursuant to Title 37, chapter 47, or purposely or knowingly  
21 violate a licensing rule adopted under Title 37, chapter 47.

22 (b) A person convicted of a violation of subsection (1)(a) is punishable by a fine of not less than \$200  
23 or more than \$1,000 or imprisonment in the county jail for up to 1 year, or both. In addition, the person shall forfeit  
24 any current hunting, fishing, or trapping license or permit issued by this state and the privilege to hunt, fish, or trap  
25 in this state for a period set by the court. A sentencing court that imposes a period of license revocation shall  
26 consider the provisions of subsection (3).

27 (2) (a) A person or entity that represents to any other person, any entity, or the public that the person  
28 or entity is an outfitter and who commits the offense of outfitting without a license, as described in subsection  
29 (1)(a), for any portion of 5 or more days for consideration within 1 calendar year for any person or for  
30 consideration valued in excess of \$5,000 is punishable by a fine of not more than \$50,000 or imprisonment in the

1 state prison for up to 5 years, or both.

2 (b) A person convicted of a violation of subsection (2)(a) shall forfeit any current hunting, fishing, or  
3 trapping license or permit issued by this state and the privilege to hunt, fish, or trap in this state for a minimum  
4 of 5 years. A sentencing court that imposes a period of license revocation shall consider the provisions of  
5 subsection (3).

6 (3) A sentencing court that imposes a period of license revocation pursuant to subsection (1)(b) or (2)(b)  
7 shall consider and may impose any of the following conditions during the period of revocation:

8 (a) prohibiting the offender from:

9 (i) participating in any hunting, fishing, or trapping endeavor as a hunter, angler, trapper, scout, guide,  
10 observer, or assistant;

11 (ii) brokering or participating in any lease of property for hunting, fishing, or trapping, either personally  
12 or through an agent or representative;

13 (iii) participating in any seminar or show that is designed to promote hunting, fishing, or trapping;

14 (iv) purchasing or possessing any hunting, fishing, or trapping permits; and

15 (b) imposing any other reasonable condition or restriction that is related to the crime committed or that  
16 is considered necessary for the rehabilitation of the offender or for the protection of the citizens or wildlife of this  
17 state.

18 (4) A person convicted of a violation of this section shall reimburse the full amount of any fees received  
19 to the person to whom illegal outfitting services were provided.

20 (5) As used in this section, the following definitions apply:

21 (a) "Consideration" means remuneration given in exchange for outfitting services supplied based on a  
22 business relationship between parties, but not including reimbursement for shared trip expenses.

23 (b) (i) "Outfitting" means providing hunting or fishing services for consideration, including any saddle or  
24 pack animal, facilities, camping equipment, personal service, or vehicle, watercraft, or other conveyance for any  
25 person to hunt, fish, trap, capture, take, kill, or pursue any game, including fish. The term includes accompanying  
26 that person, either part or all of the way, on an expedition for any of these purposes or supervision of a licensed  
27 guide or professional guide in accompanying that person.

28 (ii) The term does not include the provision of the services listed in subsection (5)(b)(i) by a person on  
29 real property that the person owns for the primary pursuit of bona fide agricultural interests.

30

1            **NEW SECTION. Section 51. Taxidermist offenses.** (1) A person convicted of a violation of 87-4-201  
2 related to the licensing and recordkeeping of taxidermists shall be fined not less than \$50 or more than \$1,000  
3 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person, upon  
4 conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping  
5 license issued by this state and the privilege to hunt, fish, or trap in this state or to use state lands, as defined in  
6 77-1-101, for recreational purposes for a period of time set by the court.

7            (2) In addition to the penalties in subsection (1), the taxidermist's license of the person convicted may  
8 be revoked by the court.

9

10           **NEW SECTION. Section 52. Fur dealer offenses.** A person convicted of a violation of 87-4-302 or  
11 87-4-303 related to the licensing and recordkeeping of a fur dealer shall be fined not less than \$50 or more than  
12 \$1,000 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the  
13 person, upon conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing,  
14 or trapping license issued by the state and the privilege to hunt, fish, or trap in this state or to use state lands, as  
15 defined in 77-1-101, for recreational purposes for a period of time set by the court.

16

17           **NEW SECTION. Section 53. Alternative livestock ranch offenses.** (1) A person may not purposely  
18 or knowingly violate any provision of or rule adopted pursuant to Title 87, chapter 4, part 4, pertaining to the  
19 licensure or operation of an alternative livestock ranch.

20           (2) In addition to license revocation or other penalties allowed by 87-4-427, a person who purposely or  
21 knowingly violates this section shall be fined not more than \$1,000 or be imprisoned in the county jail for not more  
22 than 1 year, or both.

23           (3) Any violation of [section 12] regarding the sale of an animal in connection with an alternative livestock  
24 ranch is subject to prosecution and penalties under that section.

25

26           **NEW SECTION. Section 54. Shooting preserve offenses.** (1) A person may not:

27           (a) hunt on a shooting preserve without obtaining a license pursuant to 87-4-504; or

28           (b) harvest game on a shooting preserve without tagging the game pursuant to 87-4-525.

29           (2) Each shooting preserve operator shall keep records in accordance with 87-4-526.

30           (3) A person convicted of a violation of this section shall be fined not less than \$50 or more than \$1,000

1 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person, upon  
2 conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping  
3 license issued by this state and the privilege to hunt, fish, or trap in this state or to use state lands, as defined in  
4 77-1-101, for recreational purposes for a period of time set by the court.

5  
6 **NEW SECTION. Section 55. Unlawful sale of fish or spawn.** (1) Except as provided in 87-4-601 and  
7 subsections (2) and (3) of this section, a person may not, for speculative purposes, for market, or for sale, catch  
8 game fish or remove or cause to be removed the eggs or spawn of any game fish in any way. A person may not  
9 sell or offer for sale game fish or the eggs or spawn from game fish.

10 (2) The restrictions of subsection (1) do not apply to the:

11 (a) catching of fish or the collecting of eggs or spawn in a private fish pond licensed under 87-4-603 by  
12 the owner of the pond;

13 (b) taking of fish by state authorities for the purpose of obtaining eggs for propagation in state fish  
14 hatcheries or by any person who receives a permit from the department to take eggs for use in a private fish pond  
15 licensed under 87-4-603;

16 (c) catching of whitefish by the holder of a valid fishing license fishing with hook and line or a rod in  
17 specified waters designated by rules of the commission;

18 (d) taking of whitefish by nets or traps in the Kootenai River and in its tributary streams within 1 mile of  
19 the Kootenai River under rules of the commission; or

20 (e) sale by the department of fish eggs produced from brood stock owned by the department but  
21 determined to be in excess of the department's needs.

22 (3) A person may possess and sell legally taken nongame fish as provided in 87-4-609 and rules  
23 adopted by the department pursuant to 87-4-609.

24 (4) A person convicted of a violation of this section shall be fined not less than \$50 or more than \$1,000  
25 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person, upon  
26 conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping  
27 license issued by this state and the privilege to hunt, fish, or trap in this state or to use state lands, as defined in  
28 77-1-101, for recreational purposes for a period of time set by the court.

29  
30 **NEW SECTION. Section 56. Unlawful taking of fish or aquatic organism.** (1) A person may not take

1 fish or aquatic organisms for commercial purposes without obtaining a permit from the department pursuant to  
2 87-4-609.

3 (2) A person convicted of a violation of this section shall be fined not less than \$50 or more than \$1,000  
4 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person, upon  
5 conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping  
6 license issued by this state and the privilege to hunt, fish, or trap in this state or to use state lands, as defined in  
7 77-1-101, for recreational purposes for a period of time set by the court.

8 (3) A violation of this section may also result in an order to pay restitution pursuant to [sections 67 and  
9 68].

10  
11 **NEW SECTION. Section 57. Unlawful taking of crayfish.** (1) A person may not take crayfish from  
12 the waters of the state, except from private fish ponds regulated under 87-4-603 or as provided in subsection (2)  
13 of this section, for sale or commercial distribution.

14 (2) A person may take crayfish from the waters of the state for sale or commercial distribution as fishing  
15 bait under rules adopted by the department under 87-4-609.

16 (3) A person convicted of a violation of this section may be fined not less than \$50 or more than \$500  
17 or may be imprisoned in the county jail for not more than 6 months, or both.

18  
19 **NEW SECTION. Section 58. Menagerie and zoo offenses.** (1) A person may not:

20 (a) operate a roadside menagerie or wild animal menagerie without a permit obtained pursuant to  
21 87-4-803;

22 (b) subscribe to any false statement in an application for a permit; or

23 (c) obtain wild animals for a roadside menagerie, wild animal menagerie, or zoo by capture from the wild  
24 or by purchase except in accordance with 87-4-804.

25 (2) A person convicted of a violation of this section shall be fined not less than \$50 or more than \$1,000  
26 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person, upon  
27 conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping  
28 license issued by this state and the privilege to hunt, fish, or trap in this state or to use state lands, as defined in  
29 77-1-101, for recreational purposes for a period of time set by the court.

30

1            **NEW SECTION. Section 59. Owning, controlling, or propagating game birds without license.** A  
2 person who owns, controls, or propagates game birds in violation of Title 87, chapter 4, part 9, shall be fined not  
3 less than \$50 or more than \$1,000 or be imprisoned in the county detention center for not more than 6 months,  
4 or both. In addition, the person, upon conviction or forfeiture of bond or bail, may be subject to forfeiture of any  
5 current hunting, fishing, or trapping license issued by this state and the privilege to hunt, fish, or trap in this state  
6 or to use state lands, as defined in 77-1-101, for recreational purposes for a period of time set by the court.

7  
8            **NEW SECTION. Section 60. Owning, controlling, or propagating furbearers without license.** A  
9 person who owns, controls, or propagates furbearers in violation of 87-4-1002 shall be fined not less than \$50  
10 or more than \$1,000 or be imprisoned in the county detention center for not more than 6 months, or both. In  
11 addition, the person, upon conviction or forfeiture of bond or bail, may be subject to forfeiture of any current  
12 hunting, fishing, or trapping license issued by this state and the privilege to hunt, fish, or trap in this state or to  
13 use state lands, as defined in 77-1-101, for recreational purposes for a period of time set by the court.

14  
15            **NEW SECTION. Section 61. Unlawful acquisition of furbearer.** (1) A person may not capture, take,  
16 or otherwise acquire a furbearer from the wild for use on a fur farm.

17            (2) A person convicted of a violation of this section shall be fined not less than \$50 or more than \$1,000  
18 or be imprisoned in the county detention center for not more than 6 months, or both. In addition, the person, upon  
19 conviction or forfeiture of bond or bail, may be subject to forfeiture of any current hunting, fishing, or trapping  
20 license issued by this state and the privilege to hunt, fish, or trap in this state or to use state lands, as defined in  
21 77-1-101, for recreational purposes for a period of time set by the court.

22            (3) A violation of this section may also result in an order to pay restitution pursuant to [sections 67 and  
23 68].

24  
25            **NEW SECTION. Section 62. Wild bird, raptor, and falcon offenses.** (1) A person who violates any  
26 provision of Title 87, chapter 5, part 2, pertaining to the regulation of wild birds, raptors, and falconry, shall be  
27 fined not less than \$50 or more than \$1,000 or be imprisoned in the county detention center for not more than  
28 6 months, or both. In addition, the person, upon conviction or forfeiture of bond or bail, may be subject to forfeiture  
29 of any current hunting, fishing, or trapping license issued by this state and the privilege to hunt, fish, or trap in this  
30 state or to use state lands, as defined in 77-1-101, for recreational purposes for a period of time set by the court.

1 (2) A violation of this section may also result in an order to pay restitution pursuant to [sections 67 and  
2 68].

3  
4 **NEW SECTION. Section 63. Second offense penalties.** (1) A person convicted of a second offense  
5 of any of the following offenses within 10 years of the first conviction or who is convicted of two or more of the  
6 following offenses at different times within a 10-year period is subject to the penalties provided in subsection (2):

- 7 (a) hunting during a closed season;  
8 (b) taking an animal or hunting while using projected artificial light;  
9 (c) hunting without a license;  
10 (d) unlawful taking of more than double the legal bag limit;  
11 (e) unlawful possession of more than double the legal bag limit; and  
12 (f) waste of game by abandonment in the field.

13 (2) A person convicted of the offenses in subsection (1) in the time periods specified in subsection (1)  
14 shall be fined not less than \$2,000 or more than \$5,000 or be imprisoned in the county jail for not more than 1  
15 year, or both. In addition, the person, upon conviction or forfeiture of bond or bail, shall forfeit any current hunting,  
16 fishing, or trapping license issued by this state and the privilege to hunt, fish, or trap in this state for 60 months  
17 from the date of conviction or forfeiture unless the court imposes a longer period.

18  
19 **NEW SECTION. Section 64. Third offense penalties.** (1) A person convicted of a third offense of any  
20 of the following offenses within 10 years of the first conviction is subject to the penalties provided in subsection  
21 (2):

- 22 (a) hunting during a closed season;  
23 (b) taking an animal or hunting while using projected artificial light;  
24 (c) hunting without a license; and  
25 (d) unlawful taking of more than double the legal bag limit.

26 (2) A person convicted of the offenses in subsection (1) in the time period specified in subsection (1)  
27 shall be fined not less than \$5,000 or more than \$10,000 or be imprisoned in the county jail for not more than 1  
28 year, or both. In addition, the person, upon conviction or forfeiture of bond or bail, shall forfeit any current hunting,  
29 fishing, or trapping license issued by this state and the privilege to hunt, fish, or trap in this state for life.

30



1            **NEW SECTION. Section 65. Additional penalty for use of artificial light or scope.** (1) If a person  
2 is convicted of illegally taking an animal described in [section 68 or 69] through the use of projected artificial light,  
3 nightscopes, or infrared scopes, the person is prohibited from fishing or hunting in the state for an additional 5  
4 years following the ending date of the original prohibition period. In addition, the person, upon conviction or  
5 forfeiture of bond or bail, shall successfully complete, at the person's own expense, a department-sponsored  
6 hunter education course.

7            (2) A person convicted of taking an animal while using projected artificial light as described in this section  
8 may be subject to the additional penalties provided in [sections 63 and 64].

9  
10           **NEW SECTION. Section 66. Different penalty for unlawful attempt to hunt or trap.** A person  
11 convicted of unlawfully attempting to hunt or trap a game animal shall be fined not less than \$200 or more than  
12 \$600 or be imprisoned in the county detention center for not more than 60 days, or both.

13  
14           **NEW SECTION. Section 67. Finding required for restitution.** Before restitution may be ordered  
15 pursuant to [section 68 or 69], the finder of fact at trial or the court upon entry of a guilty or nolo contendere plea  
16 shall find that the illegal killing or possession was done knowingly or purposely as defined in 45-2-101. This  
17 finding is not required for state reimbursement under [section 68] when bond or bail is forfeited.

18  
19           **NEW SECTION. Section 68. Restitution for illegal killing or possession of certain wildlife.** (1)  
20 Except as provided in [section 69] and in addition to other penalties provided by law, a person convicted or  
21 forfeiting bond or bail on a charge of the illegal taking, killing, or possession of a wild bird, mammal, or fish listed  
22 in this section shall reimburse the state for each bird, mammal, or fish according to the following schedule:

- 23            (a) mountain sheep and endangered species, \$2,000;  
24            (b) elk, caribou, bald eagle, black bear, wolf, and moose, \$1,000;  
25            (c) mountain lion, lynx, wolverine, buffalo, golden eagle, osprey, falcon, antlered deer as defined by  
26 commission regulation, bull trout longer than 18 inches, and adult buck antelope as defined by commission  
27 regulation, \$500;  
28            (d) deer not included in subsection (1)(c), antelope not included in subsection (1)(c), fisher, raptor not  
29 included in subsection (1)(c), swan, bobcat, white sturgeon, river-dwelling grayling, and paddlefish, \$300;  
30            (e) fur-bearing animals that are not listed in subsection (1)(c) or (1)(d), \$100;

1 (f) game bird (except swan), \$25;

2 (g) game fish, \$10.

3 (2) When a court enters an order declaring bond or bail to be forfeited, the court may also order that  
4 some or all of the forfeited bond or bail be paid as restitution to the state according to the schedule in subsection  
5 (1). A hearing to determine the amount of restitution, as required under 46-9-512, is not required for an order of  
6 restitution under this section.

7  
8 **NEW SECTION. Section 69. Restitution for illegal killing or possession of trophy wildlife.** In  
9 addition to other penalties provided by law, a person convicted or forfeiting bond or bail on a charge of purposely  
10 or knowingly illegally killing, taking, or possessing a trophy animal listed in this section shall reimburse the state  
11 for each trophy animal according to the following schedule:

12 (1) mountain sheep with at least one horn equal to or greater than a three-fourth curl as defined by  
13 commission regulation, \$30,000;

14 (2) elk with at least six points on one antler, as defined by commission regulation, or any grizzly bear,  
15 \$8,000;

16 (3) moose having antlers with a total spread of at least 30 inches, as defined by commission regulation,  
17 or any mountain goat, \$6,000;

18 (4) antlered deer with at least four points on one antler as defined by commission regulation, \$8,000;

19 (5) antelope with at least one horn greater than 14 inches in length as defined by commission regulation,  
20 \$2,000.

21  
22 **NEW SECTION. Section 70. Payment -- penalty for nonpayment of restitution.** (1) In each case of  
23 conviction, the court before which the conviction is obtained shall order payment of the sum stated in [section 68  
24 or 69].

25 (2) Failure to make payment in the time and manner prescribed by the court constitutes civil contempt  
26 of court and is punishable as provided in Title 3, chapter 1, part 5.

27  
28 **NEW SECTION. Section 71. Disposition of proceeds from restitution.** All money collected by a court  
29 pursuant to [sections 67 through 70] must be remitted to the department of revenue for deposit in the state special  
30 revenue fund account to the credit of the department for hunter education purposes or for enforcement.

1  
2           **NEW SECTION. Section 72. Remedial hunter education program -- sentencing.** (1) The court may  
3 sentence a person who is convicted of a hunting violation that results in a mandatory forfeiture of hunting  
4 privileges or who is convicted of a hunting violation to complete a remedial hunter education course.

5           (2) A person who is sentenced by the court to complete a remedial hunter education course shall  
6 successfully complete the course before any license privileges may be restored.

7           (3) The department may not issue a hunting, fishing, or trapping license to a person who is convicted  
8 of a hunting violation that results in a mandatory forfeiture of hunting privileges until the person has successfully  
9 completed the remedial hunter education course.

10           (4) If the person who is sentenced by the court to complete the remedial hunter education course is not  
11 a resident of the state of Montana, the sentencing court shall require the person to complete a similar remedial  
12 hunter education course in the person's state of residence. If a similar course does not exist in the person's state  
13 of residence, the person shall complete Montana's course before any Montana hunting, fishing, or trapping  
14 license may be issued.

15           (5) This section does not allow the issuance of any licenses to a person whose hunting or fishing  
16 privileges have been revoked for life.

17  
18           **NEW SECTION. Section 73. Costs of imprisonment.** Subject to sentencing restrictions, the court shall  
19 order a person who is convicted pursuant to [sections 1 through 80] to pay the costs of imprisonment under  
20 [sections 1 through 80].

21  
22           **NEW SECTION. Section 74. Privileges of juveniles.** A mandatory forfeiture of privileges imposed  
23 pursuant to [sections 1 through 80] does not apply to juveniles. However, the court may, at its discretion, order  
24 forfeiture of a juvenile's current hunting, fishing, or trapping licenses issued by this state and the juvenile's  
25 privilege to hunt, fish, or trap in this state upon conviction or forfeiture of bond or bail for a violation of this title.

26  
27           **NEW SECTION. Section 75. Restriction on special application or entry when ordered to pay**  
28 **restitution.** A person convicted or who has forfeited bond or bail under this title and who has been ordered to  
29 pay restitution under the provisions of [section 68 or 69] may not apply for any special license under Title 87,  
30 chapter 2, part 7, or enter any drawing for a special license or permit for a period of 5 years following the date

1 of conviction or restoration of license privileges, whichever is later. If the violation involved the unlawful taking of  
2 a moose, a mountain sheep, or a mountain goat, the person may not apply for a special license or enter a  
3 drawing for a special license or permit for the same species of game animal that was unlawfully taken for an  
4 additional period of 5 years following the ending date of the first 5-year period.

5

 17 trap in this state for not less than 24 months from the date of conviction or forfeiture. If the time necessary to  
 18 eliminate or mitigate the effects of the violation exceeds 24 months, a person may be required to forfeit the  
 19 privilege to hunt, fish, or trap in this state for more than 24 months. If the effects of the violation cannot be  
 20 eliminated or mitigated, a person may be required to forfeit the privilege to hunt, fish, or trap in this state for ~~the~~  
 21 lifetime of that person life.

22           (3) Any exotic wildlife held in violation of this part must be shipped out of state, returned to the point of  
 23 origin, or destroyed within a time set by the department, not to exceed 6 months. The person in possession of  
 24 the exotic wildlife may choose the method of disposition. If the person in possession of the exotic wildlife does  
 25 not comply with this requirement, the department may confiscate and then house, transport, or destroy the  
 26 unlawfully held exotic wildlife. The department may charge any person convicted of a violation of this part for the  
 27 costs associated with the handling, housing, transporting, or destroying of the exotic wildlife."
