Dear Speaker Blasdel and President Essmann:

In accordance with the power vested in me as Governor by the Constitution and the laws of the State of Montana, I hereby veto House Bill 27 (HB 27), "AN ACT AUTHORIZING THE USE OF A SUPPRESSOR WHILE HUNTING CERTAIN LARGE PREDATORS; AMENDING SECTION 87~6~401, MCA; AND PROVIDING AN EFFECTIVE DATE."

Allowing the use of suppressed weapons for hunting was proposed in the 2009 and 2011 Montana legislative sessions. In both sessions, the legislation was defeated. I do not see the need for suppressed weapons for wolf hunting. I believe most Montanans would agree.

This legislature has already passed, and I have signed into law, HB 73, which substantially liberalized the methods by which wolves may be hunted in Montana. HB 73 allows hunters to obtain multiple wolf licenses, allows wolf hunters to use electronic calls and not wear orange when hunting wolves outside the general big game season, and reduces the price of a nonresident wolf license. That bill enjoyed overwhelming bipartisan support because these measures will facilitate a more effective wolf harvest, while maintaining Montana's time-honored traditions of fair-chase hunting.

HB 27 does not meet this critical threshold. Allowing suppressed weapons to hunt wolves will not provide a more effective wolf hunting season, or add significantly to overall wolfharvest.

Most hunters are very concerned about the future of hunting in Montana. They know how important it is to act responsibly to protect our hunting traditions through reverence for game animals, use of fair-chase methodology, and attention to maintaining a respectful public image.

Hunting with suppressed weapons has negative connotations that warrant serious consideration in the face of attempts by anti-hunters to portray hunting in a negative light.

From a law enforcement perspective, suppressors represent a challenge to peace officers as they attempt to ensure compliance with both state law and rules set by property owners. Enforcing fish and game laws is a demanding job. We should not make a game warden's job that much more difficult by allowing a situation in which he or she cannot readily identify or locate the full sound of rifle shots in the field because of the use of a suppressed weapon by an individual who could have less than lawful intentions.

Property owners across Montana deserve the same consideration, as they endeavor to be good neighbors by allowing hunters access to their land. I believe most landowners prefer to hear the full discharge of a firearm when hunters or others with firearms are on or near their property. For these reasons, I respectfully ask for your support in sustaining my veto.

In accordance with the power vested in me as Governor by the Constitution and the laws of the State of Montana, I hereby return with amendments House Bill 131 (HB 131), "AN ACT AUTHORIZING THE DEPARTMENT OF PUBLIC HEALTH AND HUMAN SERVICES TO SHARE LIMITED INFORMATION ABOUT AN INVESTIGATION INTO A REPORT OF CHILD ABUSE OR NEGLECT WITH A MANDATORY REPORTER WHO MADE A REQUIRED REPORT OF ALLEGED CHILD ABUSE OR NEGLECT OR INDIVIDUALS DESIGNATED BY THE MANDATORY REPORTER; AND AMENDING SECTIONS 41-3-201 AND 41-3-205, MCA.

House Bill 131 authorizes the Department of Public Health and Human Services to release certain information concerning the status of child abuse or neglect investigations to mandatory reporters or their designees. SB 65, signed into law on March 1,2013, revised some of the same sections of code at issue in HB 131. Pursuant to SB 65, the Department may release certain limited information concerning the status of child abuse or neglect investigations to a broader category of reporters of child abuse or neglect, including mandatory reporters. These bills were not reconciled during the legislative process.

I support the intent of both of these bills. My amendments reconcile HB 131 with SB 65, maintaining the disclosure requirements of SB 65 while providing for the more specific information disclosed to mandatory reporters under HB 131.

I respectfully ask for your support of these amendments.

Dear Speaker Blasdel and President Essmann:

In accordance with the power vested in me as Governor by the Constitution and the laws of the State of Montana, I hereby veto House Bill 302 (HB 302), "AN ACT PROHIBITING THE ENFORCEMENT OF A POTENTIAL FEDERAL BAN ON SEMIAUTOMATIC WEAPONS AND LARGE MAGAZINES; PROVIDING PENAL TIES; AND PROVIDING AN 1MMEDIA TE EFFECTIVE DATE."

House Bill 302 puts law enforcement in the position of violating laws they have sworn to uphold. When public safety officers graduate from the Montana Law Enforcement Academy, they take an

oath to "enforce or apply all laws and regulations appropriately, courteously, and responsibly" and also to "work in unison with all legally authorized agencies and their representatives in the pursuit ofjustice." HB 302 would subject our peace officers to criminal sanctions for upholding the oath we ask that they take.

Further, HB 302 is unnecessary. To date, there has been no action in Congress to enact a ban on semiautomatic weapons. Moreover, recent news reports have indicated that a mc:Uority of Congress does not support such legislation.

I am and always have been a staunch supporter of our Second Amendment rights. We have a strong tradition in Montana of gun ownership, hunting and participation in shooting sports. I believe that is an important tradition to preserve. As Attorney General, I fought to protect Montanans' right to keep and bear arms, and as Governor, I will not hesitate to stand up to the federal government or anyone else who attempts to infringe on those rights. However, this bill is unnecessary political theater and would not meaningfully protect our Second Amendment rights.

Because HB 302 is unnecessary and puts law enforcement in a position of potentially violating federal law, I respectfully request that you sustain my veto.
