In accordance with the power vested in me as Governor by the Constitution and the laws of the State of Montana, I hereby return with amendments House Bill 225 (HB 225), "AN ACT REVISING THE INTEREST THAT MAYBE A WARDED ON CIVIL JUDGMENTS; AMENDING SECTIONS 25-9-205 AND 27-1-210, MCA; AND PROVIDING AN EFFECTIVE DATE AND AN APPLICABILITY DATE."

Montana law establishes interest on judgments in civil cases at 10 percent, subject to exceptions for contractually-based interest rates. HB 225 seeks to treat judgments in actions for recovery on an injury (to person or to property) differently from other civil judgments. There is no justifiable reason for the differential treatment. My amendments correct this inequitable aspect of HB 225.

HB 225 also converts the current specified interest rate to a rate that would fluctuate based on the prime rate published by the Federal Reserve System. In its current form, HB 225 would create an interest rate that would be at or near the lowest rate in the country, to the disadvantage of Montana individuals and businesses, and to the advantage of judgment debtors. My amendments establish a reasonable adjustment to the prime rate, while still allowing the interest rate to fluctuate as intended by HB 225.

I respectfully request that the Legislature concur with my amendments.

In accordance with the power vested in me as Governor by the Constitution and the laws of the State of Montana, I hereby return with amendments House Bill 274 (HB 274), "AN ACT REVISING LA WS RELATED TO THE LICENSING OF OUTFITTERS AND GUIDES; ELIMINATING THE PROFESSIONAL GUIDE LICENSE; REVISING POWERS AND DUTIES OF THE BOARD OF OUTFITTERS; REVISING REPORTING REQUIREMENTS; REVISING QUALIFICATIONS AND APPLICATION AND EXAM REQUIREMENTS; CLARIFYING THE LIMIT ON ONE LICENSE PER INDIVIDUAL; REVISING PENALTIES; REVISING RULEMAKING AUTHORITY; AMENDING SECTIONS 7-47-101,37-47-201,37-47-301,37-47-302,37-47-303, 37-47-304,37-47-305,37-47-306,37-47-307, 37-47-310, 37-47-311, 37-47-341, 37-47-343,

37-47401,37-47-402,37-47-403,37-47-404, AND 87-6-702, MCA; AND REPEALING SECTIONS 3747-103,37-47-316, AND 37-47-318, MCA."

HB 274 makes extensive changes to Title 47, Chapter 37, regulating the activities of outfitters and guides. The bill reduces several burdensome reporting requirements for outfitters, but it remains problematic.

HB 274 removes the statutory language in section 37-47-201, MCA, that requires the annual reporting of leased acreage for outfitting, and instead makes such reporting discretionary (section 6). This is unacceptable.

The annual reporting of acreages where licensed outfitters operate is important information to the people of Montana. Licensed outfitters provide valuable services to hunters. Their commercial activities depend upon the use of public wildlife resources as regulated by the Montana Fish, Wildlife & Parks (FWP). Accurate, credible data indicating where licensed outfitters operate is essential to helping the public, FWP, and the Montana Board of Outfitters (MBO) in various respects:

First, it allows MBO and FWP to provide high quality data, rather than anecdotal assumptions, when public policy issues arise regarding how both outfitted and non-outfitted hunting may interact to affect game management, season setting, access to public land, public hunting opportunities, and other resources.

Second, it assists FWP in identifying private land that may be enrolled in both the operations plan of a licensed outfitter and the Block Management program, which is typically a violation of a Block Management contract.

Third, this data is critical for the activities of the Private Land/Public Wildlife Council, mandated in section 87-1-269, MCA, in meeting their charge to evaluate the effectiveness of Block Management and other FWP hunting access programs, and to develop recommendations for the Governor and the Legislature regarding issues related to sports persons, landowners, and outfitters. As you know, on March 12, I announced my intent to revitalize this council in order to bring renewed attention to these important issues.

The collection of current, relevant, and credible data regarding acreages where licensed outfitters are authorized to serve clients and conduct business is in the public interest. This public interest outweighs the relatively small burden presented by the annual reporting requirement, and I therefore propose an amendment to retain it.

I respectfully ask for your support of this amendment.

Dear Speaker Blasdel and President Essmann:

In accordance with the power vested in me as Governor by the Constitution and the laws of the State of Montana, I hereby veto House Bill 281 (HB 281), "AN ACT CHANGING THE STATUTE OF LIMITATIONS FOR MEDICAL MALPRACTICE CLAIMS FROM 3 YEARS TO 2 YEARS; AMENDING SECTION 27-2-205, MCA; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE AND AN APPLICABILITY DATE."

HB 281 would create a shorter statute of limitations for medical negligence cases than other types of negligence actions. The statute of limitations for routine negligence cases is three years. HB 281 would reduce it to two years for medical negligence cases. Medical injury cases are complex -it can take years for the full extent of health consequences from an injury to materialize. Given that the nature of these injuries can have life changing implications for a person's health and financial well-being, reducing the time for investigation and analysis of such claims in not in the best interests of Montanans injured through no fault of their own.

I would also note that HB 281 is simply not necessary. The most recent statistics from the Montana Medical Legal Panel show that the number of medical negligence claims filed in Montana are at their lowest level in nearly 20 years. The number of claims as a percentage of

health care providers in the state is at an all-time low.

For these reasons, I respectfully request that you sustain my veto.

In accordance with the power vested in me as Governor by the Constitution and the laws of the State of Montana, I hereby return with amendments House Bill 359 (HB 359), "AN ACT PROVIDING THAT AN ADMINISTRATIVE OR JUDICIAL ORDER IS ADMISSIBLE IN A CIVIL ACTION REGARDING REMEDIAL ACTIONS RELATED TO HAZARDOUS WASTE FACILITIES; AND AMENDING SECTIONS 75-10-706 AND 75-10-711, MCA."

HB 359 provides that an administrative or judicial order is admissible in a civil action regarding remedial actions related to hazardous waste facilities. The bill arises from litigation over benzene contamination impacting the town of Sunburst. In that case, gasoline leaked from pipes at a nearby refinery operated from 1924 to 1961, contaminating the soil and groundwater. One issue in the case was whether evidence of a remediation order issued many years later by the Department of Environmental Quality (DEQ), and the company's actions relating to that order, should be admissible. The district court held, and the Montana Supreme Court affirmed, that under the facts and circumstances of the case the DEQ order was inadmissible with regard to the question of the company's liability under the common law. The Supreme Court also held that the same evidence was admissible with regard to the question of punitive damages.

HB 359 attempts to create a blanket rule of admissibility for administrative or judicial orders and activity relating to such orders in environmental cases. In my view, the trial judge should continue to have the discretion to decide what evidence comes in, and what evidence stays out, based upon the particular facts and legal action before the court. My amendments make clear that there is no rule favoring admissibility or inadmissibility in such cases -the decision rests with the trial court based on its assessment of whether the evidence is relevant and more probative than prejudicial.

I respectfully ask for your support of my amendments.
