Dear President Essmann and Speaker Blasdel:

In accordance with the power vested in me as Governor by the Constitution and the laws of the State of Montana, I hereby return **with amendments Senate Bill 337** (SB 337), "AN ACT CLARIFYING THE DEFINITION OF "GOOD CAUSE SHOWN" FOR A HEARING ON A TEMPORARY PRELIMINARY DECREE OR PRELIMINARY DECREE; AND AMENDING SECTION 85-2233, MCA."

SB 337 amends the statute defining who has standing to object to a water right claim in the Montana Water Court and who is entitled to a hearing. The bill, as written, purports to grant standing only to a person with an ownership or leasehold interest in an existing water right, permit, certificate, or state reservation.

It is important for the adjudication process to be as comprehensive as possible to allow for a thorough vetting of all tangible interests. Attempting to narrow the scope of participation in the

adjudication process will leave the state's adjudication process vulnerable to challenges by others seeking to take Montana's water, such as other states or the federal government. Further, it is possible that the amendments as proposed in SB 337 may raise constitutional issues, in light of the Montana Supreme Court's rationale in Montana Trout Unlimited v. Beaverhead Water Company, 361 Mont. 77 (2011). While it is up to the courts to decide constitutional questions, I do have an interest in making sure that the laws passed by the legislature do not create the grounds for unnecessary litigation.

My proposed amendments would define those with standing to object as persons not only with an "ownership or leasehold interest" but those with an economic, or other substantial interest. The import of these amendments is significant. With my amendments, and in order to have standing, an individual would be required to demonstrate a real interest in the water right, not simply a general interest as a member of the public.

I respectfully ask that you support my amendments.

In accordance with the power vested in me as Governor by the Constitution and the laws of the State of Montana, I hereby **veto Senate Bill 147** (SB 147), "AN ACT REVISING CRITERIA FOR LOCAL GOVERNMENT REVIEW OF A SUBDIVISION APPLICATION WITH REGARD TO IMPACT ON ADJACENT AGRICULTURAL OPERATIONS; AMENDING SECTION 76-3-608, MCA; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE AND AN APPLICABILITY DATE."

Locally-elected officials are best suited to decide the impacts to their communities from subdivision development, including the impacts of that development on agriculture. Under current law, a local governing body must review a subdivision proposal for its impact on agriculture. This provides the opportunity for local officials to consider a proposed subdivision's impact on adjacent agricultural operations, as well as the overall impacts the conversion of land from agriculture to urban uses will have on agriculture in the area. Certainly, how locally-elected officials choose to look at this issue will reflect the specific values of that particular community.

SB 147 significantly limits the ability of locally-elected officials to reflect community values. It restricts the local governing body's review to the proposed subdivision's impacts on adjacent agricultural operations. This would prevent a local official from considering the larger and cumulative impacts to agriculture as a part of the community.

Agriculture is a vital part of Montana's economy and culture. When evaluating a proposed development, a local community must be able to consider both short and long term agricultural impacts.

Protections are in place to make sure that this important power is not abused. The Montana Subdivision and Platting Act provides that the local governing body may not unreasonably restrict a landowner's ability to develop land, the Montana and United States Constitutions protect landowners from unconstitutional development conditions, and judicial precedent prohibits local elected officials from being arbitrary or capricious in their actions.

I respectfully ask you to sustain my veto.

In accordance with the power vested in me as Governor by the Constitution and the laws of the State of Montana, I hereby **veto Senate Bill 366 (SB 366)**, "AN ACT ELIMINATING THE LIMITATION ON THE NUMBER OF YEARS THAT A MEMBER OF THE ENVIRONMENTAL QUALITY COUNCIL MAY SERVE; AMENDING SECTION 5-16-103, MCA; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE."

SB 366 eliminates term limits for serving on the Environmental Quality Council (Council). Under current law, members may not serve longer than 6 years. The Council is comprised of 12 members of the Legislature and 4 members of the public, as well as an ex officio member that I designate.

The Council serves a number of very important functions, and its charge is a dynamic one. The Council must stay abreast of current environmental trends and new developments, creatively respond to the evolving needs and interests of the state, and recommend forward-looking state policies to promote the improvement of the quality of the environment. To meet these challenges requires fresh thinking and new perspectives. A 6-year term limit balances this need against the desire for continuity. Eliminating term limits could subject the collective work on the Council to a narrowing of interests and viewpoints, which would be a disservice to all Montanans.

In addition, there is a benefit from having members circulate through the Council, being educated on critical environmental issues of the day, and then making room for someone else.

For these reasons I respectfully ask that you sustain my veto.

The state agency is the employer for purposes of the compensation plan selected pursuant to this section. Any sums necessary to be paid under the provisions of this chapter by a state agency are considered to be ordinary and necessary expenses of the state agency. The state agency shall pay the sums into the state fund at the time and in the manner provided for in this chapter, notwithstanding that the state agency may have failed to anticipate the ordinary and necessary expense in a budget, estimate of expenses, appropriations, ordinances, or otherwise.

- (b) (i) Subject to subsection (5), the department of administration, provided for in 2-15-1001, shall manage The department of administration shall elect coverage under one compensation plan to provide workers' compensation insurance coverage for all state agencies except the state compensation insurance fund if the state compensation insurance chooses a plan No. 2 insurer. The plan selected by the department of administration is to be exclusive, compulsory, and obligatory upon both the employer and the employee.
- (ii) The state fund plan No. 2 or plan No. 3 insurer shall provide the department of administration with all information regarding the state agencies' coverage.
- (iii) Notwithstanding the status of a state agency as employer in subsection (1)(a) and contingent upon mutual agreement between the department of administration and the state fund, the state fund plan No. 2 or plan No. 3 insurer, the plan No. 2 or plan No. 3 insurer shall issue one or more policies for all state agencies.
- (iv) In any year in which the workers' compensation premium due from a state agency is lower than in the previous year, the appropriation for that state agency must be reduced by the same amount that the workers' compensation premium was reduced and the difference must be returned to the originating fund instead of being applied to other purposes by the state agency submitting the premium.
- (2) (a) A public corporation, other than a state agency, may elect coverage under compensation plan No. 1, plan No. 2, or plan No. 3, separately or jointly with any other public corporation, other than a state agency or with the department of administration as provided in subsection (2)(b).
- (b) Except as provided in [section 3], the department of administration, on behalf of all state agencies, may join with a public corporation to elect coverage under compensation plan No. 2 or plan No. 3. Until notes or bonds described in subsection (3)(a) are fully paid, the funds described in subsection (3)(a) must remain separate from the funds paid to the department of administration by state agencies.
- (c) A public corporation, if electing <u>coverage under</u> compensation plan No. 1, may purchase reinsurance or issue bonds or notes pursuant to subsection (3)(b). A public corporation electing <u>coverage under</u> compensation plan No. 1 is subject to the same provisions as a private employer electing compensation plan No. 1.
- (3) (a) A public corporation, other than a state agency, that elects coverage under plan No. 1 may establish a fund sufficient to pay the compensation and benefits provided for in this chapter and to discharge all liabilities that are reasonably incurred during the fiscal year for which the election is effective. Proceeds from the fund must may be used only to pay claims covered by this chapter and for actual and necessary expenses required for the efficient administration of the fund, including debt service on any bonds and notes issued pursuant to subsection (3)(b).
 - (b) (i) A public corporation, other than a state agency, separately or jointly with another

public corporation, other than a state agency, may issue and sell its bonds and notes for the purpose of establishing, in whole or in part, the self-insurance workers' compensation fund provided for in subsection (3)(a) and to pay the costs associated with the sale and issuance of the bonds. Bonds and notes may be issued in an amount not exceeding 0.18% of the total assessed value of taxable property, determined as provided in 15-8-111, of the public corporation as of the date of issue. The bonds and notes must be authorized by resolution of the governing body of the public corporation and are payable from an annual property tax levied in the amount necessary to pay principal and interest on the bonds or notes. This authority to levy an annual property tax exists despite any provision of law or maximum levy limitation, including 15-10-420, to the contrary. The revenue derived from the sale of the bonds and notes may not be used for any other purpose.

- (ii) The bonds and notes:
- (A) may be sold at public or private sale;
- (B) do not constitute debt within the meaning of any statutory debt limitation; and
- (C) may contain other terms and provisions that the governing body determines.
- (iii) Two or more public corporations, other than state agencies, may agree to exercise their respective borrowing powers jointly under this subsection (3)(b) or may authorize a joint board to exercise the powers on their behalf.
- (iv) The fund established from the proceeds of bonds and notes issued and sold under this subsection (3)(b) may, if sufficient, be used in lieu of a surety bond, reinsurance, specific and aggregate excess insurance, or any other form of additional security necessary to demonstrate the public corporation's ability to discharge all liabilities as provided in subsection (3)(a). Subject to the total assessed value limitation in subsection (3)(b)(i), a public corporation may issue bonds and notes to establish a fund sufficient to discharge liabilities for periods greater than 1 year.
- (4) All money in the fund established under subsection (3)(a) not needed to meet immediate expenditures must be invested by the governing body of the public corporation or the joint board created by two or more public corporations as provided in subsection (3)(b)(iii), and all proceeds of the investment must be credited to the fund.
- (5) For the purposes of subsection $\frac{(1)(b)}{(1)(a)}$, the judicial branch or the legislative branch may choose not to have the department of administration manage its workers' compensation policy.
- (6) The department of administration may adopt rules to implement subsection (1)(b)(i) this section.

- (a) "Public corporation" includes has the meaning provided in 39-71-116 except that a state agency is excluded and the Montana university system is included.

 - (B) the judicial branch; and
 - (C) the legislative branch.

In accordance with the power vested in me as Governor by the Constitution and the laws of the State of Montana, I hereby **return with amendments Senate Bill 28 (SB 28)**, "AN ACT ADOPTING THE INTERSTATE INSURANCE PRODUCT REGULATION COMPACT; AUTHORIZING THE STATE AUDITOR AS COMMISSIONER OF INSURANCE TO PARTICIPATE IN THE COMPACT; ENSURING THAT PARTICIPATING STATES PROVIDE A COMMON FRAMEWORK FOR REGULATING DESIGNATED INSURANCE PRODUCTS; LEGISLATIVELY OPTING OUT OF CERTAIN UNIFORM STANDARDS; PROVIDING OPTOUT AUTHORITY; LIMITING GOVERNMENTAL LIABILITY; AMENDING SECTIONS 33-1311 AND 33-1-501, MCA; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE."

SB 28 adopts the Interstate Insurance Product Regulation Compact and provides for an immediate effective date. My amendment will remove the immediate effective date to allow the Commissioner of Securities and Insurance and the insurance industry the necessary time to prepare for complying with the provisions of the bill. In accordance with the power vested in me as Governor by the Constitution and the laws of the State of Montana, I hereby **return with amendments Senate Bill 347 (SB 347)**, "AN ACT PROVIDING THAT A DIVERSION OR WITHDRAWAL OF WATER IS NOT DEGRADATION UNDER THE WATER QUALITY ACT; AMENDING SECTIONS 75-5-103 AND 75-5-317, MCA; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE."

Under existing laws protecting water quality that have been in force for two decades, an activity that decreases water flow is not significant to human health or the environment if the decrease is within certain measurable numeric limits. In addition, a decrease in flow outside of these numeric limits may still be acceptable (if the Department of Environmental Quality (DEQ) makes certain findings based on specific criteria).

SB 347 would amend the Montana Water Quality Act, replacing these protections with only a narrative standard that would require the DEQ to determine if the decrease in flow would "have a reasonable possibility to cause a significant adverse impact on a fish population."

I have several concerns with this approach.

First and foremost, I am very concerned that this change will invite substantial litigation, delaying the creation of jobs. SB 347 would replace a set standard that is measurable and widely understood ("decrease in the mean monthly flow of a surface water by less than 15% or the seven-day 10 year low flow by less than 10%"), with a narrative description that is subject to dispute and differing scientific opinions. The vagueness of the narrative standard in SB 347 was identified by several parties during the legislative process. This is sure to generate litigation.

Second, I believe the reference to "a fish population," while very important, is not consistent with our laws relating to surface water quality which use "aquatic life" as the standard yardstick. A stream should be protected from de-watering even if it does not contain fish. Besides, every angler knows that healthy aquatic insects are a critical part of having healthy fish populations.

Third, the Legislature has previously determined that the impacts on existing water rights are an important consideration, and current law reflects this judgment (section 75-5-301 (5)(c)(i), MCA).

SB 347 does away with this consideration, except in those instances where protecting "a fish population" also happens to protect an existing water right (or where the decrease in flow is for a beneficial use, which is then reviewed for its impacts on senior water right holders under Title 85, Chapter 2, MCA).

Accordingly I propose amendments to accomplish three objectives:

- 1. In order to provide as much clarity as possible in regard to this new narrative standard, and lessen the risk of litigation, I am including explicit direction to the Board of Environmental Review to adopt rules to give specificity to the new standard, with a completion date of November 1, 2014.
- 2. To provide that "aquatic life" is the benchmark in the narrative standard. In extending protection to streams where fish are not present in sufficient numbers, this amendment also provides more protection for senior water rights holders.
- 3. To clarify the prospective nature of new rules adopted by the Board of Environmental Review and allow existing applicants and permit holders the option of applying the new rules to their respective applications and operations.

Current law does not require certain types of water use to go through the water right permitting process, nor are they considered waste under Title 85, Chapter 2, MCA. However, and as I have proposed to amend this bill, for the first time the department will review these non-beneficial uses of water to ensure that they will not have an adverse impact on aquatic life.

I respectfully ask that you support my amendments.
