22	than \$1,000 or more than \$10,000 15% of the tax due for each month or fraction of a month during which the
23	person purposely or knowingly fails to file a return or report, but not to exceed 75% of the tax due as determined
24	by the department. The department may bring an action in the name of the state to recover the penalty and any
25	delinquent taxes.
26	(5) (a) A person who files a fraudulent return or report under Title 15 is liable for an additional penalty
27	of 75% of the tax due on the underpayment of tax attributable to the fraudulent amount reported on the return or
28	report. The department may bring an action in the name of the state to recover the penalty, interest, and any

A frivolous return or report is one that is filed by a person and that omits 6 information necessary to determine the taxpayer's tax liability, shows a substantially incorrect tax, is based on 7 a frivolous position, or is based on the taxpayer's action to impede collection of taxes. FRIVOLOUS POSITIONS ARE 8 THOSE IDENTIFIED UNDER 26 U.S.C. 6702 AS THOSE PROVISIONS MAY APPLY TO THE PROVISIONS OF TITLE 15. The 9 department may bring an action in the name of the state to recover the penalty, interest, and any delinguent 10 taxes. 11 (4)(7) (a) Except as provided in 15-30-2604(2)(c)(3)(c), interest on taxes not paid when due must be 12 assessed by the department. The department shall determine the interest rates rate established under subsection 13 (4)(a)(i) (7)(a)(i) for each calendar year by rule subject to the conditions of this subsection (4)(a) (7)(a). Interest 14 rates on taxes not paid when due for a calendar year are as follows: 15 (i) For individual income taxes not paid when due, including delinguent taxes and deficiency 16 assessments, the interest rate is equal to the underpayment rate for individual taxpayers established by the 17 secretary of the United States department of the treasury pursuant to section 6621 of the Internal Revenue Code, 18 26 U.S.C. 6621, for the fourth quarter of the preceding year or 8%, whichever is greater. 19 (ii) For all taxes other than individual income taxes not paid when due, including delinquent taxes and 20 deficiency assessments, the interest rate is 12% a year. 21 (b) Interest on delinquent taxes and on deficiency assessments is computed from the original due date 22 of the return until the tax is paid. (3) A shareholder of a DISC that is exempt from the corporation license tax under 15-31-102(1)(I) shall

include in the shareholder's adjusted gross income the earnings and profits of the DISC in the same manner as
 provided by section 995 of the Internal Revenue Code, 26 U.S.C. 995, for all periods for which the DISC election
 is effective.

4 (4) A taxpayer who, in determining federal adjusted gross income, has reduced the taxpayer's business
5 deductions by an amount for wages and salaries for which a federal tax credit was elected under sections 38 and
6 51(a) of the Internal Revenue Code, 26 U.S.C. 38 and 51(a), is allowed to deduct the amount of the wages and
7 salaries paid regardless of the credit taken. The deduction must be made in the year that the wages and salaries
8 were used to compute the credit. In the case of a partnership or small business corporation, the deduction must
9 be made to determine the amount of income or loss of the partnership or small business corporation.

10 (5) Married taxpayers filing a joint federal return who are required to include part of their social security 11 benefits or part of their tier 1 railroad retirement benefits in federal adjusted gross income may split the federal 12 base used in calculation of federal taxable social security benefits or federal taxable tier 1 railroad retirement 13 benefits when they file separate Montana income tax returns. The federal base must be split equally on the 14 Montana return.

(6) Married taxpayers filing a joint federal return who are allowed a capital loss deduction under section
1211 of the Internal Revenue Code, 26 U.S.C. 1211, and who file separate Montana income tax returns may
claim the same amount of the capital loss deduction that is allowed on the federal return. If the allowable capital
loss is clearly attributable to one spouse, the loss must be shown on that spouse's return; otherwise, the loss
must be split equally on each return.

(7) In the case of passive and rental income losses, married taxpayers filing a joint federal return and
who file separate Montana income tax returns are not required to recompute allowable passive losses according
to the federal passive activity rules for married taxpayers filing separately under section 469 of the Internal
Revenue Code, 26 U.S.C. 469. If the allowable passive loss is clearly attributable to one spouse, the loss must
be shown on that spouse's return; otherwise, the loss must be split equally on each return.

(8) Married taxpayers filing a joint federal return in which one or both of the taxpayers are allowed a
deduction for an individual retirement contribution under section 219 of the Internal Revenue Code, 26 U.S.C.
219, and who file separate Montana income tax returns may claim the same amount of the deduction that is
allowed on the federal return. The deduction must be attributed to the spouse who made the contribution.

(9) (a) Married taxpayers filing a joint federal return who are allowed a deduction for interest paid for a
 qualified education loan under section 221 of the Internal Revenue Code, 26 U.S.C. 221, and who file separate

Montana income tax returns may claim the same amount of the deduction that is allowed on the federal return.
 The deduction may be split equally on each return or in proportion to each taxpayer's share of federal adjusted
 gross income.

4 (b) Married taxpayers filing a joint federal return who are allowed a deduction for qualified tuition and 5 related expenses under section 222 of the Internal Revenue Code, 26 U.S.C. 222, and who file separate Montana 6 income tax returns may claim the same amount of the deduction that is allowed on the federal return. The 7 deduction may be split equally on each return or in proportion to each taxpayer's share of federal adjusted gross 8 income.

9 (10) A taxpayer receiving retirement disability benefits who has not attained 65 years of age by the end 10 of the tax year and who has retired as permanently and totally disabled may exclude from adjusted gross income 11 up to \$100 a week received as wages or payments in lieu of wages for a period during which the employee is 12 absent from work due to the disability. If the adjusted gross income before this exclusion exceeds \$15,000, the 13 excess reduces the exclusion by an equal amount. This limitation affects the amount of exclusion, but not the 14 taxpayer's eligibility for the exclusion. If eligible, married individuals shall apply the exclusion separately, but the 15 limitation for income exceeding \$15,000 is determined with respect to the spouses on their combined adjusted 16 gross income. For the purpose of this subsection, "permanently and totally disabled" means unable to engage 17 in any substantial gainful activity by reason of any medically determined physical or mental impairment lasting 18 or expected to last at least 12 months.

19 (11) An individual who contributes to one or more accounts established under the Montana family 20 education savings program may reduce adjusted gross income by the lesser of \$3,000 or the amount of the 21 contribution. In the case of married taxpayers, each spouse is entitled to a reduction, not in excess of \$3,000, for 22 the spouses' contributions to the accounts. Spouses may jointly elect to treat half of the total contributions made 23 by the spouses as being made by each spouse. The reduction in adjusted gross income under this subsection 24 applies only with respect to contributions to an account of which the account owner, as defined in 15-62-103, is 25 the taxpayer, the taxpayer's spouse, or the taxpayer's child or stepchild if the taxpayer's child or stepchild is a 26 Montana resident. The provisions of subsection (1)(e) do not apply with respect to withdrawals of contributions 27 that reduced adjusted gross income.

(12) (a) A taxpayer may exclude the amount of the loan payment received pursuant to subsection
(12)(a)(iv), not to exceed \$5,000, from the taxpayer's adjusted gross income if the taxpayer:

(i) is a health care professional licensed in Montana as provided in Title 37;

(ii) is serving a significant portion of a designated geographic area, special population, or facility
 population in a federally designated health professional shortage area, a medically underserved area or
 population, or a federal nursing shortage county as determined by the secretary of health and human services

5 (iii) has had a student loan incurred as a result of health-related education; and

6 (iv) has received a loan payment during the tax year made on the taxpayer's behalf by a loan repayment
7 program described in subsection (12)(b) as an incentive to practice in Montana.

8 (b) For the purposes of subsection (12)(a), a loan repayment program includes a federal, state, or 9 qualified private program. A qualified private loan repayment program includes a licensed health care facility, as 10 defined in 50-5-101, that makes student loan payments on behalf of the person who is employed by the facility 11 as a licensed health care professional.

(13) Notwithstanding the provisions of subsection (1), adjusted gross income does not include 40% of
 capital gains on the sale or exchange of capital assets before December 31, 1986, as capital gains are
 determined under subchapter P. of Chapter 1 of the Internal Revenue Code as it read on December 31, 1986.

15 (14) By November 1 of each year, the department shall multiply the amount of pension and annuity 16 income contained in subsection (2)(c)(i) and the federal adjusted gross income amounts in subsection (2)(c)(i)17 by the inflation factor for that tax year, but using the year 2009 consumer price index, and rounding the results 18 to the nearest \$10. The resulting amounts are effective for that tax year and must be used as the basis for the 19 exemption determined under subsection (2)(c).

20 (15) A refund received of federal income tax referred to in subsection (1)(b) must be allocated in the
 21 following order as applicable:

(a) to federal income tax in a prior tax year that was not deducted on the state tax return in that prior tax
 year;

24 (b) to federal income tax in a prior tax year that was deducted on the state tax return in that prior tax year

25 <u>but did not result in a reduction in state income tax liability in that prior tax year; and</u>

(c) to federal income tax in a prior tax year that was deducted on the state tax return in that prior tax year
 and that reduced the taxpayer's state income tax liability in that prior tax year. (Subsection (2)(f) terminates on
