9	file lawsuits without evidence or facts to justify the case; and
10	WHEREAS, the defendants in these lawsuits, who have sufficient financial resources, are forced to pay
11	thousands of dollars in court costs and legal fees before the case is dismissed or when the defendant prevails
12	in a jury or bench trial; and
13	WHEREAS, the district courts and the Montana supreme court do not always have the statutory authority
14	to allow prevailing parties to recover their attorney fees in these cases, including cases that are frivolous,
15	unreasonable, and without foundation.
