4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

6 **Section 1.** Section 2-15-1009, MCA, is amended to read:

7 **"2-15-1009. Public employees' retirement board -- terms -- allocation.** (1) There is a public
8 employees' retirement board.

9 (2) The board consists of ~~seven~~ eleven members appointed by the governor with the consent of the
10 senate. The members are:

11 (a) three public employees who are active members of a public retirement system. Not more than one
12 of these members may be an employee of the same department and at least one of these members must, no later
13 than July 1, 2003, be a member of the defined contribution plan created pursuant to Title 19, chapter 3, part 21.

14 (b) one retired public employee who is a member of the public employees' retirement system;

15 (c) two members ~~at large~~ who are active or retired public safety officers and, if possible, covered under
16 the defined contribution plan established in 19-3-2102; and

17 (d) one member who has experience in investment management, counseling, or financial planning or
18 who has other similar experience;

19 (e) two members who are teachers and, if possible, active members of the defined contribution plan
20 established in 19-3-2102;

21 (f) one member who is a retired teacher; and

22 (g) one member who is school board member.

23 (3) The term of office for each member is 5 years.

24 (4) (a) The board is allocated to the department for administrative purposes only as prescribed in
25 2-15-121.

26 (b) The board shall hire necessary employees as provided in 19-2-404.

27 (c) Consistent with its constitutional mandate to administer the retirement plans as a fiduciary of system
28 participants and their beneficiaries, the board shall appoint its own existing attorney in lieu of the person
29 appointed by the department, as provided for in 2-4-110, to have sole responsibility for the legal review of each
30 board rule proposal notice, adoption notice, or other notice related to administrative rulemaking.

1 (5) Members of the board must be compensated and receive travel expenses as provided for in
2 2-15-124."

4 **Section 2.** Section 5-5-227, MCA, is amended to read:

5 **"5-5-227. Revenue and transportation interim committee -- powers and duties -- revenue**
6 **estimating and use of estimates.** (1) The revenue and transportation interim committee has administrative rule
7 review, draft legislation review, program evaluation, and monitoring functions for the department of revenue and
8 the department of transportation and the entities attached to the departments for administrative purposes.

9 (2) (a) The committee must have prepared by December 1 for introduction during each regular session
10 of the legislature in which a revenue bill is under consideration an estimate of the amount of revenue projected
11 to be available for legislative appropriation.

12 (b) The committee may prepare for introduction during a special session of the legislature in which a
13 revenue bill or an appropriation bill is under consideration an estimate of the amount of projected revenue. The
14 revenue estimate is considered a subject specified in the call of a special session under 5-3-101.

15 (3) The committee's estimate, as introduced in the legislature, constitutes the legislature's current
16 revenue estimate until amended or until final adoption of the estimate by both houses. It is intended that the
17 legislature's estimates and the assumptions underlying the estimates will be used by all agencies with
18 responsibilities for estimating revenue or costs, including the preparation of fiscal notes.

19 (4) The committee shall develop and share information concerning the coal severance tax revenue
20 allocated to the public employee retirement systems pursuant 15-35-108 as requested by the legislative finance
21 committee for the purposes of 5-12-205(8).

22 ~~(4)~~(5) The legislative services division shall provide staff assistance to the committee. The committee
23 may request the assistance of the staffs of the office of the legislative fiscal analyst, the legislative auditor, the
24 department of revenue, and any other agency that has information regarding any of the tax or revenue bases of
25 the state."

27 **Section 3.** Section 5-5-228, MCA, is amended to read:

28 **"5-5-228. State administration and veterans' affairs interim committee.** (1) The state administration
29 and veterans' affairs interim committee has administrative rule review, draft legislation review, program
30 evaluation, and monitoring functions for the public employee retirement plans and for the following executive

1 branch agencies and, unless otherwise assigned by law, the entities attached to the agencies for administrative
2 purposes:

3 (a) department of administration, except:

4 (i) the state compensation insurance fund provided for in 39-71-2313, including the board of directors
5 of the state compensation insurance fund established in 2-15-1019; and

6 (ii) the office of state public defender;

7 (b) department of military affairs; and

8 (c) office of the secretary of state.

9 (2) The committee shall:

10 (a) consider the actuarial and fiscal soundness of the state's public employee retirement systems, based
11 on reports from the teachers' retirement board, the public employees' retirement board, and the board of
12 investments, and study and evaluate the equity and benefit structure of the state's public employee retirement
13 systems;

14 (b) establish principles of sound fiscal and public policy as guidelines;

15 (c) as necessary, develop legislation to keep the retirement systems consistent with sound policy
16 principles;

17 (d) solicit and review proposed statutory changes to any of the state's public employee retirement
18 systems;

19 (e) report to the legislature on each legislative proposal reviewed by the committee. The report must
20 include but is not limited to:

21 (i) a summary of the fiscal implications of the proposal;

22 (ii) an analysis of the effect that the proposal may have on other public employee retirement systems;

23 (iii) an analysis of the soundness of the proposal as a matter of public policy;

24 (iv) any amendments proposed by the committee; and

25 (v) the committee's recommendation on whether the proposal should be enacted by the legislature.

26 (f) attach the committee's report to any proposal that the committee considered and that is or has been
27 introduced as a bill during a legislative session; and

28 (g) publish, for legislators' use, information on the state's public employee retirement systems.

29 (3) The committee may:

30 (a) specify the date by which proposals affecting a retirement system must be submitted to the committee

1 for the review contemplated under subsection (2)(d); and

2 (b) request personnel from state agencies, including boards, political subdivisions, and the state public
3 employee retirement systems, to furnish any information and render any assistance that the committee may
4 request.

5 (4) The committee shall provide committee research and policy guidance on the retirement systems and
6 collaborate with the legislative finance committee for the purposes of 5-12-205(9)."

7

8 **Section 4.** Section 5-12-205, MCA, is amended to read:

9 **"5-12-205. Powers and duties of committee.** The committee:

10 (1) may organize, adopt rules to govern its proceedings, and meet as often as necessary, upon the call
11 of the presiding officer, to advise and consult with the legislative fiscal analyst;

12 (2) may employ and, in accordance with the rules for classification and pay adopted by the legislative
13 council, set the salary of the legislative fiscal analyst. The legislative fiscal analyst shall serve at the pleasure of
14 and be responsible for providing services to the committee.

15 (3) may exercise the investigatory powers of a standing committee under chapter 5, part 1, of this title;

16 (4) shall monitor the information technology policies of the department of administration with specific
17 attention to:

18 (a) identification of information technology issues likely to require future legislative attention; and

19 (b) the evaluation of proposed information technology policy changes and the fiscal implications of the
20 proposed changes and shall provide written responses to the department of administration communicating the
21 committee's positions and concerns on proposed policy changes;

22 (5) may accumulate, compile, analyze, and provide information relevant to existing or proposed
23 legislation on how information technology can be used to impact the welfare of the state;

24 (6) may prepare legislation to implement any proposed changes involving information technology; and

25 (7) shall, before each regular and special legislative session involving budgetary matters, prepare
26 recommendations to the house appropriations committee and the senate finance and claims committee on the
27 application of certain budget issues. At a minimum, the recommendations must include procedures for the
28 consistent application during each session of inflation factors, the allocation of fixed costs, and the personal
29 services budget. The committee may also make recommendations on other issues of major concern in the
30 budgeting process, such as estimating the cost of implementing particular programs based upon present law.

1 (8) shall examine the statutory appropriations to the public employee retirement systems under
 2 15-35-108 and [section 10] and recommend any legislation necessary to adjust the appropriation amounts to
 3 provide that the systems are 100% funded by July 1, 2043; and

4 (9) shall coordinate with and request appropriate information from the revenue and transportation interim
 5 committee concerning coal severance tax revenue, collaborate with the state administration and veterans' affairs
 6 interim committee, and request information from the retirement system administrative boards and the board of
 7 investments as appropriate to fulfill its duty under subsection (8)."

9 **Section 5.** Section 7-32-4132, MCA, is amended to read:

10 **"7-32-4132. Payment of partial salary amount of officer injured in performance of duty.** (1) A
 11 member of a municipal law enforcement agency of a municipality ~~contracting~~ who contracted for retirement
 12 coverage pursuant to 19-9-207 or [section 30] who is injured in the performance of the member's duties and who
 13 requires medical or other remedial treatment for injuries that render the member unable to perform the member's
 14 duties must be paid by the municipality the difference between the member's net salary, following adjustments
 15 for income taxes and pension contributions, and the amount received from workers' compensation until the
 16 disability has ceased, as determined by workers' compensation, or for a period not to exceed 1 year, whichever
 17 occurs first.

18 (2) To qualify for the partial salary payment provided for in subsection (1), the member of the law
 19 enforcement agency must be unable to perform the member's duties as a result of the injury."

4 (a) under option 2 or 3 provided for in 19-3-1501, one natural person designated to receive a continuing

6 (b) under option 4 provided for in 19-3-1501, a natural person, charitable organization, estate, or trust
7 that may receive a continuing monthly benefit after the death of a retired member.

8 (13) "Covered employment" means employment in a covered position.

9 (14) "Covered position" means a position in which the employee must be a member of the retirement
10 system except as otherwise provided by law.

14 (16) "Defined contribution retirement plan" or "defined contribution plan" means the retirement plan within

17 (17) "Department" means the department of administration.

18 (18) "Designated beneficiary" means the person, charitable organization, estate, or trust for the benefit
19 of a natural person designated by a member or payment recipient to receive any survivorship benefits, lump-sum
20 payments, or benefit from a retirement account upon the death of the member or payment recipient, including
21 annuities derived from the benefits or payments.

22 (19) "Direct rollover" means a payment by the plan to the eligible retirement plan specified by the
23 distributee.

24 (20) "Disability" or "disabled" means a total inability of the member to perform the member's duties by
25 reason of physical or mental incapacity. The disability must be incurred while the member is an active member

23 (24) "Eligible rollover distribution":

24 (a) means any distribution of all or any portion of the balance from a retirement plan to the credit of the
25 distributee, as provided in 19-2-1011;

26 (b) effective January 1, 2002, includes a distribution to a surviving spouse or to a spouse or former
27 spouse who is an alternate payee under a domestic relations order, as defined in section 414(p) of the Internal
28 Revenue Code, 26 U.S.C. 414(p).

29 (25) "Employee" means a person who is employed by an employer in any capacity and whose salary is
30 being paid by the employer or a person for whom an interlocal governmental entity is responsible for paying

1 retirement contributions pursuant to 7-11-105.

2 (26) "Employer" means a governmental agency participating in a retirement system enumerated in
3 19-2-302 on behalf of its eligible employees. The term includes an interlocal governmental entity identified as
4 responsible for paying retirement contributions pursuant to 7-11-105.

5 (27) "Essential elements of the position" means fundamental job duties. An element may be considered

7 (38) "Regular contributions" means contributions required from members under a retirement plan.

8 (39) "Regular interest" means interest at rates set from time to time by the board.

9 (40) "Retirement" or "retired" means the status of a member who has:

10 (a) terminated from service; and

11 (b) received and accepted a retirement benefit from a retirement plan.

12 (41) "Retirement account" means an individual account within the defined contribution retirement plan
13 for the deposit of employer and member contributions and other assets for the exclusive benefit of a member of
14 the defined contribution plan or the member's beneficiary.

15 (42) "Retirement benefit" means:

16 (a) in the case of a defined benefit plan, the periodic benefit payable as a result of service retirement,

24 (45) "Service" means employment of an employee in a position covered by a retirement system.

25 (46) "Service credit" means the periods of time for which the required contributions have been made to
26 a retirement plan and that are used to calculate retirement benefits or survivorship benefits under a defined
27 benefit retirement plan.

28 (47) "Service retirement benefit" means the retirement benefit that the member may receive at normal
29 retirement age.

30 (48) "Statutory beneficiary" means the surviving spouse or dependent child or children of a member of

1 the highway patrol officers', municipal police officers', or firefighters' unified retirement system who are statutorily
2 designated to receive benefits upon the death of the member.

3 (49) "Supplemental cost" means an element of the total actuarial cost of a defined benefit retirement plan

8 (50) "Survivorship benefit" means payments for life to the statutory or designated beneficiary of a
9 deceased member who died while in service under a defined benefit retirement plan.

10 (51) "Termination of employment", "termination from employment", "terminated employment", "terminated
11 from employment", "terminate employment", or "terminates employment" means that:

12 (a) there has been a complete severance of a covered employment relationship by the positive act of
13 either the employee, the employer, or both; and

14 (b) the member is no longer receiving compensation for covered employment, other than any outstanding
15 lump-sum payment for compensatory leave, sick leave, or annual leave.

16 (52) "Termination of service", "termination from service", "terminated from service", "terminated service",
17 "terminating service", or "terminates service" means that:

18 (a) there has been a complete severance of a covered employment relationship by the positive act of
19 either the employee, the employer, or both for at least 30 days;

20 (b) no written or verbal agreement exists between employee and employer that the employee will return
21 to covered employment in the future;

22 (c) the member is no longer receiving compensation for covered employment; and

23 (d) the member has been paid all compensation for compensatory leave, sick leave, or annual leave to
24 which the member was entitled. For the purposes of this subsection (52), compensation does not mean

26 (53) "Unfunded actuarial liabilities" or "unfunded liabilities" means the excess of a defined benefit
27 retirement plan's actuarial liabilities at any given point in time over the value of its cash and investments on that

29 (54) "Vested account" means an individual account within a defined contribution plan that is for the
30 exclusive benefit of a member or the member's beneficiary. A vested account includes all contributions and the

1 income on all contributions in each of the following accounts:

2 (a) the member's contribution account;

3 (b) the vested portion of the employer's contribution account; and

4 (c) the member's account for other contributions.

5 (55) "Vested member" or "vested" means:

6 (a) with respect to a defined benefit plan, a member or the status of a member who has at least 5 years
7 of membership service; or

8 (b) with respect to the defined contribution plan, a member or the status of a member who meets the
9 minimum membership service requirement of 19-3-2116.

10 (56) "Written application" or "written election" means a written instrument, prescribed by the board or
11 required by law, properly signed and filed with the board, that contains all required information, including
12 documentation that the board considers necessary.

7 (2) (a) The district or the cooperative shall pay the employer's contributions to the retirement, federal
8 social security, and unemployment insurance systems from the retirement fund for the following:

9 (i) a district employee whose salary and health-related benefits, if any health-related benefits are
10 provided to the employee, are paid from state or local funding sources;

11 (ii) a cooperative employee whose salary and health-related benefits, if any health-related benefits are
12 provided to the employee, are paid from the cooperative's interlocal cooperative fund if the fund is supported
13 solely from districts' general funds and state special education allowable cost payments, pursuant to 20-9-321,
14 or are paid from the miscellaneous programs fund, provided for in 20-9-507, from money received from the
15 medicaid program, pursuant to 53-6-101;

16 (iii) a district employee whose salary and health-related benefits, if any health-related benefits are
17 provided to the employee, are paid from the district's school food services fund provided for in 20-10-204; and

18 (iv) a district employee whose salary and health-related benefits, if any health-related benefits are
19 provided to the employee, are paid from the district impact aid fund, pursuant to 20-9-514.

20 (b) For an employee whose benefits are not paid from the retirement fund, the district or the cooperative
21 shall pay the employer's contributions to the retirement, federal social security, and unemployment insurance
22 systems from the funding source that pays the employee's salary.

23 (3) The trustees of a district required to make a contribution to a system referred to in subsection (1) shall
24 include in the retirement fund of the final budget the estimated amount of the employer's contribution. After the
25 final retirement fund budget has been adopted, the trustees shall pay the employer contributions to the systems
26 in accordance with the financial administration provisions of this title.

27 (4) When the final retirement fund budget has been adopted, the county superintendent shall establish
28 the levy requirement by:

29 (a) determining the sum of the money available to reduce the retirement fund levy requirement by adding:

- 6 year by the trustees from the end-of-the-year fund balance in the retirement fund. The retirement fund operating
- 7 reserve may not be more than 35% of the final retirement fund budget for the ensuing school fiscal year and must
- 8 be used for the purpose of paying retirement fund warrants issued by the district under the final retirement fund
- 9 budget.
- 10 (v) property tax reimbursements made pursuant to 15-1-123(6);
- 11 (vi) any other revenue anticipated that may be realized in the retirement fund during the ensuing school
- 12 fiscal year, excluding any guaranteed tax base aid;
- 13 (b) notwithstanding the provisions of subsection (9), subtracting the money available for reduction of the
- 14 levy requirement, as determined in subsection (4)(a), from the budgeted amount for expenditures in the final
- 15 retirement fund budget.
- 16 (5) The county superintendent shall:
- 17 (a) total the net retirement fund levy requirements separately for all elementary school districts, all high
- 18 school districts, and all community college districts of the county, including any prorated joint district or special
- 19 education cooperative agreement levy requirements; and
- 20 (b) report each levy requirement to the county commissioners by the later of the first Tuesday in
- 21 September or within 30 calendar days after receiving certified taxable values as the respective county levy
- 22 requirements for elementary district, high school district, and community college district retirement funds.
- 23 (6) The county commissioners shall fix and set the county levy or district levy in accordance with
- 24 20-9-142.
- 25 (7) The net retirement fund levy requirement for a joint elementary district or a joint high school district
- 26 must be prorated to each county in which a part of the district is located in the same proportion as the district ANB
- 27 of the joint district is distributed by pupil residence in each county. The county superintendents of the counties
- 28 affected shall jointly determine the net retirement fund levy requirement for each county as provided in 20-9-151.
- 29 (8) The net retirement fund levy requirement for districts that are members of special education
- 30 cooperative agreements must be prorated to each county in which the district is located in the same proportion

1 as the special education cooperative budget is prorated to the member school districts. The county
2 superintendents of the counties affected shall jointly determine the net retirement fund levy requirement for each
3 county in the same manner as provided in 20-9-151, and the county commissioners shall fix and levy the net
4 retirement fund levy for each county in the same manner as provided in 20-9-152.

5 (9) The county superintendent shall calculate the number of mills to be levied on the taxable property
6 in the county to finance the retirement fund net levy requirement by dividing the amount determined in subsection
7 (5)(a) by the sum of:

8 (a) the amount of guaranteed tax base aid that the county will receive for each mill levied, as certified
9 by the superintendent of public instruction; and

10 (b) the taxable valuation of the district divided by 1,000.

11 (10) The levy for a community college district may be applied only to property within the district.

12 (11) The county superintendent of each county shall submit a report of the revenue amounts used to
13 establish the levy requirements for county school funds supporting elementary and high school district retirement
14 obligations to the superintendent of public instruction on or before September 15. The report must be completed
15 on forms supplied by the superintendent of public instruction."

17 **Section 83.** Section 25-13-608, MCA, is amended to read:

18 **"25-13-608. Property exempt without limitation -- exceptions.** (1) A judgment debtor is entitled to
19 exemption from execution of the following:

20 (a) professionally prescribed health aids for the judgment debtor or a dependent of the judgment debtor;

21 (b) benefits the judgment debtor has received or is entitled to receive under federal social security or
22 local public assistance legislation, except as provided in subsection (2);

23 (c) veterans' benefits, except as provided in subsection (2);

24 (d) disability or illness benefits, except as provided in subsection (2);

25 (e) except as provided in subsection (2), individual retirement accounts, as defined in 26 U.S.C. 408(a),
26 to the extent of deductible contributions made before the suit resulting in judgment was filed and the earnings on
27 those contributions, and Roth individual retirement accounts, as defined in 26 U.S.C. 408A, to the extent of
28 qualified contributions made before the suit resulting in judgment was filed and the earnings on those
29 contributions;

30 (f) benefits paid or payable for medical, surgical, or hospital care to the extent they are used or will be

- 1 used to pay for the care;
- 2 (g) maintenance and child support;
- 3 (h) a burial plot for the judgment debtor and the debtor's family;
- 4 (i) benefits or payments paid or payable from a retirement system or plan within Title 19, chapters 3, 5
5 through 9, ~~and 13, and [sections 27, 30, 32, 33, 39 through 45, and 48]~~, as provided by 19-2-1004;
- 6 (j) benefits or payments paid or payable from a retirement system or plan within Title 19, chapter 20, as
7 provided by 19-20-706; and
- 8 (k) the judgment debtor's interest in any unmaturred life insurance contracts owned by the judgment
9 debtor.
- 10 (2) Veterans' and social security legislation benefits based upon remuneration for employment, disability
11 benefits, and assets of individual retirement accounts are not exempt from execution if the debt for which
12 execution is levied is for:
- 13 (a) child support; or
- 14 (b) maintenance to be paid to a spouse or former spouse."

16 **Section 84.** Section 44-1-518, MCA, is amended to read:

17 **"44-1-518. Contribution for retirement -- length of service credit -- transfer of retirement**
18 **contributions.** (1) When an officer receives compensation under 44-1-511, the officer's contribution for retirement
19 under 19-6-402 or [section 33] must be paid on the compensation received under 44-1-511 and the state's
20 contribution for retirement under 19-6-404 must be paid on the compensation received under 44-1-511.

21 (2) The time for which contributions are paid under 44-1-511 must be credited to the length of service
22 computed for retirement purposes under 19-2-701.

23 (3) When a disabled officer who qualifies for benefits under 44-1-511 accepts a transfer under 44-1-515
24 to a nonhighway patrol position within the department of justice that is covered under the Public Employees'
25 Retirement System Act, all or any portion of the officer's length of service credited with the highway patrol officers'
26 retirement system must be transferred to the public employees' retirement system according to 19-2-715."

7 NEW SECTION. **Section 90. Effective dates.** (1) Except as provided in subsection (2), [this act] is
8 effective July 1, 2013.
