4 A BILL FOR AN ACT ENTITLED: "AN ACT REVISING CERTAIN HUNTING LICENSE APPLICATION FEES;
5 ALLOWING PER SPECIES COLLECTION OF THE PREFERENCE SYSTEM APPLICATION FEE; AMENDING
6 SECTIONS 87-2-113 AND 87-2-730, MCA; AND PROVIDING A DELAYED EFFECTIVE DATE."

8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

10 **Section 1.** Section 87-2-113, MCA, is amended to read:

11 **"87-2-113. ~~Drawing and application~~ Application fees.** (1) ~~(a) When~~ Except as provided in subsection
12 (1)(b), when the department determines a drawing is necessary prior to issuance of hunting licenses for any game
13 species during a hunting season, it shall collect a \$5 per species drawing application fee ~~with each application~~
14 ~~submitted.~~

15 (b) The department shall collect the following per species special license application fees:

- 16 (i) moose--resident, \$10; nonresident, \$50;
17 (ii) mountain goat--resident, \$10; nonresident, \$50;
18 (iii) mountain sheep--resident, \$10; nonresident, \$50;
19 (iv) wild buffalo or bison--resident, \$10; nonresident, \$50.

20 (2) (a) If a resident participates in a preference system adopted by the commission, the department shall
21 collect an additional application fee of \$2 ~~for each application form~~ per species to fund the administration of the
22 preference system.

23 (b) If a nonresident participates in a preference system adopted by the commission, the department shall
24 collect an additional application fee of \$20 ~~for each application form~~ per species to fund the administration of the
25 preference system.

26 (3) ~~Drawing Application~~ Application fees collected pursuant to this section must be deposited in the state special
27 revenue fund to the credit of the department as set forth in 87-1-601.

28 (4) The payment of ~~a drawing~~ an application fee confers no hunting rights or privileges.

29 (5) The commission may waive the provisions of subsection (1) when a drawing is required for a special
30 season under 87-1-304."

2 **Section 2.** Section 87-2-730, MCA, is amended to read:
3 **"87-2-730. Special wild buffalo license -- regulation.** (1) The public hunting of wild buffalo or bison
4 that have been designated as a species in need of disease control under 81-2-120 is permitted only when
5 authorized by the department of livestock under the provisions set forth in 81-2-120.

6 (2) The department may issue special licenses to hunt wild buffalo or bison designated as a species in
7 need of disease control when authorized by the department of livestock.

8 (3) The department shall adopt rules in cooperation with the department of livestock. The rules must
9 provide for:

- 10 (a) license drawing procedures;
- 11 (b) ~~drawing and~~ application fees consistent with 87-2-113;
- 12 (c) notification of license recipients as to when and where they may hunt, but notification may not include
13 information regarding the actual physical location of a wild buffalo or bison other than the prescribed hunting
14 district where the animal may be taken;
- 15 (d) fair chase hunting of wild buffalo or bison, including requirements that hunting be conducted on foot
16 and away from public roads and that there be no designation of specific wild buffalo or bison to be hunted;
- 17 (e) means of taking and handling of carcasses in the field, which must include provisions for public safety
18 because of the potential for the spread of infectious disease;
- 19 (f) the use of bows and arrows and other hunting arms;
- 20 (g) tagging requirements for carcasses, skulls, and hides;
- 21 (h) possession limits;
- 22 (i) requirements for transportation and exportation; and
- 23 (j) requirements and criteria for authorization by the state veterinarian and the department of livestock
24 of any public hunting."

26 NEW SECTION. **Section 3. Effective date.** [This act] is effective March 1, 2014.
