9	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

11	Section 1. Section 16-4-115, MCA, is amended to read:
12	"16-4-115. Beer and wine licenses for off-premises consumption. (1) A retail license to sell beer
13	or table wine, or both, in the original packages for off-premises consumption may be issued only to a person, firm,
14	or corporation that is approved by the department as a person, firm, or corporation qualified to sell beer or table
15	wine, or both., and whose premises proposed for licensing are operated as a bona fide grocery store or a
16	drugstore licensed as a pharmacy have received approval from local building, health, or fire officials AND IF IF THE
17	PREMISES PROPOSED FOR LICENSING ARE OPERATED IN CONJUNCTION WITH ANOTHER BUSINESS, THAT BUSINESS MUST
18	BE A GROCERY STORE OR DRUGSTORE LICENSED AS A PHARMACY. The number of licenses that the department may
19	issue is not limited by the provisions of 16-4-105 but must be determined by the department in the exercise of
20	its sound discretion, and the department may in the exercise of its sound discretion grant or deny an application
21	for any license or suspend or revoke any license for cause.
22	(2) Upon receipt of a completed application for a license under this section, accompanied by the
23	necessary license fee as provided in 16-4-501, the department shall request that the department of justice make
24	a background investigation of all matters relating to the application.
25	(3) Based on the results of the investigation or in exercising its sound discretion as provided in
26	subsection (1), the department shall determine whether:
27	(a) the applicant is qualified to receive a license;
28	(b) the applicant's premises are suitable for the carrying on of the business; and
29	(c) the requirements of this code and the rules promulgated by the department are met and complied
30	with.

1 (4) License applications submitted under this section are not subject to the provisions of 16-4-203 and 2 16-4-207.

(5) If the premises proposed for licensing under this section are a new or remodeled structure, the department may issue a conditional license prior to completion of the premises upon reasonable evidence that the premises will be suitable for the carrying on of business as a bona fide grocery store or a drugstore licensed as a pharmacy."
