7	DISCHARGED; AND AMENDING SECTION 39-2-905, MCA."

9	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

11	Section 1. Section 39-2-905, MCA, is amended to read:
12	"39-2-905. Remedies. (1) (a) If an employer has committed a wrongful discharge, the employee may
13	be awarded lost wages and fringe benefits for a period not to exceed 4 years from in an amount equal to 6
14	months of employment for every full year of employment completed by the employee prior to FOR A PERIOD NOT
15	$ ext{TO EXCEED 2 YEARS FROM}$ IN AN AMOUNT EQUAL UP TO ONE-HALF OF THE PERIOD OF TIME THE EMPLOYEE WAS EMPLOYED
16	PRIOR TO the date of discharge, together with interest on the lost wages and fringe benefits.
17	(b) The total amount awarded in subsection (1)(a) may not exceed the equivalent of 24 months of
18	employment.
19	(B) THE TOTAL AMOUNT AWARDED IN SUBSECTION (1)(A) MAY NOT EXCEED THE EQUIVALENT OF 48 MONTHS OF
20	EMPLOYMENT.
21	(e)(B)(C) Interim earnings and unemployment benefits, including amounts the employee could have
22	earned with reasonable diligence, must be deducted from the amount awarded for lost wages. Before interim
23	earnings are deducted from lost wages, there must be deducted from the interim earnings any reasonable
24	amounts expended by the employee in searching for, obtaining, or relocating to new employment.
25	(2) The employee may recover punitive damages otherwise allowed by law if it is established by clear
26	and convincing evidence that the employer engaged in actual fraud or actual malice in the discharge of the
27	employee in violation of 39-2-904(1)(a).
28	(3) There is no right under any legal theory to damages for wrongful discharge under this part for pain
29	and suffering, emotional distress, compensatory damages, punitive damages, or any other form of damages,
30	except as provided for in subsections (1) and (2)."
