15	NEW SECTION. Section 3. Licensure of vendors rulemaking. (1) A vendor must hold a limited lines
16	insurance producer license to sell or offer coverage under a policy of portable electronics insurance.
17	(2) A license issued under [sections 1 through 9] authorizes any employee or authorized representative
18	of the vendor to sell or offer coverage under a policy of portable electronics insurance to a customer at each
19	location at which the vendor engages in portable electronics transactions.
20	(3) The supervising entity shall maintain a registry of vendor locations that are authorized to sell or solicit
21	portable electronics insurance coverage in this state. Upon request by the commissioner and with 10 days' notice
22	to the supervising entity, the registry must be open to inspection and examination by the commissioner during
23	regular business hours of the supervising entity.
24	(4) A license issued under [sections 1 through 9] authorizes the licensee and its employees or authorized
25	representatives to engage in those activities that are permitted in [sections 1 through 9].
26	(5) The commissioner may adopt rules to implement the provisions of [sections 1 through 9].
27	
28	NEW SECTION. Section 4. Requirements for sale of portable electronics insurance. (1) At each
29	location where portable electronics insurance is offered to customers, brochures or other written materials must
30	be made available to a prospective customer that:

1 (a) disclose that portable electronics insurance may provide a duplication of coverage already provided 2 by a customer's homeowner's insurance policy, renter's insurance policy, or other source of coverage; 3 (b) state that the enrollment by the customer in a portable electronics insurance program is not required 4 in order to purchase or lease portable electronics or services; 5 (c) summarize the material terms of the insurance coverage, including: 6 (i) the identity of the insurer; 7 (ii) the identity of the supervising entity; 8 (iii) the amount of any applicable deductible and how it is to be paid; 9 (iv) benefits of the coverage; and 10 (v) key terms and conditions of coverage such as whether portable electronics may be repaired or 11 replaced with similar make and model reconditioned or nonoriginal manufacturer parts or equipment; 12 (d) summarize the process for filing a claim, including a description of how to return portable electronics 13 and the maximum fee applicable in the event that the customer fails to comply with any equipment return 14 requirements; and 15 (e) state that an enrolled customer may cancel enrollment for coverage under a portable electronics 16 insurance policy at any time and that the person paying the premium shall receive a refund of any applicable 17 unearned premium. 18 (2) The written materials required by this section are not subject to filing with or approval by the 19 commissioner. 20 (3) Portable electronics insurance may be offered on a month-to-month or other periodic basis as a 21 group or master commercial inland marine policy, subject to 33-1-221 through 33-1-229, issued to a vendor of 22 portable electronics for its enrolled customers. 23 (4) Eligibility and underwriting standards for customers electing to enroll in coverage must be established 24 by the supervising entity for each portable electronics insurance program. 25 26 NEW SECTION. Section 5. Authority of vendors of portable electronics. (1) An employee or 27 authorized representative of a vendor may sell or offer portable electronics insurance to a customer and is not 28 subject to licensure as an insurance producer under this title provided that: 29 (a) the vendor obtains a limited lines insurance producer license to authorize its employees or authorized 30 representatives to sell or offer portable electronics insurance;

(b) the insurer issuing the portable electronics insurance either directly supervises or appoints a
 supervising entity to supervise the administration of the program, including development of a training program
 for employees and authorized representatives of the vendors. The training required by this subsection (1)(b) must
 comply with the following:

5 (i) the training must be delivered to employees and authorized representatives of a vendor who is directly
6 engaged in the activity of selling or offering portable electronics insurance;

(ii) the training may be provided in electronic form. If the training is conducted in an electronic form, the
supervising entity shall implement a supplemental education program regarding the portable electronics insurance
product that is conducted and overseen by licensed insurance producers or adjusters employed by the
supervising entity; and

(iii) each employee and authorized representative individually must receive basic instruction about the
 portable electronics insurance offered to customers and the disclosures required under [section 4].

(c) employees or authorized representatives of a vendor of portable electronics may not advertise,
 represent, or otherwise represent to the public that they are nonlimited lines licensed insurance producers.

(2) Employees or authorized representatives of a vendor of portable electronics may not be
 compensated based primarily on the number of customers enrolled for portable electronics insurance coverage
 but may receive compensation for activities under the limited lines insurance producer license that is incidental
 to their overall compensation.

(3) (a) The charges for portable electronics insurance coverage may be billed and collected by the
vendor of portable electronics. Any charge to the enrolled customer for coverage that is not included in the cost
associated with the purchase or lease of portable electronics or related services must be separately itemized on
the enrolled customer's bill.

(b) If the portable electronics insurance coverage is included with the purchase or lease of portable
 electronics or related services, the vendor shall clearly and conspicuously disclose to the enrolled customer that
 the portable electronics insurance coverage is included with the portable electronics or related services.

(c) Vendors that are billing and collecting the charges are not required to maintain the funds in a segregated account if the vendor is authorized by the insurer to hold the funds in an alternative manner and remits the amounts to the supervising entity within 60 days of receipt. All funds received by a vendor from an enrolled customer for the sale of portable electronics insurance are considered funds held in trust by the vendor in a fiduciary capacity for the benefit of the insurer. Vendors may receive compensation for billing and collection

- 3 NEW SECTION. Section 6. Application for vendor license -- fees. (1) An applicant for a license under 4 [sections 1 through 9] shall file with the commissioner an application on forms prescribed by the commissioner.
  - (2) The application must:

6 (a) provide the name, residence address, and other information required by the commissioner for an 7 employee or officer of the vendor that is designated by the applicant as the person responsible for the vendor's 8 compliance with the requirements of [sections 1 through 9], and if the vendor derives more than 50% of its 9 revenue from the sale of portable electronics insurance, the information required by this subsection (2)(a) must 10 be provided for all officers, directors, and shareholders of record having beneficial ownership of 10% or more of 11 any class of securities registered under federal securities law; and

(b) the location of the applicant's home office.

13 (3) Any vendor engaging in portable electronics insurance transactions on or before [the effective date

14 of this act] shall apply for licensure within 90 days of the application being made available by the commissioner.

15 Any applicant commencing operations after [the effective date of this act] shall obtain a license prior to offering

16 portable electronics insurance.

17 (4) Initial licenses issued under [sections 1 through 9] are valid for a period of 24 months.

18 (5) Each vendor of portable electronics licensed under [sections 1 through 9] shall pay to the 19 commissioner a fee determined by the commissioner as follows:

20 (a) for a vendor that is engaged in portable electronics transactions at 10 or fewer locations in the state,

21 the fee may not exceed \$100 for an initial license or for each renewal; and

22 (b) for a vendor that is engaged in portable electronics transaction at more than 10 locations in the state,

23 the fee may not exceed \$1,000 for an initial license or \$500 for each renewal.

25 NEW SECTION. Section 7. Suspension or revocation of vendor license. If a vendor of portable 26 electronics or its employee or authorized representative violates any provision of [sections 1 through 9], the 27 commissioner may do any of the following after notice and the opportunity for a hearing:

(1) impose fines not to exceed \$500 for each violation or \$5,000 in the aggregate for violations;

29 (2) impose other penalties that the commissioner considers reasonable to carry out the purpose of 30 [sections 1 through 9], including:



1 (a) suspending the privilege of transacting portable electronics insurance under [sections 1 through 9], 2 at specific business locations where violations have occurred; or 3 (b) suspending or revoking the ability of individual employees or authorized representatives to act under 4 the license. 5 6 NEW SECTION. Section 8. Termination of portable electronics insurance. (1) Except as provided 7 in subsections (3) and (4) THROUGH (5), an insurer may terminate or otherwise change the terms and conditions 8 of a policy of portable electronics insurance upon providing the vendor policyholder and enrolled customers with 9 at least 30 days' notice. 10 (2) If the insurer changes the terms and conditions of a policy of portable electronics insurance, the 11 insurer shall provide the vendor policyholder with a revised policy or endorsement and each enrolled customer 12 with a revised certificate, endorsement, updated brochure, or other evidence indicating that a change in the terms 13 and conditions has occurred and a summary of material changes. 14 (3) An insurer may terminate an enrolled customer's enrollment under a portable electronics insurance 15 policy upon 15 days' notice for discovery of fraud or material misrepresentation in obtaining coverage or in the 16 presentation of a claim under the coverage. 17 (4) AN INSURER MAY TERMINATE AN ENROLLED CUSTOMER'S ENROLLMENT UNDER A PORTABLE ELECTRONICS 18 INSURANCE POLICY FOR NONPAYMENT OF PREMIUM WITH AT LEAST 10 DAYS' NOTICE. 19 (4)(5) An insurer may immediately terminate an enrolled customer's enrollment under a portable 20 electronics insurance policy without prior notice: 21 (a) for nonpayment of premium; 22 (b)(A) if the enrolled customer ceases to have an active service agreement with the vendor of portable 23 electronics; or 24 (c)(B) if an enrolled customer exhausts the aggregate limit of liability, if any, under the terms of the 25 portable electronics insurance policy and the insurer sends notice of termination to the enrolled customer within 26 30 calendar days after exhaustion of the limit. If the notice of exhaustion is not timely sent, the customer's 27 enrollment must continue regardless of the aggregate limit of liability until the insurer sends notice of termination 28 to the enrolled customer. 29 (5)(6) When a portable electronics insurance policy is terminated by a vendor policyholder, the vendor 30 policyholder shall mail or deliver written notice to each enrolled customer advising the enrolled customer of the

termination of the policy and the effective date of termination. The written notice must be mailed or delivered to
 the enrolled customer at least 30 days prior to the termination.

3 (6)(7) Any notice or correspondence with respect to a policy of portable electronics insurance required 4 by this section or other applicable law must be in writing and sent within the required notice period. Notices and 5 correspondence may be sent either by mail or by electronic means as set forth in this subsection. If the notice or correspondence is mailed, it must be sent to the vendor of portable electronics at the vendor's mailing address 6 7 specified for the purpose and to an affected enrolled customer's last-known mailing address on file with the 8 insurer. The insurer or vendor of portable electronics shall maintain proof of mailing in a form authorized or 9 accepted by the United States postal service or other commercial mail delivery service. If the notice or 10 correspondence is sent by electronic means, it must be sent to the vendor of portable electronics at the vendor's 11 electronic mail address specified for the purpose and to an affected enrolled customer's last-known electronic 12 mail address as provided by each enrolled customer to the insurer or vendor of portable electronics. For 13 purposes of this subsection, an enrolled customer's provision of an electronic mail address to the insurer or 14 vendor of portable electronics is considered to be consent to receive notices and correspondence by electronic 15 means. The insurer or vendor of portable electronics shall maintain proof that the notice or correspondence was 16 sent.

17 (7)(8) Notices or correspondence required by [sections 1 through 9] or otherwise required by law may
 18 be sent on behalf of an insurer or vendor by the supervising entity appointed by the insurer.

20 <u>NEW SECTION.</u> Section 9. Portable electronics insurance claims. (1) An individual who collects 21 claim information from or furnishes claim information to insureds or claimants and who conducts data entry, 22 including entering data into an automated claims adjudication system, is exempt from licensure under this title 23 if no more than 25 of these individuals are under the supervision of one licensed independent adjuster or licensed 24 insurance producer who is exempt from licensure pursuant to 33-17-102(1)(b)(iii).

(2) For purposes of portable electronics insurance claims, residents of Canada may not be licensed as
 nonresident adjusters unless they have obtained a resident license in another state or designated another state
 as their home state.

(3) For purposes of this section, "automated claims adjudication system" means a preprogrammed
 computer system designed for the collection, data entry, calculation, and final resolution of portable electronics
 insurance claims that:

The 24 licensee shall renew the license by the biennial renewal date and pay the appropriate fee or the license will lapse. 25 The biennial fee is established pursuant to 33-2-708. 26 (6)(7) The commissioner may adopt rules providing for the examination, licensure, bonding, and 27 regulation of public adjusters." 28 29 NEW SECTION.
