4 A BILL FOR AN ACT ENTITLED: "AN ACT GENERALLY REVISING TAXATION OF INCOME, INCLUDING THE  
5 CORPORATE LICENSE TAX; REQUIRING THE TAXATION OF INDIVIDUALS, PARTNERSHIPS, AND  
6 SUBCHAPTER S. CORPORATIONS, INCLUDING TRUSTS AND ESTATES, TO RELATE THE STATE  
7 INDIVIDUAL INCOME TAX TO FEDERAL TAXABLE INCOME; PROVIDING ADJUSTMENTS TO FEDERAL  
8 TAXABLE INCOME TO INCLUDE CERTAIN INCOME; PROVIDING ADJUSTMENTS TO FEDERAL TAXABLE  
9 INCOME TO EXCLUDE CERTAIN INCOME; ELIMINATING MOST INDIVIDUAL INCOME TAX DEDUCTIONS;

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

7

8 **NEW SECTION. Section 1. Adjustments to federal taxable income to determine Montana taxable**

9 **income.** (1) The items in subsection (2) are added to and the items in subsection (3) are subtracted from federal  
 10 taxable income to determine Montana taxable income.

11 (2) The following are added to federal taxable income:

12 (a) to the extent that it is not exempt from taxation by Montana under federal law, interest from  
 13 obligations of a territory or another state or any political subdivision of a territory or another state and  
 14 exempt-interest dividends attributable to that interest except to the extent already included in federal taxable  
 15 income;

16 (b) a withdrawal from a medical care savings account provided for in Title 15, chapter 61, used for a  
 17 purpose other than an eligible medical expense or long-term care of the employee or account holder or a  
 18 dependent of the employee or account holder;

19 (c) a nonqualified withdrawal from a family education savings account provided for in Title 15, chapter  
 20 62, to the extent that it was deducted from income in calculating Montana individual income taxes;

21 (d) a withdrawal from a first-time home buyer savings account provided for in Title 15, chapter 63, used  
 22 for a purpose other than for eligible costs for the purchase of a single-family residence;

23 (e) an item of income, deduction, or expense to the extent that it was used to calculate federal taxable  
 24 income if the item was also used to calculate a credit against a Montana income tax liability; and

25 (f) a deduction or expense upon which a state tax credit is computed under 33-22-2006 to the extent  
 26 included as a deduction or expense in determining federal taxable income.

27 (3) To the extent included as income or gain or not already excluded as a deduction or expense in  
 28 determining federal taxable income, the following are subtracted from federal taxable income:

29 (a) if exempt from taxation by Montana under federal law:

30 (i) interest from obligations of the United States government and exempt-interest dividends attributable

1 to that interest;

2 (ii) railroad retirement benefits;

3 (iii) tribal source income;

4 (b) salary received from the armed forces by residents who entered into active duty from Montana and  
5 are serving on active duty in the regular armed forces;

6 (c) interest and other income related to contributions that were made prior to January 1, 2014, that are  
7 retained in a medical care savings account provided for in Title 15, chapter 61, and any withdrawal for payment  
8 of eligible medical expenses or for the long-term care of the employee or account holder or a dependent of the  
9 employee or account holder;

10 (d) interest and other income related to contributions that were made prior to January 1, 2014, that are  
11 retained in a family education savings account provided for in Title 15, chapter 62, and any qualified withdrawal  
12 for payment of qualified higher education expenses; and

13 (e) interest and other income related to contributions that were made prior to January 1, 2014, that are  
14 retained in a first-time home buyer savings account provided for in Title 15, chapter 63, and any withdrawal for  
15 payment of eligible costs for the first-time purchase of a single-family residence.

17 **Section 2.** Section 2-18-1312, MCA, is amended to read:

18 **"2-18-1312. Tax exemption.** Employer contributions into an account, the accumulation of interest or  
19 other earnings in an account, and payments from an account for qualified health care expenses are tax-exempt;  
20 as provided in ~~15-30-2110~~ and under applicable federal laws and regulations to the extent that the plan is  
21 qualified under applicable sections of the Internal Revenue Code."

22

23 **Section 3.** Section 7-14-1133, MCA, is amended to read:

24 **"7-14-1133. Bonds and obligations.** (1) Except for providing financial support to a private development  
25 organization, including a corporation organized under Title 32, chapter 4, whose purpose is to advance the  
26 economic development of its jurisdiction and of the state and its citizens, an authority may borrow money for any  
27 of its corporate purposes and issue bonds, including refunding bonds, for any of its corporate purposes. The  
28 bonds may be in the form and upon terms as it determines, payable out of any revenue of the authority, including  
29 revenue derived from:

30 (a) any port or transportation and storage facility;

- 1 (b) taxes levied pursuant to 7-14-1131 or 67-10-402;
- 2 (c) grants or contributions from the federal government; or
- 3 (d) other sources.
- 4 (2) The bonds may be issued by resolution of the authority, without an election and without any limitation
- 5 of amount, except that bonds may not be issued at any time if the total amount of principal and interest to become
- 6 due in any year on the bonds and on any ~~then-outstanding~~ then-outstanding bonds for which revenue from the
- 7 same source is pledged exceeds the amount of revenue to be received in that year, as estimated in the resolution
- 8 authorizing the issuance of the bonds. The authority shall take all action necessary and possible to impose,
- 9 maintain, and collect rates, charges, and rentals and to request taxes, if any are pledged, sufficient to make the
- 10 revenue from the pledged source in ~~such~~ that year at least equal to the amount of principal and interest due in
- 11 that year.
- 12 (3) The bonds may be sold at public or private sale and may bear interest as provided in 17-5-102.
- 13 Except as otherwise provided in this part, any bonds issued pursuant to this part by an authority may be payable
- 14 as to principal and interest solely from revenue of the authority or from particular port, transportation, storage,
- 15 or other facilities of the authority. The bonds must state on their face the applicable limitations or restrictions
- 16 regarding the source from which principal and interest are payable.
- 17 (4) Bonds issued by an authority, county, or municipality pursuant to the provisions of this part are
- 18 declared to be issued for an essential public and governmental purpose by a political subdivision ~~within the~~
- 19 ~~meaning of 15-30-2110(2)(a).~~
- 20 (5) (a) For the security of bonds, the authority, county, or municipality may by resolution make and enter
- 21 into any covenant, agreement, or indenture and may exercise any additional powers authorized to be exercised
- 22 by a municipality under Title 7, chapter 7, parts 44 and 45. The sums required from time to time to pay principal
- 23 and interest and to create and maintain a reserve for the bonds may be paid from any revenue referred to in this
- 24 part, prior to the payment of current costs of operation and maintenance of the facilities.
- 25 (b) As further security for the bonds, the authority, with the approval of the governing body of the county
- 26 or municipality that created the authority, may pledge, lease, sell, mortgage, or grant a security interest in all or
- 27 any portion of its port, transportation, storage, or other facilities, whether or not the facilities are financed by the
- 28 bonds. The instrument effecting the pledge, lease, sale, mortgage, or security interest may contain any
- 29 agreements and provisions customarily contained in instruments securing bonds, as the commissioners of the
- 30 authority consider advisable. The provisions must be consistent with this part and are subject to and must be in

1 accordance with the laws of this state governing mortgages, trust indentures, security agreements, or  
 2 instruments. The instrument may provide that in the event of a default in the payment of principal or interest on  
 3 the bonds or in the performance of any agreement contained in the proceedings authorizing the bonds or  
 4 instrument, the payment or performance may be enforced by mandamus or by the appointment of a receiver in  
 5 equity. The receiver may collect charges, rental, or fees and may apply the revenue from the mortgaged property  
 6 or collateral in accordance with the proceedings or the provisions of the instrument.

7 (6) Nothing in ~~this section or 7-14-1134~~ this section may be construed to limit the use of port authority  
 8 revenue, including federal and state money as described in 7-14-1136, to make grants and loans or to otherwise  
 9 provide financial and other support to private development organizations, including corporations organized under  
 10 the provisions of the development corporation act in Title 32, chapter 4. The credit of the state, county, or  
 11 municipal ~~governments~~ government or their agencies or authorities may not be pledged to provide financial  
 12 support to the development organizations."  
 13

14 **Section 4.** Section 7-14-1636, MCA, is amended to read:

15 **"7-14-1636. Bonds and obligations.** (1) An authority may borrow money for any of its corporate  
 16 purposes and issue bonds for its purposes, including refunding bonds, in a form and upon terms ~~as~~ that it  
 17 determines, payable out of any revenue of the authority, including revenue derived from:

- 18 (a) a railroad;  
 19 (b) taxes levied pursuant to 7-14-1632;  
 20 (c) grants or contributions from the federal government; or  
 21 (d) other sources.

22 (2) The bonds may be issued by resolution of the authority, without an election and without any limitation  
 23 of amount, except that bonds may not be issued at any time if the total amount of principal and interest to become  
 24 due in a year on the bonds and on any then-outstanding bonds for which revenue from the same source is  
 25 pledged exceeds the amount of the revenue to be received in that year, as estimated in the resolution authorizing  
 26 the issuance of the bonds. The authority shall take all action necessary and possible to impose, maintain, and  
 27 collect rates, charges, and rentals and to request taxes, if any are pledged, sufficient to make the revenue from  
 28 the pledged source in the year at least equal to the amount of principal and interest due in that year.

29 (3) The bonds may be sold at public or private sale and may bear interest as provided in 17-5-102.  
 30 Bonds issued by an authority pursuant to this part may be payable as to principal and interest solely from revenue

1 of the authority and must state on their face the applicable limitations or restrictions regarding the source from  
 2 which the principal and interest are payable.

3 (4) Bonds issued by an authority pursuant to the provisions of this part are declared to be issued for an  
 4 essential public and governmental purpose by a political subdivision ~~within the meaning of 15-30-2110(2)(a).~~

5 (5) For the security of the bonds, the authority may by resolution make and enter into any covenant,  
 6 agreement, or indenture and may exercise any additional powers authorized to be exercised by a municipality  
 7 under Title 7, chapter 7, parts 44 and 45. The sums required from time to time to pay principal and interest and  
 8 to create and maintain a reserve for the bonds may be paid from the revenue referred to in this part, prior to the  
 9 payment of current costs of operation and maintenance of the facilities."  
 10

11 **Section 5.** Section 7-34-2416, MCA, is amended to read:  
 12 **"7-34-2416. Tax-exempt status of bonds.** Bonds issued by a county pursuant to the provisions of  
 13 7-34-2411 and 7-34-2413 through 7-34-2418 are declared to be issued for an essential public and governmental  
 14 purpose by a political subdivision ~~within the meaning of 15-30-2110(2)(a).~~"  
 15

16 **Section 6.** Section 15-1-208, MCA, is amended to read:  
 17 **"15-1-208. Signature alternatives for electronically filed returns.** For purposes of Title 15, chapters  
 18 1, 2, 6 through 10, 15 through 18, 23, 24, 30 through 33, 35 through 38, 44, ~~50~~, 51, 53, 59 through 61, and 65,  
 19 and Title 16, chapter 11, the director of revenue, and for the purposes of Title 15, chapter 70, the director of the  
 20 department of transportation, may prescribe, by rule, methods for signing, subscribing, or verifying electronically  
 21 filed tax returns. Returns electronically filed in accordance with the methods adopted by rule have the same  
 22 validity and consequences as physical forms signed by a taxpayer."

 25 **"15-30-2101. Definitions.** For the purpose of this chapter, unless otherwise required by the context, the

7 ~~(3)(2)~~ "Corporation" or "C. corporation" means a corporation, limited liability company, or other entity:

8 (a) that is treated as an association for federal income tax purposes;

9 (b) for which a valid election under section 1362 of the Internal Revenue Code (26 U.S.C. 1362) is not  
 10 in effect; and

11 (c) that is not a disregarded entity.

12 ~~(4)(3)~~ "Department" means the department of revenue.

13 ~~(5)(4)~~ "Disregarded entity" means a business entity:

14 (a) that is disregarded as an entity separate from its owner for federal tax purposes, as provided in  
 15 United States treasury regulations 301.7701-2 or 301.7701-3, 26 CFR 301.7701-2 or 26 CFR 301.7701-3, or as  
 16 those regulations may be labeled or amended; or

17 (b) that is a qualified subchapter S. subsidiary that is not treated as a separate corporation, as provided  
 18 in section 1361(b)(3) of the Internal Revenue Code (26 U.S.C. 1361(b)(3)).

19 ~~(6)(5)~~ "Dividend" means:

20 (a) any distribution made by a C. corporation out of its earnings and profits to its shareholders or  
 21 members, whether in cash or in other property or in stock of the corporation, other than stock dividends; and

22 (b) any distribution made by an S. corporation treated as a dividend for federal income tax purposes.

23 ~~(6)~~ "Federal adjusted gross income" means adjusted gross income as defined in section 62 of the  
 24 Internal Revenue Code (26 U.S.C. 62).

25 ~~(7)~~ "Federal taxable income", when referring to an individual, means taxable income as defined and  
 26 described in section 63 of the Internal Revenue Code (26 U.S.C. 63) and, when referring to a trust or estate,  
 27 means taxable income as defined and described in Subtitle A, Chapter 1, Subchapter J., of the Internal Revenue  
 28 Code.

29 ~~(7)(8)~~ "Fiduciary" means a guardian, trustee, executor, administrator, receiver, conservator, or any  
 30 person, whether individual or corporate, acting in any fiduciary capacity for any person, trust, or estate.

2 as provided in 15-31-101.

5           ~~(10)~~ "Gross income" means the taxpayer's gross income for federal income tax purposes as defined in  
6 section 61 of the Internal Revenue Code (26 U.S.C. 61) or as that section may be labeled or amended, excluding  
7 unemployment compensation included in federal gross income under the provisions of section 85 of the Internal  
8 Revenue Code (26 U.S.C. 85) as amended.

9           (11) "Head of household" means a head of household as defined and described in section 2(b) of the  
10 Internal Revenue Code (26 U.S.C. 2(b)).

11           ~~(11)~~(12) "Inflation factor" means a number determined for each tax year by dividing the consumer price  
12 index for June of the tax year by the consumer price index for June ~~2005~~ 2014.

13           ~~(12)~~(13) "Information agents" includes all individuals and entities acting in whatever capacity, including  
14 lessees or mortgagors of real or personal property, fiduciaries, brokers, real estate brokers, employers, and all  
15 officers and employees of the state or of any municipal corporation or political subdivision of the state, having the  
16 control, receipt, custody, disposal, or payment of interest, rent, salaries, wages, premiums, annuities,  
17 compensations, remunerations, emoluments, or other fixed or determinable annual or periodical gains, profits,  
18 and income with respect to which any person or fiduciary is taxable under this chapter.

5 (ii) gain attributable to the sale or other transfer of tangible property located in the state, sold or otherwise  
6 transferred while a resident of the state, or used or held in connection with a trade, business, or occupation  
7 carried on in the state;

8 (iii) gain attributable to the sale or other transfer of intangible property received or accrued while a  
9 resident of the state;

10 (iv) interest received or accrued while a resident of the state or from an installment sale of real property  
11 or tangible commercial or business personal property located in the state;

12 (v) dividends received or accrued while a resident of the state;

13 (vi) net income or loss derived from a trade, business, profession, or occupation carried on in the state  
14 or while a resident of the state;

15 (vii) net income or loss derived from farming activities carried on in the state or while a resident of the  
16 state;

17 (viii) net rents from real property and tangible personal property located in the state or received or  
18 accrued while a resident of the state;

19 (ix) net royalties from real property and from tangible real property to the extent the property is used in  
20 the state or the net royalties are received or accrued while a resident of the state. The extent of use in the state  
21 is determined by multiplying the royalties by a fraction, the numerator of which is the number of days of physical  
22 location of the property in the state during the royalty period in the tax year and the denominator of which is the  
23 number of days of physical location of the property everywhere during all royalty periods in the tax year. If the  
24 physical location is unknown or unascertainable by the taxpayer, the property is considered used in the state in  
25 which it was located at the time the person paying the royalty obtained possession.

26 (x) patent royalties to the extent the person paying them employs the patent in production, fabrication,  
27 manufacturing, or other processing in the state, a patented product is produced in the state, or the royalties are  
28 received or accrued while a resident of the state;

29 (xi) net copyright royalties to the extent printing or other publication originates in the state or the royalties  
30 are received or accrued while a resident of the state;

- 1 (xii) partnership income, gain, loss, deduction, or credit or item of income, gain, loss, deduction, or credit:  
 2 (A) derived from a trade, business, occupation, or profession carried on in the state;  
 3 (B) derived from the sale or other transfer or the rental, lease, or other commercial exploitation of  
 4 property located in the state; or  
 5 (C) taken into account while a resident of the state;
- 6 (xiii) an S. corporation's separately and nonseparately stated income, gain, loss, deduction, or credit or  
 7 item of income, gain, loss, deduction, or credit:  
 8 (A) derived from a trade, business, occupation, or profession carried on in the state;  
 9 (B) derived from the sale or other transfer or the rental, lease, or other commercial exploitation of  
 10 property located in the state; or  
 11 (C) taken into account while a resident of the state;
- 12 (xiv) social security benefits received or accrued while a resident of the state;  
 13 (xv) taxable individual retirement account distributions, annuities, pensions, and other retirement benefits  
 14 received while a resident of the state;
- 15 (xvi) any other income attributable to the state, including but not limited to lottery winnings, state and  
 16 federal tax refunds, nonemployee compensation, recapture of tax benefits, and capital loss addbacks; and  
 17 (xvii) in the case of a nonresident who sells the nonresident's interest in a publicly traded partnership  
 18 doing business in Montana, the gain described in section 751 of the Internal Revenue Code, 26 U.S.C. 751,  
 19 multiplied by the Montana apportionment factor. If the net gain or loss resulting from the use of the apportionment  
 20 factor as provided in this subsection ~~(18)(a)(xvii)~~ (21)(a)(xvii) does not fairly and equitably represent the  
 21 nonresident taxpayer's business activity interest, then the nonresident taxpayer may petition for, or the  
 22 department may require with respect to any and all of the partnership interest, the employment of another method  
 23 to effectuate an equitable allocation or apportionment of the nonresident's income. This subsection ~~(18)(a)(xvii)~~  
 24 (21)(a)(xvii) is intended to preserve the rights and privileges of a nonresident taxpayer and align those rights with  
 25 taxpayers who are afforded the same rights under 15-1-601 and 15-31-312.
- 26 (b) The term does not include:

13           (d) debt of a business association or financial organization, other than a bearer bond or an original issue  
14 discount bond, 5 years after the date of the most recent interest payment that was unclaimed by the apparent

17 the earlier of maturity or the date of the last indication by the owner of interest in the property; however, a deposit  
18 that is automatically renewable is considered matured for purposes of this section upon its initial date of maturity  
19 unless the owner has consented to a renewal at or about the time of the renewal and the consent is in writing or  
20 is evidenced by a memorandum or other record on file with the holder;

21           (f) money or credits owed to a customer as a result of a retail business transaction, 3 years after the

25 A gift certificate is not presumed abandoned if the gift certificate was sold by a person who in the past fiscal year  
26 sold no more than \$200,000 in gift certificates, which amount must be adjusted by November of each year by the  
27 inflation factor defined in ~~15-30-2104~~. The amount considered abandoned for a person who sells more than the  
28 amount that triggers presumption of abandonment is the value of gift certificates greater than that trigger.

29           (h) amount that is owed by an insurer on a life or endowment insurance policy or an annuity that has  
30 matured or terminated, 3 years after the obligation to pay arose or, in the case of a policy or annuity payable upon

11 payable;

12 (n) property in an individual retirement account, defined benefit plan, or other account or plan that is  
13 qualified for tax deferral under the income tax laws of the United States, 3 years after the earliest of the date of  
14 the distribution or attempted distribution of the property, the date of the required distribution as stated in the plan  
15 or trust agreement governing the plan, or the date, if determinable by the holder, specified in the income tax laws  
16 of the United States by which distribution of the property must begin in order to avoid a tax penalty;

17 (o) a patronage refund owed to a member of a rural electric or telephone cooperative organized under  
18 Title 35, chapter 18, that is not used by the cooperative for educational purposes, 5 years after the distribution

20 (p) an unclaimed share in a cooperative that is not used for charitable or civic purposes in the community  
21 in which the cooperative is located, 5 years after the distribution date; and

22 (q) all other property, 5 years after the owner's right to demand the property or after the obligation to pay

24 (2) At the time that an interest is presumed abandoned under subsection (1), any other property right

27 (3) Property is unclaimed if, for the applicable period set forth in subsection (1), the apparent owner has  
28 not communicated in writing or by other means reflected in a contemporaneous record prepared by or on behalf  
29 of the holder with the holder concerning the property or the account in which the property is held and has not  
30 otherwise indicated an interest in the property. A communication with an owner by a person other than the holder

- 14 (a) a substance defined as hazardous under 75-10-403 or defined as hazardous in department

- 17 (13) (a) "Incinerator" means any single- or multiple-chambered combustion device that burns combustible

- 20 (b) Incinerator does not include:

14 (8) "Department" means the department of environmental quality provided for in 2-15-3501.

15 (9) "Disposal system" means a system for disposing of sewage, industrial, or other wastes and includes

17 (10) "Effluent standard" means a restriction or prohibition on quantities, rates, and concentrations of  
18 chemical, physical, biological, and other constituents that are discharged into state waters.

4 (13) "High-quality waters" means all state waters, except:

5 (a) ground water classified as of January 1, 1995, within the "III" or "IV" classifications established by  
6 the board's classification rules; and

7 (b) surface waters that:

8 (i) are not capable of supporting any one of the designated uses for their classification; or

9 (ii) have zero flow or surface expression for more than 270 days during most years.

10 (14) "Impaired water body" means a water body or stream segment for which sufficient credible data  
11 shows that the water body or stream segment is failing to achieve compliance with applicable water quality  
12 standards.

13 (15) "Industrial waste" means a waste substance from the process of business or industry or from the  
14 development of any natural resource, together with any sewage that may be present.

15 (16) "Interested person" means a person who has a real property interest, a water right, or an economic  
16 interest that is or may be directly and adversely affected by the department's preliminary decision regarding  
17 degradation of state waters, pursuant to 75-5-303. The term includes a person who has requested authorization  
18 to degrade high-quality waters.

19 (17) "Load allocation" means the portion of a receiving water's loading capacity that is allocated to one  
20 of its existing or future nonpoint sources or to natural background sources.

21 (18) "Loading capacity" means the mass of a pollutant that a water body can assimilate without a violation  
22 of water quality standards. For pollutants that cannot be measured in terms of mass, it means the maximum  
23 change that can occur from the best practicable condition in a surface water without causing a violation of the  
24 surface water quality standards.

25 (19) "Local department of health" means the staff, including health officers, employed by a county, city,  
26 city-county, or district board of health.

27 (20) "Metal parameters" includes but is not limited to aluminum, antimony, arsenic, beryllium, barium,  
28 cadmium, chromium, copper, fluoride, iron, lead, manganese, mercury, nickel, selenium, silver, thallium, and zinc.

15 entered the armed forces and continues to meet the residency criteria of subsections (4)(b) through (4)(e); or

16 (ii) the member is currently stationed in and assigned to active duty in Montana, has resided in Montana  
17 for at least 30 days, and presents official assignment orders and proof of completion of a hunter safety course  
18 approved by the department, as provided in 87-2-105, or a certificate verifying the successful completion of a  
19 hunter safety course in any state or province. The 30-day residence requirement is waived in time of war.  
20 Reassignment to another state, United States territory, or country terminates Montana residency for purposes  
21 of this section, except that a reassigned member continues to qualify as a resident if the member's spouse and  
22 dependents continue to physically reside in Montana and the member continues to meet the residency criteria

- 11 (a) a Montana hunter safety and education course established in subsection (4) or (6);

15 (2) A hunting license may not be issued to a member of the regular armed forces of the United States

 17 who is assigned to active duty in Montana and who is otherwise considered a resident under 87-2-102(1) or to

 12 **NEW SECTION. Section 62. Transition -- carryover of credits.** A credit allowed a taxpayer prior to  
 13 January 1, 2014, under the provisions of 7-21-3710, 15-30-2356, 15-31-907, 15-32-115, 15-32-201, 15-32-202,  
 14 15-32-402, 15-32-404, 15-32-503, 15-32-505, 15-32-506, 15-32-507, 15-32-508, 15-32-509, 15-32-701,  
 15 15-32-702, 15-32-703, 15-50-207, or 33-2-724 that may be carried forward for a specified number of years is not  
 16 impaired by [this act], and the taxpayer may claim the credit for the taxes specified for the period established in  
 17 the section at the time the credit was first allowed.

 19 **NEW SECTION. Section 63. Transition.** (1) As used in this section, the following definitions apply:  
 20 (a) "Transition adjustment" means the net sum of all positive and negative adjustments to a taxpayer's  
 21 Montana taxable income related to transition items provided in subsection (3).  
 22 (b) "Transition item" means any difference arising prior to January 1, 2014, from a difference in federal  
 23 and Montana income tax laws in:  
 24 (i) the amount, character, realization, or recognition of income or an item of income, gain, or credit;  
 25 (ii) the amount, character, allowance, or disallowance of loss or an item of loss, deduction, or expense;  
 26 or  
 27 (iii) the basis of an asset or liability that will not, after December 31, 2013, increase or decrease a  
 28 taxpayer's federal taxable income.  
 29 (2) An adjustment to Montana taxable income may not be made to take transition items into account  
 30 except as provided in subsection (3).

1 (3) On or before the due date, including extensions, of a return for the tax year ending after December  
2 31, 2013, and before January 1, 2015, a taxpayer may, on forms prescribed by the department, file an election  
3 to make a transition adjustment to Montana taxable income. The election must specify and account for all  
4 transition items, including but not limited to the following:

5 (a) If a taxpayer has a disallowed passive activity loss within the meaning of section 469 of the Internal  
6 Revenue Code (26 U.S.C. 469) that is carried over to a tax year ending after December 31, 2013, and before  
7 January 1, 2015, and if the amount of the federal carryover is not the same amount as the Montana carryover,  
8 the difference is a positive adjustment to the taxpayer's Montana taxable income if the Montana carryover is  
9 smaller than the federal carryover and the difference is a negative adjustment to the taxpayer's Montana taxable  
10 income if the Montana carryover is larger than the federal carryover.

11 (b) If a taxpayer has excess long-term or short-term net capital loss described in section 1212(b)(1) of  
12 the Internal Revenue Code (26 U.S.C. 1212(b)(1)) that is carried over to a tax year ending after December 31,  
13 2013, and before January 1, 2015, and if the amount of the federal carryover is not the same amount as the  
14 Montana carryover, the difference is a positive adjustment to the taxpayer's Montana taxable income if the  
15 Montana carryover is smaller than the federal carryover and the difference is a negative adjustment to the  
16 taxpayer's Montana taxable income if the Montana carryover is larger than the federal carryover.

17 (c) If a taxpayer or a taxpayer and the taxpayer's spouse made an election on the taxpayer's federal  
18 return to defer income ratably because of a conversion from an IRA, other than a Roth IRA, to a Roth IRA  
19 pursuant to section 408A(d)(3) of the Internal Revenue Code (26 U.S.C. 408A(d)(3)) but included all the income  
20 in the taxpayer's Montana income tax return, the sum of the balance of the federal deferred amount as of January  
21 1, 2014, is a negative adjustment to the taxpayer's Montana taxable income.

22 (d) Notwithstanding the deduction that a taxpayer would be allowed for net operating loss carryovers and  
23 net operating loss carrybacks under section 172(a) of the Internal Revenue Code (26 U.S.C. 172(a)) in a tax year  
24 ending after December 31, 2013, and before January 1, 2015, if the taxpayer's federal net operating loss is  
25 different from the taxpayer's Montana net operating loss as of December 31, 2013, no adjustment to the  
26 taxpayer's Montana taxable income may be made.

27 (e) If a taxpayer has an asset with a different adjusted basis for federal and Montana income tax  
28 purposes after taking into account the effect of the adjustments provided in subsections (3)(a), (3)(b), and (3)(c),  
29 the difference is a positive adjustment to the taxpayer's Montana taxable income if the Montana adjusted basis  
30 is higher than the federal adjusted basis and the difference is a negative adjustment to the taxpayer's Montana

1 taxable income if the Montana adjusted basis is lower than the federal adjusted basis.

2 (f) If a taxpayer has a liability with a different adjusted basis for federal and Montana income tax  
3 purposes after taking into account the effect of the adjustments provided in subsections (3)(a), (3)(b), and (3)(c),  
4 the difference is a negative adjustment to the taxpayer's Montana taxable income if the Montana adjusted basis  
5 is higher than the federal adjusted basis and the difference is a positive adjustment to the taxpayer's Montana  
6 taxable income if the Montana adjusted basis is lower than the federal adjusted basis.

7 (g) If a taxpayer received a refund of federal income tax the deduction of which in a tax year beginning  
8 after December 31, 2012, resulted in a reduction of Montana income tax liability, the refund is, to the extent the  
9 deduction resulted in a reduction of Montana income tax liability, a positive adjustment to the taxpayer's Montana  
10 taxable income.

11 (4) The department is authorized to adopt rules and require facts and information to be reported that it  
12 considers necessary to administer the transition adjustment provided in this section.

13  
14 **NEW SECTION. Section 64. Codification instruction.** [Section 1] is intended to be codified as an  
15 integral part of Title 15, chapter 30, part 21, and the provisions of Title 15, chapter 30, part 21, apply to [section  
16 1].

17  
18 **NEW SECTION. Section 65. Severability.** If a part of [this act] is invalid, all valid parts that are  
19 severable from the invalid part remain in effect. If a part of [this act] is invalid in one or more of its applications,  
20 the part remains in effect in all valid applications that are severable from the invalid applications.

21  
22 **NEW SECTION. Section 66. Effective date.** [This act] is effective January 1, 2014.

23  
24 **NEW SECTION. Section 67. Applicability.** [This act] applies to tax years beginning after December  
25 31, 2013.
